T'gana CM Seeks Central Assistance for Flood Relief

CM Reddy Requests Equitable Relief Measures and Flexibility in Disaster Fund Utilization Amidst Estimated RS 5,438 Crore in Flood Damages

elangana Chief Minister A. Revanth Reddy has urgently appealed to the Union Government for immediate support following severe flooding that has devastated parts of the state. In a detailed briefing to Union Agriculture and Rural Development Minister Shivraj Singh Chouhan, CM Reddy highlighted preliminary damage estimates of approximately ₹5,438 crore due to recent torrential rains and flooding.

The Chief Minister's call for assistance comes after he, along with Union Ministers Shivraj Singh Chouhan and Bandi Sanjay, conducted a meeting at the Secretariat. Prior to this, the union ministers inspected the flood-affected areas. Key figures present at the meeting included Deputy Chief Minister Bhatti Vikramarka, and other senior officials such as State Chief Secretary Santhi Kumari and Special Chief Secretary Ramakrishna Rao.

CM Reddy outlined the severity of the situation, emphasizing that Khammam, Mahabubnagar, Suryapet, and other districts received up to 40 cm of rainfall in a single day. He reported significant damage to national highways, roads,

houses, and bridges, with many areas experiencing halted vehicular traffic and severely affected railway services.

In his presentation, the Chief Minister showcased the extensive impact on infrastructure and agriculture, including damaged crops and disrupted train services. The state government has already provided ₹10,000 in immediate relief to each flood-affected family.

Reddy has urged the Union Government to approve immediate repairs for breached lakes, damaged roads, and bridges, and to allocate adequate funds for permanent restoration.

Asifabad violence: AIMIM meets TG DGP over arson of Muslim


Modi emphasised the urgent need for water conservation by adopting the "reduce, reuse, recharge, and recycle" approach to secure India's water future. During the launch of the "Jal Sanchay Jan Bhagidari" initiative in Gujarat, Modi highlighted India's limited freshwater resources, with only 4 per cent of the global supply. He stressed the impact of water scarcity and climate change on people's lives and urged innovative water-saving technologies and practices like drip

Modi also praised state efforts to incentivise water-efficient crops and called for nationwide collaboration on water conservation. ers in managing water resources for recharging groundwater. Further, the 'Catch the Rain' campaign, started in 2021, has a large number of stakeholders involved today," he said. Speaking of the "Namami Gange" initiative, Modi underlined that it had become an emotional resolution for citizens and people are giving up old traditions and irrelevant customs to ensure the cleanliness of rivers. The Jal Sanchay Jan Bhagidari initiative seeks to conserve water with a strong emphasis on community partnership and ownership. It is driven by a whole-of-society and whole-of-government approach.



Amidst heavy police presence, Asifabad peaceful after violence

The situation in the violence affected Jainoor mandal in Kumaram Bheem Asifabad district of Telangana remained peaceful on Friday. Heavy police presence has still remained in neighbouring towns in view of the violence that occurred during a protest rally held to condemn the

alleged rape attempt and attack on a tribal woman last month. The Kumaram Bheem Asifabad police arrested an auto rickshaw driver in the case and have remanded him.On Wednesday, September 4, a 5000-strong mob entered into residential colonies after attacking shops belonging to Muslims and set ablaze vehicles and shops. The mob outnumbered the policemen who could

not control the arsonists. It was only after reinforcements arrived that the police managed to chase away the mob, but not before a lot of damage was done to Muslim properties. Senior police officials from Kumaram Bheem Asifabad district including ADG (law and order) Mahesh M Bhagwat on Thursday visited the violence affected area and held meetings with both

the communities. The police deployed 2000 personnel including Rapid Action Force to control the situation. Heavy deployment was done on Friday in Asifabad, Adilabad, Nirmal and other communally sensitive areas for prayers. The bandobast and prohibitory orders will continue in view of Vinaya Chaturthi on Saturday. The police so far registered four cases in regard to the

violence that took place on Wednesday. The Asifabad district administration in Jainoor clamped prohibitory orders under section 163 of the BNSS in Jainoor in view of protests and attacks on houses and business establishments of the Muslim community. The police appealed to people not to believe in rumours being spread about communal incidents.

Telangana auto driver fills potholes with bricks, mud amid govt inaction

Standing crops in 2,000 acres damaged by heavy rains in Adilabad

Various standing crops being raised in nearly 2,000 acres were dam-

aged by torrential rains in the district, causing losses to farmers. Officials of the agriculture department said that standing paddy, red gram, soya and maize crops to the extent of 1,961 acres were affected by heavy rains that lashed

the district recently.

1,609 acres stood at the top, followed by the soya crop being raised in 234 acres submerged. The crop was damaged by the downpours and backwater of the Penganga river. Significantly, the cotton crop reached the flowering stage. Consequently, the growers suffered huge losses. They requested the

government to extend compensation for crop damage at the earliest.

Mohammad Rafeeq,

a farmer from Anandapur village in Jainath mandal said that he raised the cotton crop in two acres, but was completely inundated by backwater of Penganga river. Goli Vittal of Arli (T) village in Bheempur mandal said that he had registered losses in farming with his cotton crop grown in three acres getting damaged by heavy rains.

Officials said that a comprehensive survey was being carried out to estimate the crop damage. They stated that details of farmers were being gathered and damaged crops by visiting the field. A re-

port would be submitted to the government, which would extend compensation to the farmers soon, the officials explained. Adilabad sees excess rainfall Incidentally, the actual rainfall of Adilabad district was measured to be 1,012 mm as against the normal rainfall of 869 mm from June 1 to September 6, posting an excess by 16 percent. Indervelli, Gudihathnoor, Adilabad Rural, Tamsi, Adilabad Urban, Ichoda and Utnoor mandals received excess rainfall ranging from 20 percent to 50 percent.

Centre announces Rs 3,448 cr flood relief for AP, Telangana

Agriculture Minister Shivraj Singh Chouhan on Friday announced an immediate assistance of Rs 3,448 crore to mitigate the impact of floods in Andhra Pradesh and Telangana.

Chouhan, who is in Telangana today after reviewing the flood situation in Andhra Pradesh, said: "No one needs to be disappointed. We are working to provide immediate help".

Presently, the arrangement is being made to provide immediate assistance of Rs 3,448 crore under the State Disaster Relief Fund (SDRF), which also includes the central government's share, he said.

After providing immediate assistance, the government will think about making available fertilisers and seeds to farmers for the next crop, he added.

The minister also assured the farming community that the Centre will provide appropriate compensation after

the assessment of the crop damage. "We will ask the banks not to recover

loans from farmers in times of crisis," he added. Chouhan conducted an aerial survey of crop damage in flood-hit areas of Meenavalu, Peddagopavaram, Mannur, and Kattleru, of Telangana. He also met people in Khammam and discussed their problems, an official statement said.

The minister mentioned that Prime Minister Narendra Modi is concerned about the flood situation in Andhra Pradesh and Telangana.

TGEJAC puts forward 39 demands before government



Para-Olympic medalist Deepthi Jeevanji welcomed home

The Para-Olympic Bronze medal winner from Telangana, Deepthi Jeevanji returned from Paris, and was given a warm welcome by well-wishers and the sporting fraternity at Hyderabad airport on Friday, September 6. The 2003-born para-athlete is a native of Warangal, Telangana, finished third place in the women's 400 metres, T20 classification final, at the Stade de France in Paris on September 3, winning India's second medal in the Paris Para-Olympics. At the race, the runner came behind only Ukraine's Yulia Shuliar and Turkiye's Ayser Onder, by clocking a speed of 55.82 seconds in the 400-metre race. Deepthi Jeevanji was born with intellectual disability, to daily wage labourer parents Jeevanji Yadhagiri and Jeevanji Dha-

nalaxmi in Kalleda

district. The athlete had to face multiple hurdles while paving her path to the top. Deepthi Jeevanji had to face body-shaming and social exclusion from her villagers and some relatives, during her childhood, because of the cognitive disability she was born with. Her ability to run fast was discovered by her physical education teacher at school. She was later supported by Pullela Gopichand in her transformation into an elite-level para-athlete. Before her Para-Olympic feat, Deepthi had proven herself by winning gold at the World Para Athletic Grand Prix-Morocco in September 2022, 400 metres, T20 classification race, clocking the speed of 57.66 seconds. Later, at the Para Athletic World Championship held in Kobe, Japan on May 20, 2024, she won gold and set an unbeaten world record with a timing of 55.06 seconds.

Centre's contribution to Telangana's revenue receipts declines over the years

The union government's contribution to Telangana's revenue receipts has been steadily declining over the past 10 years, from 29.98 per cent as per actual revenue receipts in 2014-15 to just 19.79 per cent in the revised budget estimates for 2023-24. The significant drop in the Central contribution, which comprises the State's share in Central taxes and grants-in-aid,

is raising serious concerns about the State's fiscal autonomy. Telangana's total revenue receipts grew from Rs 51,041.79 crore in 2014-15 to an estimated Rs 1,69,089.59 crore in 2023-24. However, during the same period, the Centre's contribution increased at a much slower pace, resulting in its percentage share declining each year, impacting the total revenue receipts. In 2014-15, the Centre contributed Rs 15,306.59 crore,

which accounted for nearly 30 per cent of the State's revenue. By 2023-24, despite

the absolute contribution rising to Rs 33,471.95 crore, its share in the total revenue receipts had fallen to 19.79 per cent.

Over the past de-

cade, the State's own tax revenue (SOTR) witnessed a significant increase from Rs 29,288.38 crore in 2014-15 to Rs 1,11,798.14 crore in 2023-24. The State's share in Central taxes has also been slower, increasing from Rs 8,188.5 crore alarming trend is the decrease in grants-inaid, which are critical for funding state-specific projects and welfare programmes. This decline suggests a shift in the union government's partisan approach, prioritising other States. In 2014-15, grants-in-aid stood at Rs 7,118.09 crore, reaching a peak of Rs 15,471.13 crore in 2020-21 during the post-Covid era. However, this figure

sharply declined to Rs 9,729.91 crore in

2023-24. The downward trend raises questions about the sustainability of Telangana's financial planning and may compel the State to seek alternative revenue sources or increase its borrowings, which would impact its overall fiscal health in the long run. The officials fear that the decreasing Central support may impact Telangana's ability to fund its developmental projects and welfare schemes

Policy expert slams Centre for co-hosting awareness session with seed industry on IPR

Farmers' Rights (PPV&-FR) Act 2001 will not be tolerated by the Indian people."

"There is a notable exclusion from this program of most of the major players involved in over ten years of debates and discussions that contributed to the framing of India's unique sui generis legislation," Dr Sahai observed.

Suspected Maoist from Haryana arrested in Bengaluru

Haryana was arrested from a lodge here, said police sources on Friday, adding that he had come to Bengaluru to meet his girlfriend. The police recovered two bags, pen drives, and a tablet from the accused, identified as Aniruddh. According to the sources, Aniruddh was working for the CPI Maoists and was involved in subversive activities. Acting on a tip-off, the Anti-Terrorist Squad (ATS) attached to the Central City Crime Branch (CCB) nabbed him when he was about to leave for Chennai by an RTC bus. After arriving from Haryana, Aniruddh was staying at a lodge within the Upparpet police station limits in Bengaluru's Central Business District. He was arrested at the Majestic KSRTC bus stand while preparing to leave for Chennai on Thursday morning, police sources revealed. The suspect was involved in circulating banned literature and had managed to evade the police until now. He was actively involved in Maoist activities and was a member of a banned organisation. Aniruddh had been collecting and raising funds for the banned outfit he worked for and had held secret meetings across the



country, according to the police.Preliminary investigations revealed that the suspect had arrived in Bengaluru three to four days ago to meet his girlfriend. The accused was found with a fake Aadhaar identity card in the name of Vikas Ghadge. A case has been registered at the Upparpet police station in this regard. The police have charged the accused under the Unlawful Activities (Prevention) Act (UAPA) and have taken him into custody for further investigation. The Karnataka Police have shared this information with their counterparts in Haryana, and a team from Haryana is expected to arrive to question the accused, sources stated. However, the official statement is yet to come from the Karnataka Police Department. Police sources maintained that they will conduct a thorough investigation as the Maoist network is active in hilly and coastal districts of Karnataka. The police had earlier detected satellite phone communication from these regions to abroad.

Editorial

Buoyant year for banks

Much of how the banks shape their growth strategies in 2023 will depend upon the evolving macroeconomic dynamics whose roots lie in 2022. Banks face domestic and external sector risks in an integrated world order. It can be recalled that when Covid was receding in early 2022, major central banks in the world were on a binge to normalise easy money policies that were aligned to fight the pandemic ills. But the invasion of Ukraine by Russia in February 2022 overturned the global economic landscape. Sanctions against Russia, surge in energy and commodity prices, continued supply-side disruptions, aftermath of 'Zero Covid policy' in China and increasing polarisation of economies exacerbated geopolitical risks. Inflation made a galloping rise, interest rates soared and volatility became the watchword on markets ranging from stocks and bonds to cryptocurrencies and Chinese real estate. The appreciation of the US dollar against domestic currencies and the flight of overseas funds back to developed economies exacerbated exchange rate challenges. While the fears of the resurgence of Covid19 in many parts of the world now cannot be ignored, India is said to be better placed with its strong immunisation campaign and wider exposure of society to the virus, forming hybrid immunity.

RBI Strategies

The Reserve Bank of India (RBI) joined the policy normalisation along with its global peers while customising it to domestic needs. It opted for a tectonic shift in monetary policy beginning in May 2022 steeply raising the repo rate by 225 basis points to fight inflation. It was coupled with absorbing excess liquidity using the variable rate reverse repo (VRRR) tool and retained low fixed rate reverse repo intact at 3.35%. Banks quickly needed to fine-tune liquidity risk management as the cost of funds soared and resource inflows slowed. At the same time, the RBI continued its innovative strategies by introducing Standing Deposit Facility (SDF) on April 8 at an interest rate of 3.75%, which now stands at 6%, for absorbing excess liquidity. As the impact of fiscal and monetary policy actions of 2022 and external sector dynamics work their way to shape the challenges and opportunities in the economy, the banking industry is set to enter another aggressive growth orbit in 2023. Banks will have to sync their functional barometer in line with the evolving macroeconomic ecosystem to make the most out of it. Influenced by the demand for credit from reviving trade and industry, bank credit growth rose fast during 2022 to reach 17.5% while deposits were sluggish at 9.9% as on December 2, 2022. The incremental credit deposit (CD) ratio has been staying above 100% since August 2022. Even the flow of funds to the commercial sector has been expanding at a faster pace which should work to stimulate growth. Due to changed resources, banks plunged into stiff liquidity mismatches that needed heightened resource augmentation strategies. While the cost of resources has gone up due to the rise in interest rates on deposits, loans had to wait to get repriced until their Marginal Cost of Funds Based Lending Rates (MCLR) were reset. The excess investment made in SLR (Statutory Liquidity Ratio) securities beyond the statutory limit of 18% during pandemic times when demand for credit nosedived also helped. Such excess liquidity could be now used to meet expanding credit. But going forward, 2023 will definitely be the year of depositors who may enjoy positive real rates of interest with inflation plunging and deposit rates going up. The stiff competition for deposits will further heighten rates.

Stronger HeadwindsWhen the economy is strong, sectors grow well and banks can unleash their potential. It is noteworthy that the macroeconomic fundamentals are getting stronger against the backdrop of GDP in O1 growing at 13.5% and in O2 at 6.3%. The trend reflects a strong sequential momentum where private final consumption expenditure and gross fixed capital expenditure are looking up. The fiscal is expected to end GDP at 6.8% with Q3 and Q4 at 4.4% and 4.2%, respectively, providing strong impetus to banks. While the global GDP and cross-border trade are on descent, the growth data of the domestic economy resonates with optimism. The external spillover risks to inflation continue to haunt and that could potentially add imported inflation to it. Tapering of crude oil prices, now close to \$80 a barrel, is a significant positive development that could provide a speedy revival of the economy. Despite the innate resilience of the Indian economy, sensitivity towards emerging global risks in articulating a forward pathway of growth-inflation dynamics is the right way to be pragmatic.

In addition to diminishing inflation and stable growth headwinds, the findings from the RBI surveys of households, businesses and professional forecasters provide ample optimism for growth prospects. Banks while bracing to meet stiff challenges of liquidity risk management due to increased demand for credit will have to, in addition, work out strategies to finance green projects to reduce carbon footprints and achieve the UN Sustainable Development Goals. Financing such projects will need different wherewithal, including risk assessment and risk management systems.National Bank for Financing Infrastructure and Development (NaBFID), now fully equipped, will be able to provide support to banks in infrastructure lending, including green projects. National Asset Reconstruction Company Ltd – Bad bank – should also ease the burden of toxic loans of banks to create space for fresh lending.



News Channels, Chasing TRPs, Ignore The Necessary

In the new year, Television Rating Points (TRPs) should be renamed by media networks. To reflect the content being churned out every evening, the abbreviation could just as easily stand for Third Rate Programming (TRP)! Controversial, cynical statements that polarize are a prime time favorite. A Chief Minister of a BJP state will try and outdo a woman MP from his party to spew communal venom. An easy way to earn points in the Modi-Shah era. Ninety per cent of the narrative on Indian television today lingers on these contrived, divisive issues. When was the last time you saw a TV programme discussing the plight of manual scavengers risking their lives or the importance of safe drinking water for all? Sadly, the same illness affects the quality of the output in Parliament- but that's a story for another day in 2023.Prime time news is now a cacophony of triviality, a chorus of anchors turned cheerleaders. In all this madness, there have been worthy exceptions- a credible network or two, built over decades of trust and following the rules of good old-fashioned journalism. One such gem is NDTV. Which is why I am writing this piece here - not to garner 'Likes' or re-tweets or 'Views'. Instead, allow me to draw attention at the beginning of the new year to an issue that will - God forbid- cause national and international strife. Not oil, nor gold, nor data. This is about safe drinking water. Safe drinking water is not only crucial to human health and well-being but access to it is also a fundamental right protected under the ambit of the Right to Life (Article 21) in the Constitution.India has about 18 per cent of the world's total population, but only 4 per cent of the water resources. This makes us one of the most water-stressed countries in the world. Many Indians face high to extreme water stress caused by lack of availability and poor quality of available water, according to the NITI Aayog as well. On top of that, chemical pollution of

den, whether natural in origin or anthropogenic. It affects livelihood, school attendance, standard of living, people's dignity and the environment. More than 60 per cent households do not treat their water before drinking. According to UNICEF, only 1/4th of the total population in the country has drinking water in their households and approximately three-quarters of all illnesses in India are caused by impurities in the water supply. About 38 per cent children under the age of five are stunted, and 50 per cent of malnutrition cases are linked to diarrhoea. Around 30 diseases are a consequence of unsafe water, poor sanitation, and hygiene. According to the National Family Health Survey 5, diarrhoea was prevalent in 7.3 per cent children under five years of age. The existing sources of data for tracking water and its safety are the Census, National Family Health Survey and Integrated Management Information System. The first two do not dwell upon the quality and reliability of water and the third lacks data on sufficiency of water and is not standardised and comprehensive for rural areas. Delay in the Census and data gaps such as these provide a big lacunae in handling water resources to the optimal level. There is an urgent need to strengthen, standardise existing reporting and expand the scope of surveys to cover more indicators of safely managing the drinking water services. This is critical to good policy-making and planning of welfare schemes. All individuals should be entitled to clean water and sanitation without any discrimination. Marginalised populations, including women, children, refugees are frequently disregarded by and excluded from access to supply of safe drinking water, based on their societal positioning.Article 14(2)(h) of Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) provides: "States parties shall take all appropriate measures to eliminate discrimination against women in rural

areas in order to ensure, on a basis of equality of men and women, that they participate in and benefit from rural development." But the burden of water collection often falls on women who have to travel long distances and stand in long queues to fetch water. This makes them lag behind in school attendance, work, childcare etc, and positions at the front of verbal, sexual and physical violence and discrimination by societies. The denial of access to safe drinking water in public spaces is a big manifestation of the existence of discrimination. Caste plays an important role in the same. More than 20 percent of Dalits lack access to safe drinking water and often face violence for trying to access these resources. Harmful concepts of purity and contamination govern the thinking of individuals in affected areas even after untouchability had been abolished. The Union government controls the regulation and development of inter-state rivers which are a major source of water in India. Making these channels safe for drinking needs to be prioritised. The Jal Jeevan Mission that targets providing tap water in every household too misses out on making this water safe for drinking. Such weak systems and lack of funding from the Union have hindered the reach in India. India's water sector has faced an investment gap of 21 lakh crores between 2015-2030 according to the G20 Infrastructure Outlook. Hence there is a need to make the sector more attractive for investment, along with increasing the budgetary allocation specifically for making drinking water safe so states can make a bigger difference. The issue of access to clean drinking water cannot be looked at in isolation. It is dependent on other factors of gender, class, caste, education among others. Involvement of stakeholders in the making of policies at each level is imperative in minimising the discrimi-

feels authentic, perhaps due to most of its cast being comprised of modern-day residents of the favela depicted in the movie. In the 20 years since its release, City of God not only aged well but remained very current - the issues it depicts are still as salient as ever before.Indeed, poverty and extreme inequality are still chief problems in Rio de Janeiro. In favelas like City of God, the many struggles caused by poverty are exacerbated by police brutality and corruption,

addiction, racism and - as it was very subtly depicted in the film -the condescending attitudes of the liberal white middle class towards the poor. The film depicts a favela in the grip of organised crime in the 1970s and underlines the role corrupt police officers played in transforming this suburban neighbourhood (purpose-built to try and keep the poor outside the centre) into a place where laws do not apply, justice is never achieved and no one can ever truly feel safe.

Linkin Park reunite 7 years after Chester Bennington's death, with new music

Linkin Park is back with a new lineup and debuting their first new music since the 2017 death of lead singer Chester Bennington. On Thursday, the band kicked off a livestream showcasing new singer Emily Armstrong and drummer Colin Brittain, who will join returning members Mike Shinoda, Brad Delson, Phoenix and Joe Hahn in Linkin Park's new lineup. Shinoda and Armstrong share vocal duties. The new lineup launched into a new single, "The Emptiness Machine", at the top of the stream. Armstrong's performance style comfortably continues the band's legacy: Her full-throated vocals recall Bennington without attempting parody, immediately evidenced on the second song of the set: "Somewhere I Belong". "This is a very special day for us," Shinoda said as he led introductions, mentioning that guitarist Alex Feder was filling in Delson for the night. "In the role of Chester Bennington this afternoon is each of you," Shinoda addressed the crowd. The new Linkin Park also announced a new album, "From Zero". It releases November 15. At 41, he died by suicide shortly after the release of the group's last album, "One More Light". "Before Linkin Park, our first band name was Xero. This album title refers to both this humble beginning and the journey we're currently undertaking," Shinoda said in a statement announcing the upcoming release.Armstrong comes from alt-rock band Dead Sara and Brittain is a songwriter and producer who has worked with Papa Roach, One OK Rock and All Time Low, among others. He replaces original drummer Rob Bourdon, who "has decided to step away", a band representative told The Associated Press."The more we worked with Emily and Colin, the more we enjoyed their world-class talents, their company, and the things we created," Shinoda said. "We feel really empowered with this new lineup and the vibrant and energised new music we've made together. We're weaving together the sonic touchpoints we've been known for and still exploring new ones." 




ing the initiation in 2022.

HMWSSB MD asks dept to revive 22mgd Hyder Nagar reservoir

Hyderabad Metropolitan Water Supply & Sewerage Board (HMWSSB) managing director Ashok Reddy has instructed his officials to bring back into use an old drinking water reservoir having a capacity to store 22

million gallons per

day (mgd) of water in Hyder Nagar section of the board.

During his inspection of various reservoirs for water quality and supply for the third straight day on Friday, Ashok Reddy said that water from Osmansagar (Gandipet) could be stored in the Hyder Nagar section reservoir, from where drink-



ing water could be supplied in that area by the HMWSSB in Hyderabad.

managing direcgtor said that the burden for water supply in other peripheral By doing areas of Hyderabad that, the HMWSSB could be reduced,

and water tankers booked by the people during the summer could fetch and supply drinking water from that reservoir itself. He expressed

his shock over two generators purchased years ago for Golden Heights reservoir and Budwel reservoir were lying in neglect, as electricity connection

was not given to them. He instructed HMWSSB officials to immediately give the connections, and if needed, get the generators repaired.

The HMWSSB managing director asked the officials to build a compound wall around it to prevent private persons from entering the Golden Heights

es, and to prepare proposals to build a section office there.

He asked HMWSSB officials to explore if there could be a way that whenever chlorine stock depletes in the reservoirs, automated messages could be sent to the cell phones of officials, and asked the officials to record

the chlorine levels in the log books of the reservoirs every hour and upload the data online.

He spoke with the residents of Yadava Reddy Nagar in Upparpalli and asked the locals not to waste water, as HMWSSB has been spending Rs 50 to supply kilo litre of water to the residents.
