"It Felt Like Hell": **Truck Driver Who Dodged Death In Jaipur Fire**

With a desperate lurch to the left, trucker Sumer Singh dodged death on the Jaipur-Ajmer Highway, where a massive ball of fire waited for him. He got away with some burns, but many were not so lucky. Sumer Singh, 40, was on his way towards Vishwakarma Industrial Area like any other day when suddenly a scene straight from hell appeared before his eyes. To prevent driving straight into the fire, Sumer Singh, without wasting a moment sent his truck off the road with a lurch to the left, jumped off it as soon as it stopped, and ran for his life.Sumer Singh survived but his truck was completely burnt. Eleven people died, while more than 35 suffered burns on Friday when an LPG tanker collided with a truck, sparking a huge fire that turned a stretch of the Jaipur-Ajmer highway into an inferno.

The Telangana Legislative Assembly passed the Telangana Bhu Bharati (Record of Rights in Land) Bill, 2024, on Friday, replacing the controversial Dharani portal with a new system. The Bill was passed through a voice vote, despite a walkout staged by the main opposition party, BRS, in protest against the Speaker's decision to disallow discussion on the Formula E race issue.While BRS members walked out, other opposition parties, including BJP, AIMIM, and CPI, took part in the debate. They welcomed the new legislation but proposed several amendments, all of which were rejected by the House. Revenue Minister Ponguleti Srinivasa Reddy assured the Assembly

would be incorporated into an executive order to be issued within three months, following the formulation of implementation rules for the Bhu Bharati Act.Chief Minister A. Revanth Reddy described the Bhu Bharati Act, also known as the RoR (Record of Rights) Act, as a historic initiative to safeguard the land rights of the poor and correct the flaws in the previous land registration system. Reddy emphasized that the legislation aims to protect eligible landowners from exploitation and ensure transparency in land dealings. The Chief Minister also highlighted the historical importance of land rights in Telangana, cit-

US universities Advise Students to Return Before Trump Takes Office

New delhi WUT | DEC.21

An increasing number of U.S. colleges and universities are advising international students to return to campus before President-elect Donald Trump's inauguration, fearing that he may reintroduce travel bans similar to those imposed during his first administration. While Trump's plans remain unclear, over a dozen

schools have issued these advisories. Some schools have spring semesters that begin before Trump takes office, so students may need to return to campus anyway. However, for those whose stay in the U.S. depends on an academic visa, the best course of action is to reduce risks and return before January 20.What Did Trump Do in the Past?In January 2017, Trump signed an executive order banning travel from

seven predominantly Muslim countries: Iraq, Syria, Iran, Sudan, Libya, Somalia, and Yemen. This ban affected a wide range of travelers, including students, faculty, businesspeople, tourists, and family visitors, many of whom were detained or barred from boarding flights to the U.S. Trump later modified the list, eventually affecting 15 countries, and more than 40,000 individuals were denied visas due



President Joe Biden rescinded these orders in 2021.During the 2023-24 academic year, over 1.1 million international students were enrolled in U.S. colleges and universities, with students from India and China representing more than half of this number. Saving Kaleshwaram Barrages to **Be Delayed Further**

It is becoming increasingly clear that the National Dam Safety Authority (NDSA) is nowhere near to completing its much-awaited report to the state government on possible solutions to the problems at Medigadda, Annaram and Sundilla barrages of the Kaleshwaram project. This has become evident with the Union ministry of jal shakti writing yet another letter to the Telangana irrigation department saying that the NDSA expert committee constituted

specifically to address the problems at Kaleshwaram barrages, was still waiting for reports of several technical test reports at the three barrages.

In a letter to the secretary of the irrigation department, the NDSA's policy and research wing director Ajay Kumar Sinha has said that the expert committee "has expressed concerns



regarding the non-submission of inputs sought from the irrigation and CAD department. The delay in providing these inputs is likely to result in a corresponding delay in the submission of the committee's final report." Sinha's letter to the state government followed a letter from the committee to the NDSA chairman on November 29, saying the "It is requested that NDSA may impress upon the secretary, I&CAD dept., government of Telangana to expeditiously submit all the remaining inputs to the committee without further delay."

Harish Rao Slams Revanth Reddy, Defends KTR's Integrity

In a significant development, the Telangana High Court has delivered a favorable verdict, ruling against the arrest of KTR in a case allegedly fabricated by Revanth Reddy. The court's decision marks a moral victory for KTR and brings to light the baselessness of the charges. The case, which was dismissed by the court, is described as a fake and politically motivated attack, with KTR receiving congratulations for his first step toward justice. The BRS leaders further accused Revanth Reddy of making false statements in the Legislative Assembly, where he spread misleading information about the Formula E race



held in Hyderabad.BRS leaders have pointed out that while Revanth Reddy made accusations about a corruption scandal related to the Formula E race, the facts tell a different story. Contrary to his claims of a loss of Rs 600 crore, reports from a prestigious

firm, Nielsen, show that the state actually benefited by over Rs 700 crore. They criticized Revanth Reddy for distorting the truth, causing harm to the state's reputation, and using the issue for political gain.KTR's efforts to bring the Formula E race

to Hyderabad, a prestigious international event, are lauded by the BRS leaders as a step to boost the state's economy. The event generated significant revenue, with GST collections expected to surpass Rs 140 crore, benefiting both state and central treasuries. Despite this, Revanth Reddy's attempts to tarnish KTR's reputation have been met with strong rebuttals from the ruling party. The BRS leaders also accused the opposition of undermining the state's progress and making baseless allegations. They pointed out that while KTR is working to expose the corruption within the opposition, including alleged links to his political adversaries, Revanth Reddy's leader-

ship is marked by blameshifting and failed promises.Further criticisms were directed at the Chief Minister for his inability to bring about any significant changes since taking office, and for the deteriorating reputation of Telangana under his leadership. The BRS leaders argue that Revanth Reddy's reckless actions are causing harm to the state and its people, and reiterated their commitment to exposing the truth and working for the welfare of Telangana. The ongoing battle between the ruling and opposition parties continues, with KTR's supporters promising to keep fighting for the people of Telangana and hold the government accountable for its actions.

BRS Leaders Slam Govt Over E-Race Issue

Former Ministers Jagadish Reddy and Prashanth Reddy have strongly criticized the state government for filing illegal cases to divert attention from pressing public issues and unfulfilled promises. Speaking to the media, Jagadish Reddy accused the government of trying to sideline important matters, such as the promises made to farmers, by focusing on petty legal actions against KTR. He demanded that the government provide evidence if it believes



KTR's previous actions as a minister caused any financial loss.Reddy also questioned the government's reluctance to hold a discussion in the assembly regarding the controversial car racing issue. "KTR has made a fair request to discuss this in the assembly,

MBLY where the views of four crore people could be heard," he said, adding that the government's failure to engage in such discussions shows a lack of accountability.In a pointed attack, Reddy highlighted that while no discussions have been held on farmer assur-

ances or the promises made to the agricultural community, the government is focused on filing cases without evidence. "What crime did KTR commit in the Formula A racing issue? Where is the evidence?" he asked.Echoing similar concerns, Prashanth Reddy, another former minister, slammed the filing of an "illegal case" against KTR. He called for an open discussion in the assembly, stressing that the Congress government should not shy away from addressing the issue if it has the courage to do so.Both leaders vowed to continue fighting in the assembly until the matter is brought to the floor for debate, accusing the government of avoiding public issues in favor of political maneuvering. The former ministers also criticized the BJP and Congress for their lack of difference in approach, with Reddy remarking, "Bade bhai and chote bhai are in the same line."The controversy surrounding car racing and the alleged legal cases has become a flashpoint for political debate in the state, with both opposition and ruling party members pointing fingers at each other.

Patil took Dr. Mohan task for failing to maintain enough stocks of medicines and for advising patient's attendants to go to Diagnostic Hub on their own to get medical tests done. The Collector questioned the superintendent why he could not monitor the status of stocks, which was one of his duties. He further noted that it was the duty of the staff to collect patients' samples.

Revanth Reddy has accused the ruling party of transferring sensitive land records and personal data of landowners and farmers to foreign companies, including those involved in criminal activities and financial fraud. During a debate on The Telangana Record of Rights in Land (Amendment) Bill 2024 in the Assembly on Friday, Reddy slammed former Chief Minister K.

Chandrashekar Rao (KCR) and former IT

Minister K.T. Rama Rao (KTR) for allegedly entrusting the controversial Dharani portal to companies based in tax havens like the Cayman Islands and the British Virgin Islands.Reddy criticized the Dharani portal, which launched in 2020, calling it a mere replica of Odisha's e-Dharani system rather than an innovative project as claimed by KCR. He pointed out that the Odisha system, launched in 2010 and managed by IL&FS, had faced significant lapses as

lighted by the Comptroller and Auditor General (CAG), yet the BRS government handed over the management of Dharani to IL&FS.Accusing top BRS leaders of

compromising the state's land records, Reddy claimed that the personal data of 1.52 crore acres of land had been transferred to companies embroiled in financial scandals. He

further alleged that the portal served as a front for benefiting fraudulent companies tied to major scams like those of Satyam Computers and Maytas, naming close associates of KTR—Gade Sridhar Raju, Rahul Goswami, and Anand Kumar-as primary beneficiaries. The CM also revealed that TerraCIS Technologies, the company managing the Dharani portal, was under investigation by the Anti-Corruption Bureau (ACB) for violating contractual terms. Reddy alleged that the firm had operated

from offices in Vijayawada, Bengaluru, and foreign tax havens, raising suspicions about clandestine transactions. He traced TerraCIS's ownership, noting that it was linked to IL&FS before being acquired by the Philippine-based Falcon SG, and later, Singaporebased Falcon Investments, with shares spread across companies in tax havens.Reddy condemned the BRS government for disregarding tender policies that prevent firms

> with criminal backgrounds from operating in government projects. He

also accused the previous administration of bypassing reputable institutions like the National Informatics Centre (NIC) and the Centre for Good Governance (CGG) in favor of these foreign entities. Furthermore, he alleged that the BRS government violated the Digital Personal Data Protection Act, 2023, by handing over private citizen data to foreign firms without consent. The Chief Minister also pointed to the BRS government's failure to address Union Minister G. Kishan Reddy's complaints about illegal

Bhoodan land transfers in his native village, Thimmapur, and vowed that the Congress government would take steps to reverse such transactions.Reddy questioned why KCR, who had earlier hailed the Dharani portal as a revolutionary system, did not attend the Assembly session to defend it. BRS legislators strongly criticized the Congress-led government's move to replace the Dharani land management and registration system with the Bhu Bharati Act, accusing it of betraying farmers and promoting land grabbing and corruption. The BRS leaders staged a walkout from the Telangana Legislative Assembly on Friday, voicing their opposition to the new law.Speaking to the media after the walkout, BRS MLA Dr. Palla Rajeshwar Reddy condemned the Bhu Bharati Act as a regressive measure that would undermine the progress made under Dharani. He described the replacement as a significant setback for farmers, replacing the transparency of Dharani with confusion and chaos. Reddy emphasized that the Dharani system had benefited 75 lakh farmers, ensuring clear ownership over 1.52 crore acres of land. He dismissed claims that the system was flawed, pointing out that minor gaps should not be used as a basis for

facilitate real estate scams and bring back outdated land practices such as Jamabandi, which he argued would benefit only land grabbers and criminals.In a separate statement, MLA K.P. Vivekananda criticized the mismanagement of Assembly proceedings under Chief Minister Revanth Reddy's leadership, accusing the government of trampling on legislative rules. CM Revanth Reddy Slams Formula E Deal, Claims 500 Crore Saved

Chief Minister A. Revanth Reddy on Friday announced that the Telangana government saved ₹500 crore by rejecting a Formula E race deal. The decision came after a representative from the Formula E Organisation (FEO) met with him in December 2023, shortly after the Congress government took office. According to the CM, the representative claimed an agreement had been made with the previous BRS government and sought cooperation for the new administration.Reddy alleged that the Formula E deal was designed to siphon off ₹600 crore, and if he had agreed to it, ₹500 crore could have been misused. "Even ₹55 crore is not a small amount," he stated. Addressing the controversy in the Assembly, the CM clarified that he had granted the FEO representative an appointment, stating that

Delhi Police Crime Branch to Probe Rahul Gandhi **Over Scuffle**

The Delhi Police Crime Branch has taken over the investigation into the case against Congress leader Rahul Gandhi, following an alleged altercation on Parliament premises that resulted in injuries to two BJP MPs. According to officials, the case has been transferred from local police to the Crime Branch for a more comprehensive inquiry.An FIR was filed on Thursday at Parliament Street Police Station, based on a complaint from the BJP. The complaint accuses Gandhi of physical assault and incitement after BJP MPs Pratap Chandra Sarangi and Mukesh Rajput were reportedly injured during the incident. The FIR includes multiple charges under sections 115, 117, 125, 131, 351, and 3(5) of the Bharatiya Nyaya Sanhita, relating to voluntary causing hurt, grievous hurt, endangering life, and the use of criminal force, among other offences.A senior police officer confirmed that the Crime Branch would be recording state-

ments from Sarangi and Rajput, and might also summon Gandhi for questioning. Investigators are reviewing CCTV footage and reaching out to media outlets for potential video evidence. 

India's economic trajectory has been both inspiring and challenging. While the country has emerged as one of the fastest-growing economies globally, its informal labour sector, which includes the lower 50% of the labour force, such as nano-entrepreneurs, construction workers, domestic helpers, and street vendors, continues to operate under severe constraints. Despite their substantial contribution, their potential remains untapped due to systemic barriers such as financial exclusion, lack of training, and poor policy support.As India grapples with GDP growth falling to 5.4%, there is an urgent need to focus on this segment of the workforce. India's informal sector employs an estimated 87% of the workforce, encompassing millions of workers and micro-entrepreneurs. Nano-entrepreneurs alone account for a significant share, often operating small businesses with minimal investment. According to the National Sample Survey Office (NSSO), the informal sector's Gross Value Added (GVA) rose from Rs 8.62 lakh crore in 2022 to Rs 9.99 lakh

Rajendranagar Court Delivers Life Sentence in 2020 Gangrape Case

:The Rajendranagar Pocso court on Friday convicted Shaik Zaffar and Shaik Nayeem to life imprisonment for kidnapping, raping and attempting to kill a 17-year-old girl in 2020. The incident occurred in what is now the Attapur police limits, According to the Attapur police, in 2020, the victim, who was from an economically weaker background, became acquainted with Zaffar. When Zaffar's cousin Nayeem learnt of it, he orchestrated a plan to gangrape her, police said. Zaffar took the victim her to an under-construction site in Rajendranagar, where Nayeem joined him and the two then gangraped her and pushed her from the first floor building. When she survived, they allegedly threw her near a hut near the RGIA police station while she was unconscious state. This spot turned out to be near her residence. Her parents spotted her and shifted her to the Osmania Hospital. A police case was registered. Two months later, when the girl's condition stabilised, a district magistrate recorded her statement. Following this, using CCTV cameras, and the phone number of the accused that the victim possessed, the accused were traced out and arrested and convicted.

A 23-year-old man, Nadgotti Bharath from Warangal, was arrested by Cyberabad Police in connection with a burglary at his relative's house in Jagadgirigutta. Bharath, who was found in possession of stolen gold ornaments weighing 12.7 tulas (valued at over Rs 7 lakh), is accused of breaking into the home of Jangam Paramesh on December 15.Paramesh had locked his house to attend a family event in Jangoan, Warangal, and upon returning three days later, discovered a broken window and a damaged

Hanumantha Rao confirmed that Bharath had a criminal history, with previous arrests in 2020 by Medipally Police and in 2022 by Charminar Police for theft-related offenses. Despite serving time in jail, Bharath returned to criminal activities after his release. The Cyberabad Police successfully recovered the stolen gold ornaments and have taken Bharath into custody for further investigation.



Telangana HC strikes down GO reserving PG medical seats for locals

The Telangana High Court on Tuesday, December 17, struck down government orders reserving postgraduate medical seats for local students.

A bench of chief justice Alok Aradhe and Justice J Sreenivas Rao declared as 'bad' the state govt's GOs 148 and 149, issued on October 28 as per which only those who studied medical courses in Telangana under local quota would be treated as local candidates in PG medical admissions and not those who have studied in Telangana under non-local quota.

Disposing of a batch of nearly 100 petitions that challenged the government's action in amending the rules in October, the bench said that all those who completed MBBS in Telangana were entitled to compete for 2024-25 PG medical seats as local candidates.

Agreeing with senior counsel G Vidya Sagar who argued that Presidential Order 1974 was very much in force in Telangana's education sector even after the bifurcation of united Andhra Pradesh and that the state's amended rules cannot change the mandate of the Presidential Order, the bench said that in case of a conflict between them, the Presidential Order would prevail.Telangana had amended the rules of medical admissions and brought in explanation (b) to Rule VIII (ii) of Telangana Medical Colleges (admission into PG medical courses) Rules, 2021, as amended by GO 148 and explanation (b) to Rule 8 (ii) of the Telangana Admission into PG (AYUSH) Courses Rules issued GO 149. The govt said the objective of these GOs was to help local candidates. However, the bench said that since the Presidential Order defines those who studied the qualifying course (MBBS) in Telangana as local candidates, they would be eligible to compete for the PG medical.

According to the excise department, Abhisek Singh was smuggling ganja from Doolapet to Nanakramguda. The task force team intercepted him during a vehicle check in Nanakramguda.

Abhisek Singh has a history of involvement in ganja smuggling. He was previously caught with ganja in Shamshabad two months ago and a case was booked.After being released from jail, he resorted to his old ways.A case is registered against Abhisek Singh under the Narcotic Drugs and Psychotropic Substances (NDPS) Act. Further investigation is underway. The arrest is part of the excise department's ongoing efforts to curb the smuggling of narcotics in the state, said the officials.

After collecting money from the victims, the accused paid partial amounts to some of the victims and later they failed to fulfill their promise.

Pakistan veterans Babar Azam and Mohammad Rizwan laid the foundation for a convincing, series-clinching 81-run win over South Africa in the second one-day international at Newlands on Thursday. Pakistan's total of 329 all out was set up by Babar (73) and captain Rizwan (80), who put on 115 off 142 balls for the third wicket. Heinrich Klaasen made 97 for South Africa but the hosts were bowled out for 248. Fast bowlers Shaheen Afridi (four for 47) and Naseem Shah (three for 37) were the main destroyers.

The win gave Pakistan an unbeatable 2-0 lead in the three-match series. Pakistan's win on Thursday saw them become the first team in 21st century to win three ODI bilaterals in South Africa.

it was their fifth successive series win - and the third for the Champions Trophy hosts in the southern hemisphere season, following victories in Australia and Zimbabwe.

"It's a team game, from beginning to end all of the guys are involved and contributing," said Rizwan. Babar and Rizwan, whose combined 204 one-day caps exceeded the total of the rest of the team, batted soundly and sensibly before Babar was out with the total on 192 in the 33rd over.

Rizwan followed three overs later to a sensational diving catch off his own bowling by 18-year-old one-day debutant Kwena Maphaka.

Ravi Shastri feels India justified in celebrating on avoiding follow-on in Brisbane

Former India head coach Ravi Shastri believes the Rohit Sharmaled side was justified in celebrating on avoiding the follow-on during the rain-hit third Test against Australia in Brisbane, which led to the five-match series being locked at 1-1. On Day Four of the match at the Gabba, Akash Deep sliced a Pat Cummins delivery over the gully for a boundary, which helped India avoid the follow-on, leading to jubilant celebrations in the dressing room by captain Rohit

Sharma, head coach Gautam Gambhir and Virat Kohli.

While many in the Australian camp were surprised by it, Shastri felt there was nothing bad about it. "You should celebrate. It required a lot of character from the last pair with 35-36 runs needed. That celebration showed they knew the importance of that effort within the dressing room in the context of the series." "It's one thing following-on, it's one thing then again being 2-3 down as opposed to, you going ahead and rattling the Australian top-order. It is fully justified," said Shastri on the ICC Review show.

Talking about the scenes in Brisbane, Shastri recalled the 89run partnership between Bumrah and Mohammed Shami at the Lord's during the 2021 series against England, a match which India eventually won. He also highlighted the importance of lower-order bailing India out of tough situations.

"It reminded me of the celebration, in COVID times when Jasprit and Mohammed Shami were involved in a partnership at the Lord's, which turned the game on its head. England were odds-on favourites on the final day to win the Test. And that partnership, I think of about 80 or 90, suddenly turned the game on its head, and by the end of the day, India had won the Test match." "When the tail-enders

Akbaruddin Owaisi Accuses BRS of Prioritizing First Family's Interests

AIMIM MLA Akbaruddin Owaisi on Friday launched a sharp attack on the ruling BRS, accusing the party of focusing solely on protecting the interests of its 'first family' while disrupting the legislative proceedings in the Assembly. Owaisi urged the Speaker to take action against BRS members who caused a ruckus in the House, milling around the podium and encroaching on the well of the House.During the debate on the Telangana Bhu Bharati (Record of Rights in Land) Bill, 2024, Owaisi called for a comprehensive land survey and pointed out that the Centre would bear the cost of digitizing

land records. He further suggested the government look into the property management systems of countries such as the Netherlands, Singapore, and Estonia

to improve Telangana's land administration."This is a sad day for Telangana. The BRS seems more concerned with the welfare of its family than with the problems of the people," Owaisi said. He criticized the introduction of the Dharani portal, claiming it was designed to benefit a particular family and enrich them. "The right of members to discuss important bills is being disrupted by the ongoing chaos in the House," he added.Referring to the torn papers scattered on the floor of the Assembly, Owaisi labeled it



a symbol of the 'kachra sarkar' (garbage government) run by the BRS for the past decade. He predicted harsh consequences for the BRS in the upcoming elections, citing the party's failure to address landowner grievances.Owaisi also questioned the BRS's previous slogan "Tanashahi Nahi Chalega" (Dictatorship will not be tolerated) against the Congress government,

stating that the BRS should introspect. "They enjoyed the fruits of power and looted the state. The 2020 Act lacked a redressal mechanism for affected landowners. About 18 lakh acres were placed in Part B, denying rights to lakhs of people," he said. The MLA further criticized the Congress for only forming a land committee rather than a land commission, which

had been promised. He demanded that the committee's findings be disclosed and called for redrafting of certain clauses. He also advocated for the removal of unauthorized entries in the Dharani portal and questioned why properties bought through notarized papers in Hyderabad were not allowed for

registration.Owaisi concluded by stressing the importance of transparency and accountability in land management and warned the government that the people would not tolerate inefficiency and corruption any longer. He urged the government to ensure that landowners' rights are protected, and the Dharani portal is restructured to serve the people rather than a select few.


