#### **RGIA** records steady growth



Hyderabad's Rajiv Gandhi International Airport (RGIA) has recorded a steady growth in number of passengers with 27 lakh flyers using the facility in December 2024. This is a 17.8 per cent increase, compared to December 2023 when there were 23 lakh passengers, according to a statement. In November 2024, the airport handled 25.3 lakh passengers. The December 2024 passengers data reflected a near-seven per cent growth over the previous month. The consistent growth shows Hyderabad's rising connectivity, both domestically and internationally, as well as an uptick in festive and holiday travellers.

#### Gold Rallies Rs 500 to Rs 81,300 per 10 gm



Gold prices rallied Rs 500 to hit over a two-month high of Rs 81,300 per 10 grams in the national capital on Thursday amid fresh buying from jewellers and retailers and rupee depreciation, according to the All India Sarafa Association. The precious metal had closed at Rs 80,800 per 10 grams on Wednesday. The price of gold of 99.5 per cent purity climbed Rs 500 to Rs 80,900 per 10 grams. It settled at Rs 80,400 per 10 grams in the previous

trading session. Silver also surged Rs 2,300 to Rs 94,000 per kg from the previous close of Rs 91,700 per kg on Wednesday. Meanwhile, gold contracts for February delivery rose Rs 297, or 0.38 per cent, to Rs 79,007 per 10 grams in the futures trade on the MCX on Thursday.

# **Huge win for Telangana in** Krishna river battle with AP

In a huge victory for Telangana against Andhra Pradesh over the sharing of the Krishna river water, the Krishna River Water Disputes Tribunal-II on Thursday said it was inclined to take up the issue of project-wise allocation of water under the new terms of reference (TOR) issued by the Centre in 2023, a stand that Telangana had fought hard for in face of stiff opposition from AP.

minister N. Uttam Kumar Reddy, who was in New Delhi supervising Telangana's arguments before the Tribunal, welcomed the decision and said: "The decision will pave the way for proper justice to be delivered to Telangana." He said that under the additional terms of reference (TOR) given by

the Centre, allocation of River Krishna waters would include the earlier en bloc allocation of 811 thousand million cubic feet (tmc ft) done by the Bachawat tribunal, thus enabling Telangana its

rightful share of the

river's waters."

He said as per the provisions of Section 89 of the AP Reorganisation Act 2014, KWDT-II was to make project-wise specific allocations if they were not made by a tribunal set up as per the Interstate River Water

Disputes (SRWD) Act, 1956. "But as per these TOR, the already existing project-wise allocations are not to be touched, thus restricting the amount of water to be distributed afresh to Telangana," Uttam Kumar Reddy explained.

"In 2015, Telangana went to the Supreme Court asking for the setting of up a new tribunal which eventually paved the way for the Central government to issue new terms of reference (TOR) to KWDT-II (Brijesh Kumar Tribunal).

# Armed Gang on the Run After ATM Heist Opens Fire in Hyderabad

An armed two-member gang, accused of killing two security guards at an ATM kiosk in Bidar, Karnataka, and looting ₹93 lakh, opened fire at a travel company manager in Afzalgunj on Thursday. The manager, Mohammed Jahangir, sustained injuries to his leg and abdomen and is undergoing treatment in the ICU of a private hospital. According to the police, the

gang, attempting to escape to Raipur, entered into an argument with Jahangir at a travel office and fired two rounds before fleeing towards Osmania General Hospital. City police have issued a red alert and intensified frisking operations in southeast, east, central, and southwest zones to track down the assailants. Sequence of Events

The gang, aged between 30 and 35 years, reportedly crossed into Telangana on a bike early Thursday morning after their attack in



Bidar. They arrived at a travel office in Hyderabad around 3 PM, requesting tickets to Raipur. Witnesses reported their suspicious

behavior, including wearing hoodies and carrying backpacks. Coincidentally, a Karnataka police team arrived at the office to serve NBWs in a separate case. Spotting the officers, the gang panicked and attempted to bribe Jahangir with a bundle of cash to issue tickets immediately. When Jahangir demanded ID cards, one of the assailants opened fire and

Police Response East Zone police, along with four special teams and task force per-

sonnel, are conducting operations to apprehend the attackers. Karnataka police teams have also joined the investigation. IT teams are tracking the suspects through GPS and CCTV footage, and one of the attackers is believed to be

Forensic experts are examining spent shells of a 9 mm countrymade pistol recovered from the scene. Authorities confirmed Jahangir's condition is stable despite heavy bleeding. **Eyewitness Accounts** 

Mohammed Wali, a passenger at the scene, recounted that the gang initially approached the travel office on a bike and appeared tense. Roshan Travels owner Mohammed Mousam added that Jahangir became suspicious due to their unusual behavior and attempted to delay their request.

The incident has triggered widespread alarm, and police efforts are underway to bring the fugitives to justice.

#### Six-lane ORR-Kondapur flyover likely to be ready by April

six-lane flyover from Outer Ring Road (ORR) towards Kondapur is likely to be completed by April, having already missed its deadline of last April. This facility will provide traffic relief at Gachibowli junction and also ensure better connectivity between Hitec City and the financial district. The commuters will enter this flyover from one of its ramps on the

The 1.2-km bi-directional

ORR and reach street number 2, Gachibowli, skipping the junction. The flyover ends approximately 300 metres before the ZP

Traffic going out of the city through Gachibowli can directly reach the ORR through another ramp of the flyover. Speaking about the flyover, a GHMC official said that works are in their final stages. He blamed TSSPDCL for the delay. "Despite paying Rs 2.78 crore to it, the utility shifting was delayed. Finally, GHMC commissioner K. Ilambarithi had to intervene and get the issue resolved," said an official from the corporation.

When asked, power officials did not offer comment on the delay in shifting the cables. According to GHMC records, the peak hour traffic at the Gachibowli junction was 9,806 passenger car units (PCU)/hour in 2019. The projected peak hour traffic in 2036 will be 17,711 PCU/ hour. # Hyderabad's Heritage Sites Make it to 2025 World Monuments Watchlist


Hyderabad's Musi River buildings including the Osmania General Hospital (OGH), High Court, and State Central Library, have earned a place on the 2025 World Monuments Watch. The World Monuments Fund (WMF), based in New York, selected these structures from over 200 nominations worldwide, bringing global attention to the challenges they face due to environmental degradation, neglect, encroachment and urban expansion. This recognition could give fresh momentum to the state government's Musi Riverfront Development Project and Chief Minister Revanth Reddy's



vision of the city's heritage. The WMF described the Musi River corridor as a cultural anchor of Hyderabad, with its historic buildings reflecting the city's evolution. "Landmarks like the Osmania General Hospital, City College, and the State Central Library represent Hyderabad's civic and architectural history. These structures once

connected neighbourhoods and markets, serving as shared spaces in urban life," the WMF stated.

This listing owes much to the efforts of three Hyderabadis and WMF India Council members Shalini Bhupal and Xavier Augustin and conservation architect Anuradha Naik. "When organisations like WMF back a project, it brings global credibility. It also starts local conversations and encourages people to care for their heritage, which is of utmost importance. WMF has been part of rebuilding projects like Angkor Wat and Notre Dame. Their expertise can change how Musi's historic buildings are preserved," Xavier Augustin told.

#### Passengers Pick APSRTC Due to Low Fares

Passengers travelling to Andhra Pradesh for Sankranti were found to be favouring APSRTC buses for their lower fares over those of the TGSRTC. APSRTC retained standard ticket fares, whereas the TGSRTC charged one-and-a-half times the regular fare for its special services. AP buses were offering luxury and deluxe services, the Mahalakshmi fares do not apply for these services on the



TSRTC, thereby eliminating any advantage. APSRTC deployed 2,200 special buses for the festive season and became the first choice. Those who were unable to secure

APSRTC tickets opted for the TGSRTC services. Despite this, all TGSRTC buses have reported full occupancy through advance bookings. TGSRTC, on the other hand, operated 1,600 special buses and 1,500 regular. A senior TGSRTC official noted that 330 special buses scheduled for Friday and Saturday achieved full occupancy through advance reservations.

Explaining the higher fares, the official said, "TGSRTC's special buses, which often

have no fixed depot stops, run empty in one direction, such as the 650-km trip to Visakhapatnam. The additional fuel costs are a factor, leading to the one-and-a-half fare for special buses. Each bus carries around 40 passengers." TGSRTC reported carrying approximately five lakh passengers during the Sankranti season, with additional trips planned for the weekend to accommodate the ongoing demand of people returning to Telangana.

### Enumamula agriculture market opens after Sankranti

After a five-day holiday for Sankranti, Enumamula Agriculture Market in Warangal saw a bustling atmosphere on Thursday as farmers brought large quantities of chilli and cotton to sell their crops. The market saw the arrival of around 4,000 chilli bags of various varieties and 600 cotton bags. To handle the surge, authorities made special arrangements to ensure smooth operations. Among the chilli varieties, Teja Chilli fetched a maximum price of ₹14,800 per quintal and a minimum of ₹1,100, while Wonder Hot Chilli sold at a maximum of



₹13,000 and a minimum of ₹10,000. Cotton was sold at a maximum price of ₹7,210 per quintal and a minimum of ₹6,200, slightly below the Minimum Support Price (MSP) of ₹7,521.

Meanwhile, the Cotton Corporation of India (CCI) announced a further reduction in the MSP for cotton, citing quality considerations. The new MSP, effective from today, stands at ₹7,421 per quintal, down from ₹7,471, marking a

past 15 days, the MSP has been reduced by a total of ₹100. In private markets, cotton is currently being sold at ₹7,060 per quintal, further adding to concerns among farmers. The lively trading at the Enumamula Market reflects both the excitement of post-festival sales and the challenges faced by farmers navigating fluctuating market dynamics.

# Give Velimela lands back to tribals: Raghunandan

BJP Medak MP M. Raghunandan Rao demanded that the government give land rights to tribal farmers who have been cultivating a 429acre parcel in Kondakal and Velimela villages in Shankarpally and Ramachandrapuram mandals of Sangareddy and Rangareddy districts respectively. He charged that some land sharks had been trying to get control over this huge chunk of land.

Addressing a press conference, Raghunandan Rao said the tribal farmers had been mak-



ing multiple rounds of revenue offices seeking land ownership rights as they have been cultivating the land for generations. The government had long ago allotted 180 acres to the AP radesh Industrial Infrastructure Corporation (APIIC) to set up indus-

tries. The MP said the tribals were being deprived of their rights over the land as some BRS leaders have eved a large chunk of it. "The revenue officers have given new survey numbers to these land parcels as part of survey settlement. Some BRS

leaders took advantage of it and set their sights on the land, which is worth more than `1,200 crore. The dispute started in 2009, is still going on and false cases have been filed against 17 tribals," he explained. Raghunandan Rao said the Sangareddy police have been camping on the land for the last three days as some people are trying to get the land by vacating the villagers. He urged Chief Minister A. Revanth Reddy to sell the 180-acre land and use the funds for Rythu Bharosa. He announced his visit to the village

# Krishna Water Disputes Tribunal-II prioritises water sharing issues for crucial phase of hearing

The Krishna Water Disputes Tribunal-II (KWDT-II) issued a significant ruling on Thursday, deciding to prioritize the 'Further Reference' in its ongoing proceedings. This decision pertains to crucial questions concerning the water-sharing arrangement between the states of Andhra Pradesh and Telangana, which could have substantial implications for project-wise water allocation under Section 89 of the Andhra Pradesh Reorganization Act (APRA) of 2014. The KWDT-II is currently addressing two primary references. The first concerns Section 89 of the APRA 2014, which



outlines the equitable allocation of water resources between the newly formed states of Telangana and Andhra Pradesh. The second reference pertains to Section 3 of the Inter-State River Water Disputes (ISRWD) Act of 1956, which focuses on the broader allocation of Krishna River water among the riparian states.In its latest order, the Tribunal clarified that it would consider the evidence from the reference under Section

89 of the APRA in the context of the 'Further Reference'. The admissibility of certain documents will be determined during the arguments. While acknowledging that there is overlap between the issues in both references, the Tribunal determined that it would be more appropriate to address them separately. Telangana had initially requested that the Tribunal consider both references together. However, Andhra Pra-

desh objected to this proposal and filed a writ petition challenging the validity of the 'Further Reference'. Telangana, in its submission, strongly argued for a revision in the existing water-sharing ratio, which has been in place for the past decade. Currently, the ratio stands at 66:34 in favor of Andhra Pradesh, but Telangana has called for an amendment to this allocation. The state has urged the KWDT-II to revise the water-sharing arrangement and issue a permanent resolution in this regard. The proceedings witnessed significant participation from key figures. #### Public Rally in Hyderabad on March 15th to Push for Change in Political Leadership: Nune Venkat Swamy's Call

Nune Venkat Swamy, State Convenor of the Bahujan Liberation Front (BLF) and President of the People's Struggle Committee (PRPS), has called for a massive public rally on March 15th at the Saroornagar Stadium in Hyderabad. Under the slogan "We hold more power in the population," the rally aims to gather one lakh people from various regions to demand a change in political leadership in Telangana. Speaking at a PRPS leadership meeting, Venkat Swamy emphasized the need for a new political system where power is distributed among marginalized



communities. He proposed that over 50% of the state's BC population should have the opportunity to serve as Chief Ministers for two years, SCs (with 20% of the population) for one and a half years, and tribals (with 10%) for one year. # Over 2,000 government schools in Telangana lack toilet facilities for girls

Hyderabad WUT | Jan. 17

Thousands of students in government-run schools across Telangana are grappling with a lack of proper sanitation facilities, with over 2,000 schools having no toilets at all and another 2,200 schools facing defunct facilities. The findings, revealed in the Unified District Information System for Education (UDISE) Plus report for the academic year 2023-24, have brought to light the grim reality of basic hygiene issues in schools.Out of 29,383 government-managed girls' and co-educational schools, 27,366 schools have toilet facilities, leaving 2,017 schools without this essential amenity. Female students, in particular, are bearing the brunt of this crisis, as many are forced to either use open spaces or hold their bladder until they return home. The lack of toilets has led to several girls reporting urinary tract infec-



tions, with the problem worsening during menstruation. Without access to safe and hygienic facilities, many female students are compelled to stay home during their periods, affecting their education.Even among the schools equipped with toilets, only 25,089 have functional facilities, while 2,277 toilets remain unusable due to poor maintenance, lack of running water, or absence of security. Telangana ranks below the national average, with only 93.1 per-

cent of schools having toilet facilities for girls compared to the national average of 97.1 percent. In terms of functional toilets, the State lags further behind, with just 85.4 percent of schools meeting this criterion against the national average of 93.2 percent. The situation is equally concerning for boys in government schools, where 4,823 schools lack toilet facilities and 2,618 schools have non-functional toilets. Only 83.2 percent of schools in the State pro-

vide toilet facilities for boys, compared to the national average of 94.8 percent, with just 74.1 percent having functional toilets, far below the national average of 90 percent.Teachers and administrators blame stalled construction projects and poor maintenance for the crisis. The construction of toilets under the "Mana Ooru – Mana Badi" program was halted midway in several schools following a change in the State government and subsequent lack of funds.

failed to address the problem.A government high school headmaster, speaking anonymously, stated, "Lack of maintenance and timely release of school grants are the primary reasons for this issue. Additionally, the absence of security has left school toilets vulnerable to theft. In many cases, taps and fixtures were stolen, and running water supply remains a persistent challenge."The findings highlight the urgent need for immediate intervention by the State government to address these infrastructural issues. Completing stalled projects, ensuring regular maintenance, and providing sufficient funds for school grants are essential to improving the situation. Without these measures, thousands of students will continue to face health risks, indignity, and disruption in their education.

#### 'We lost so many': Gaza cautiously waits for ceasefire as bombing continues

New delhi WUT | Jan. 17

Palestinians in the Gaza Strip woke up on Thursday to the sound of renewed bombing, adding trepidation to the joy they felt at the news that a ceasefire had been agreed between Israel and the Palestinian group Hamas the night

before. They hope that announcement will mean an end to Israel's 15month war, which has killed more than 46,700 Palestinians and left thousands more missing. But their memories of the war will not go away any time soon.In Deir el-Balah in central Gaza, many people are displaced from other areas of the enclave after fleeing their homes in the wake of Israeli attacks or Israeli orders to leave or face bombing.

They have struggled to survive. Many have lost their nearest and dearest and feel lucky to be alive. But what comes next is still unknown. And with the devastation across Gaza so evident and Israel seemingly unwilling to leave the territory alone, many pitfalls lie ahead

in the future. Al Jazeera spoke to people in Deir el-Balah the day after Wednesday's announcement of the ceasefire as they await its implementation on Sunday. Here's what they had to say:It feels very nice. We're so happy. It feels like it's Eid. We hope this feeling remains forever and that we don't see any more bloodshed. We hope that we don't see it again and that we won't have to live through this experience again. We all lost people. I lost my brother, my nephew, my other nephew and another relative. I'm worried that in the coming days we will see more escalation. This is the nature of the Israeli politicians. Before signing a ceasefire or before a ceasefire comes into effect, they continu-

ously try to escalate the killing more and more. The pace of the killing intensifies. In 2014, on the last day of the war, I lost my sister and her

children. There is still a great concern that the Israeli leadership might backtrack on agreements, and the pace of the killings has increased in the last two or three days, so I pray to God that this does not happen. After the war, there will be a large number of people suffering from very difficult psychological conditions from tensions and phobias and the fears they have lived through. It's possible that these conditions and psychological fatigue could even get worse and develop beyond depression. There must be treatment for these people. Even a few days ago, I had a case of an elderly woman whose son passed away. She was suffering from severe mental health problems and began psychiatry sessions to aid her situation. Honestly, my feelings are indescribable. It was a great joy, I cried and was happy at the same time. I cried over the things that happened to us. It wasn't easy, and there is a lot of sadness. People's hearts are wounded. The

We lost people. Some are missing, some were taken by the [Israeli] occupation and some were martyred. Generally, I'm happy that the bloodshed and violence are going to stop, but at the same time, I'm sad because we've lost many dear and precious people. But it happened, and all you can do is pray to God. God willing, the ceasefire won't collapse and will continue this time. Honestly, I would have preferred an immediate ceasefire because these two difficult days have been worse than the whole of the past year.

# 'Devastating': Wildfire ravages historic **Black community in Los Angeles**

Bill Threadgill picked through the ashes of his home in Altadena, California, where he lived for 15 years, pulling out copper pipes and setting them aside to sell. Only his chimney and two porch pillars remained standing, but nothing else. A wildfire had burned the whole structure to the ground.Even before flames swept through the area, his family had struggled to make ends meet. "We've been stretched financially," Threadgill, a handyman and caregiver, said through his N95 face mask.

On January 7, the Eaton Fire ignited in the nearby mountains, forcing thousands of residents to evacuate. Fanned by hurricane-force winds, the fire damaged or destroyed more than 5,700 structures and killed at least 16 people.

It was one of a series of blazes that tore through the Los Angeles area over the last week and a half, intensified by climate change. All told, nearly 12,000 buildings have been consumed, and mpeople killed.

The fires could become one of the costliest natural

disasters in United States history, with experts estimating \$250bn in damage.While

multimillion-dollar homes were destroyed in the wealthy Pacific Palisades area, the working-class neighbourhood of Altadena was also devastated.

mSome of the victims were elderly or disabled and could not flee. Threadgill himself lived with and cared for a 73year-old friend whom he considers family. She was in short-term convalescent care at the time of the fire.

As he walked through the debris, he searched for his calico cat, Catra. "I hope that she got out, because I left the back door open for her to get out," he said. He looked at the spot where his front door used to be. "Won't be entering here like this no more. Never again," Threadgill said. "Uprooted unexpectedly. # BJP Releases Second List for Delhi Assembly Elections, Features 29 Candidates

New delhi WUT | Jan. 17

The BJP on Saturday released its second list of 29 candidates for the upcoming Delhi Assembly elections, fielding former AAP leader Kapil Mishra from Karawal Nagar. Mishra, now aligned with hardline Hindutva politics, replaces sitting MLA Mohan Singh Bisht. The party also named Harish Khurana, the son of former Delhi Chief Minister Madan Lal Khurana, as the candidate from Moti Nagar. With this announcement, the BJP has now named candidates for 58 out of the 70 seats

in the Delhi Assembly. The elections are scheduled for February 5, with the vote counting set for February 8.Mishra, known for his controversial speeches before the communal riots in northeast Delhi in February 2020, will compete for the seat alongside Abhay Verma, the sitting BJP MLA from Laxmi Nagar, who will seek reelection. Verma won the constituency in 2020 by a narrow margin of just over 800 votes. Additionally, BJP has fielded candidates from the Purvanchali community, including Bajrang Shukla from Kirari and Pankaj Singh from Vikaspuri.

Karnail Singh, Delhi BJP's Mandir Prakoshth chief, will contest against sitting AAP MLA and former minister Satyendar Iain in Shakoor Basti.Other notable candidates include former Kasturba Nagar MLA Neeraj Basoya, who recently defected from Congress, and Pawan Sharma, the former Delhi BJP general secretary, who will contest from Uttam Nagar. The list also includes several women candidates, such as Deepti Indora from Matia Mahal, Urmila Kailash Gangwar from Madipur (SC), Shweta Saini from Tilak Nagar, Priyanka Gautam from Kondli

(SC), and Neelam Pahalwan from Najafgarh.The BJP has fielded four former MLAs and eight sitting municipal councilors. Former mayor Shyam Sharma has been nominated from the Hari Nagar seat, which has a significant Sikh population. The party is expected to announce candidates for the remaining 12 seats, including Delhi Cantt, Greater Kailash, and Shahdara, after further discussions. Sources indicated that former Union Minister Meenakshi Lekhi was considered for the Greater Kailash seat, although she expressed interest in contesting from

Mark Carney, the former head of the Bank of Canada, has formally entered the race to replace Prime Minister Justin Trudeau as leader of the ruling Liberal Party. Carney launched his campaign for the party leadership at a rally in Edmonton, the capital of Canada's western province of Alberta, on Thursday afternoon."I'm back home in Edmonton to declare my candidacy for leader of the Liberal Party and prime minister of Canada," said Carney, flanked by supporters and Liberal lawmakers. The 59-year-old is con-

#### SMART OR STUPID FOR 2025?

"If we are so smart, why are we so stupid?" This striking remark by Israeli historian Yuval Noah Harari has gained the attention of millions

tion of millions worldwide, sparking diverse reactions and reflections on the state of contemporary human intellect. My brief exploration into this question led me to realise that Harari is not the first great mind to express such a sentiment. Similar notions have been echoed by intellectuals and geniuses across history. For instance, there's a popular saying that, 'scientists should stop analysing animal intelligence and start studying human stupidity.' This perspective is often (though not definitively) attributed to Argentinian Nobel laureate César Milstein. Existential Questions

In the same manner, Albert Einstein once humorously quipped, "Two things are infinite: the universe and human stupidity; and I'm not sure about the universe." Einstein's words remind us to be mindful of our own fallibility when attempting to understand and master the unknowns of the cosmos. Harari's statement reflects this lineage of thought. Like Milstein and Einstein, he underscores the importance of questioning, rethinking and facing our ignorance, even as we invent, discover, and innovate.

A few days ago, I watched an intriguing interview in which journalist Andrew Ross Sorkin spoke with Harari. In this conversation, Harari raised numerous existential questions about the trajectory of technological advancements — are they for the good or the detriment of humanity? His most emphatic observation was a haunting one: how can humans, capable of showcasing amazing scientific and technological achievements, also exhibit such profound stupidity that they risk self-destruction?

Harari's latest book,

Nexus: A Brief History of Information Networks from the Stone Age to AI, released in September 2024, delves into the hidden dynamics of information networks, which are truthful and deceptive, that form the foundations of artificial intelligence (AI) systems. He warns that these networks can lead to unpredictable and potentially catastrophic consequences, including scenarios like an AI-

# Notice to director of prosecutions in contempt case

Justice Pulla Karthik of the Telangana High Court ordered notice to the director of prosecutions holding full additional charge for the state and others in a contempt case pertaining to delegation of powers to a junior officer. The judge was dealing with a contempt case filed by P. Manjula Devi alleging wilful disobedience of the orders passed by the judge in an earlier writ plea. The petitioner, the most senior officer, working as additional public prosecutor (grade I)/deputy director of prosecution before the XIII Additional District and Sessions Judge's Court, LB Nagar filed the writ plea. The petitioner contended that administrative powers were delegated to the APP (grade-I)/deputy director of prosecution declaring them as unit officers at the district-level as per GO dated September 24, 2013.

As per the GO, since the petitioner as the senior-most officer in the unit was deemed as the unit officer and the drawing and disbursing officer in Rangareddy district. The petitioner alleged that the respondent vide impugned proceedings delegated the powers to the unofficial respondent, who is junior to the petitioner and is the most junior officer in the district. The judge in the earlier plea passed an interim order suspending the impugned proceedings, insofar as conferring the powers of drawing and disbursing officer to unofficial respondent was concerned. The petitioner alleged that despite the interim suspension, the respondents failed to implement the orders passed by the judge and thus guilty of contempt. The matter is posted for further adjudication.

# Telangana HC disposes 66-year long pending CS-7/1958 suit

Hyderabad WUT | Jan. 17

The Telangana High Court has recently disposed of a partition suit that was pending for 66 years, known as CS 7/1958, among the legal heirs of Nawab Moinud-Dowla Bahadur (son of Asman Jah Bahadur. 28th prime minister of Hyderabad and Tahniyath Ali Khan, daughter of the fifth Nizam) over the Matruka properties of the family, which includes several maktas like Raidurg and Shamshiguda. The CS 7 suit led to multiple court cases and applications before the High Court and the Supreme Court. A division bench of the High Court, comprising Chief Justice

Alok Aradhe and Justice N.V. While the suit was pending, several third parties and the legal heirs of the Nawab filed applications in the pending partition deeds claiming the land, seeking possession and delivering possession of the lands mentioned in

the 25 maktas. The third parties claimed that some of the legal heirs had sold their share and submitted to the High Court a copy of the order of the commissioner of survey settlement—releasing makta land dated 30.12.1977.

filed to the extent of the release order pertaining to the land in the maktas. The court faulted their claims and wanted to know what they were doing till 2023, as the release order was issued in 1977. The court expressed doubts about the document and rejected the claims, since the land was not available physically. # APPROACH AFTER ALL APPEALS: HC

**Hyderabad** WUT | Jan. 17

Justice T. Vinod Kumar of the Telangana High Court dismissed a writ plea reiterating that the remedy of appeal needed to be exhausted first, before invoking the jurisdiction of the High Court under Article 226 of the Constitution. The judge was dealing with a writ plea filed by Gopu Srinivasa, who challenged the freezing orders issued by the inspector of police, Rajendranagar, which was confirmed

by the competent authority under the Narcotic Drugs and Psychotropic Substances (NDPS) that froze the petitioner's assets on suspicion of involvement in narcotics-related activities.

The petitioner argued that the original freezing order was set aside by the metropolitan sessions judge of RR district. Despite this, authorities issued fresh orders freezing the assets, which the petitioner claimed were illegal, violated principles of natural justice, and infringed rights under the

Constitution. The petitioner sought a declaration that the freezing orders were null and void and requested de-freezing of his properties. The judge, however, held that the petitioner should first exhaust the appellate remedy provided under Section 68-O of the NDPS Act. Citing the Supreme Court's judgment in Whirlpool Corporation v. Registrar of Trade Marks (1998), the judge, while dismissing the writ plea, directed the petitioner to approach the appellant authority under the NDPS

#### 3 MEN FROM MADHYA PRADESH MURDER SEX WORKER IN HYDERABAD

### 'Blue Velvet' filmmaker David Lynch dies days before his 79th birthday



David Lynch, the filmmaker celebrated for his uniquely dark vision in such movies as Blue Velvet and Mulholland Drive and TV series Twin Peaks, has died just days before his 79th birthday.

His family announced the death in a Facebook post on Thursday. The cause of death and location was not immediately available, but Lynch had been public about his emphysema."We would appreciate some privacy at this time. There's a big hole in the world now that he's no longer with us. But, as he would say, 'Keep your eye on the donut and not on the hole,"" the post read. "It's a beautiful day with golden sunshine and blue skies all the way."

Last summer, Lynch had revealed to Sight and Sound that he was diagnosed with emphysema and would not be leaving his home because of fears of contracting the coronavirus or "even a cold."

"I've gotten emphysema from smoking for so long and so I'm homebound whether I like it or not," he had said, adding that he didn't expect to make another film. "I would try to do it remotely, if it comes to it," Lynch said. "I wouldn't like that so

Lynch was a onetime painter who broke through in the 1970s with the surreal Eraserhead and rarely failed to startle and inspire audiences and peers in the following decades. His notable releases ranged from the neo-noir Mulholland Drive to the skewed Gothic of Blue Velvet to the eclectic and eccentric Twin

His other credits included the crime story Wild at Heart, winner of the Palme d'Or at the Cannes Film Festival; the biographical drama The Elephant Man and the G-rated, aptly straightforward The Straight

Actors regularly appearing in his movies included Kyle McLachlan, Laura Dern, Naomi Watts and Richard Farnsworth.

Lynch was a Missoula, Montana, native who moved around often with his family as a child and would long feel most at home away from the classroom, free to explore his fascination with the world.

He had an early gift for visual arts and a passion for travel and discovery that led to his enrollment in the Pennsylvania Academy of the Fine Arts and the beginning of a decade-long apprenticeship as a maker.

request that the media and paparazzi refrain from the relentless speculation and coverage," she wrote on the social media platform.







# BCCI's 10-point policy: Domestic cricket mandatory, restrictions on family and personal staff stay



Mandatory domestic cricket, restriction on the presence of families and personal staff on tours and a bar on individual endorsements during series were among a slew of measures that the BCCI unveiled on Thursday in a 10-point policy to promote "discipline and unity" in the embattled national cricket team.

Non-compliance would invite sanctions, including cuts in their retainer fee from central contracts and a bar on participating in the cash-rich Indian Premier League. The measures have been announced in the wake of the team's disastrous tour of Australia which was preceded by a series whitewash against New Zealand at home.


The Board has approved only a two-week window for families to stay with the players during overseas tours, besides imposing restrictions on personal staff, and commercial shoots.

"Any exceptions or deviations must be pre-approved by the Chairman of the Selection Committee and Head Coach. Non-compliance may lead to disciplinary action as deemed appropriate by the BCCI," the Board policy states.

"Additionally, the BCCI reserves the right to take disciplinary action against a player which may include sanction against the concerned player from participating in all BCCI conducted tournaments including the Indian Premier League; and deduction from retainer amount/match fees under BCCI Player contract," it warns.

The document also states that from now on, players won't be allowed to travel separately during a tour and would also be discouraged from leaving early in case a tour or a match ends early.

#### Barcelona hammer Real Betis 5-1, advance to quarterfinals of Copa del Rey



Barcelona followed up its rout of Real Madrid in the Spanish Super Cup final with a comfortable 5-1 victory over Real Betis in the round of 16 of the Copa del Rev.

"The Indian players' style is characterised by their exceptional strength and power," Wang said. "Their attacks are highly threatening, and their height further enhances their gameplay, making them formidable opponents." Liang and Wang, who have claimed titles at the Malaysia, Indonesia, and Denmark Opens, are among the many top players who have recognised the growing influence of Satwik and Chirag in men's doubles on the international circuit. Top Indonesian pair Fajar Alfian and Muhammad Rian Ardianto, who have also faced Satwik and Chirag in recent tournaments, have had similar assessments. "They



have a good speed-power game, and with their tall stature, facing them has been difficult for us," Alfian said.

"The key point is that they play with a lot of confidence and have incredible attacking and defending power, which boosts their confidence during matches. And that's what makes them strong. That's why they perform well, and they are experienced also," Ardianto added.

Satwik and Chirag's journey has been marked by steady progress, with key milestones being the Hangzhou Asian Games gold medal, Thomas Cup victory, India's first-ever men's doubles bronze at the World Championships in 2022, Commonwealth Games and

Asian Championships title triumphs. The duo also won Super 1000 title in Indonesia in 2023 and finished runner-up in Malaysia last year, besides claiming the French Open Super 750 twice in 2022 and 2024 and four Super 500 titles in Thailand, Korea and India.

Despite a tough Olympic campaign, where they narrowly missed out on a medal, the duo has maintained a strong focus on their goals, reaching the semifinals in 2024 China Masters and Malaysia last week.

On the other hand, Alfian and Ardianto were part of Indonesia's winning team at the 2020 Thomas Cup, and were silver medallists at the 2024 edition.

Talking about the changing compet-

itive landscape, Alfian said, "In men's doubles, many have also changed their partners. After the Olympics, many Korean players, many Indonesian players have also changed their partners. We must always be ready to face anyone because they are not the same pair." Beyond the competition on court, the badminton world fosters mutual admiration and friendships. Alfian, 29, shared that his parents are Bollywood fans. "My parents often watch Indian films. I've seen some films, like Kuch Kuch Hota Hai," he quipped, before striking a playful pose with Ardianto to replicate a famous Shah Rukh Khan gesture.

# Australian Open: US teen Learner Tien knocks Daniil Medvedev out in Round two thriller

Learner Tien, a 19-yearold qualifier from California, became the youngest American man to reach the Australian Open's third round since Pete Sampras in 1990, upsetting a racket-tossing Daniil Medvedev 6-3, 7-6 (4), 6-7 (8), 1-6, 7-6 (10-7) on Thursday night. The 4-hour, 49-minute contest had a bit of everything, including — hard to believe — a six-minute rain delay that interrupted play shortly before 2:30 a.m. with Tien serving at 5-all, 15-all in the fifth set. When they resumed, Medvedev broke and served for the victory at 6-5, but Tien wouldn't cede a thing, broke back, and forced the concluding first-to-10 tiebreaker that he emerged to win shortly before 3 am, about two hours after he failed to convert his initial match

brow-raising because of the wide gulf in experience and accomplishments between the two players at Margaret Court Arena. Tien is ranked 121st and owned a career Grand Slam record of 0-3 before this week; Medvedev was seeded No. 5, won the 2021 US Open and was the runner-up at Melbourne Park in three of the past four years, including 12 months ago. "I was definitely hoping it wouldn't go to a fifthset breaker. ... It was definitely harder than maybe it could have been, but, whatever," Tien said, then told the crowd: "I really appreciate all you guys staying out here. I know it's late. I have no idea what time it is." Because of the time dif-

Because of the time difference, the match ended at about 8 am on Thursday morning back home in California, and he took the microphone to speak directly to his family —



he said he hoped they were tuned in on TV. "I don't know if my parents are still watching. ... I love you guys. Thank you for always supporting me from across the world," Tien said. "I know you guys wish you could be here. I wish you could be here, too." The left-handed Tien played fearlessly and almost flawlessly for stretches, surprisingly getting the better of lengthy exchanges at the baseline: Across the first

two sets, he won 32 of the 51 points that lasted nine or more strokes, even coming out on top on one that went 45 shots and another that lasted 32. Tien did not blink until he reached the precipice of by far his most important win, holding a match point in the third-set tiebreaker when he led it 7-6. But Medvedev erased that with a 122 mph (196 kph) ace and eventually converted his third set point at a little past 1 am, then easily pushed things

Medvedev was penalized a point in the third set while showing the same sorts of signs of frustration that led him to destroy a tiny camera hanging in the net by smacking it with his racket during a surprisingly difficult, five-set, first-round win against an opponent ranked 418th. After getting broken to trail 4-3 in the second set when Tien delivered a lob that landed at a baseline — not the only time he

— not the only time he did that to his 6-foot-6 (1.98-meter) foe — Medvedev chucked his equipment toward the sideline, skidding it across the court until it reached an advertising panel near his beach

bench.
At other moments of anger, Medvedev hit a ball against the back wall toppled a camera behind a baseline and punched his racket bag. He also voiced displeasure about being called for two con-

secutive foot faults, resulting in a double fault, during the second-set tiebreaker.

# Formula-E case: KTR dares Revanth Reddy for live lie detector test

In a bold counter to the ongoing allegations against him, BRS working president KT Rama Rao on Thursday challenged Chief Minister A Revanth Reddy to a live lie detector test before a judge to settle cases of corruption rather than wasting public money in investigations for political vendetta.

"I have a Sankranti offer to

Revanth Reddy. Let us undergo a lie detector test together and face questioning by judges in front of the media with live telecast. I am ready to appear anywhere, anytime. Let the truth come out," he said, charging Revanth Reddy with orchestrating false cases to distract the public from his own legal troubles in the Cash-for-Vote scam and called on the Chief Minister to stop wasting public money on baseless investigations.

The BRS working president



reaffirmed his cooperation with investigative agencies, stating that he had appeared before the Anti-Corruption Bureau (ACB) on January 9 and the ED on January 16, despite no evidence of wrongdoing or corruption.

"Both agencies asked the same questions, and I have answered everything transparently," he said, reiterating his confidence in the judicimaligning his reputation. He also asserted that as a law-abiding citizen, he had and would cooperate with the investigation agencies as well as utilise the legal avenues available to prove his innocence.

He vowed to face any inquiry and prove his innocence, asserting that the truth will triumph ultimately — if not today, then tomorrow. He urged the public to see through the political games being played at the expense of governance and accountability

Earlier, Rama Rao left his Gachibowli residence at 10 am and arrived at the ED office in Basheerbagh under heavy police security. The ED had summoned him for questioning after the Telangana High Court dismissed a quash petition filed in the ACB case linked to the matter

Initially scheduled to appear on January 7, Rama Rao sought an extension until the High Court's decision, and the ED subsequently summoned him on January 16. Tensions ran high outside the ED office as a large number of BRS leaders and activists gathered in solidarity. They raised slogans against the government for indulging in political vendetta. A scuffle broke out between the party activists and police.

BRS spokesperson Manne Krishank was prevented from speaking to the media and detained. Several other BRS leaders, including Batthini Keerthi Latha and Pavani Goud, were also arrested.


