Trump births confusion among NRIs

Worried Indians plan to come back to homeland

Hyderabad WUT | Jan. 22

US President Donald Trump's executive order ending birthright citizenship for children of undocumented immigrants born in the country has sent shockwaves among immigrant communities, including an estimated 7.5 lakh undocumented Indians currently residing in the United States. American Civil Liberties Union, NAACP Legal

Defense and Educational Fund, State Democracy Defenders Fund and Asian Law Caucus filed a lawsuit, on behalf of immigrant support organisations, arguing that the order violates the 14th Amendment. Although more lawsuits and legal disputes are being prepared by Democrat-backed organisations, the announcement has already sparked widespread discontent among Non-Resident Indians (NRIs) and persons of Indian-origin. A



study cited that more than 7.5 lakh undocumented Indians are currently in the United States, and the decision taken by Trump will severely affect not just those currently living in the US, but also future travellers.

Deepa Kathi, a four-month pregnant IT professional in California, said "This decision has turned my joy into worry. I was hoping I could provide my child with a better future, but this decision has completely shocked me. I might return back to India with my husband soon." Bhanu Kumar, a student pursuing MS in New Jersey, said "The 14th Amendment grants citizenship to anyone who is born in this country, irrespective

of whether the parents are documented or not. The order is completely violating the base on which the USA stood."

Netizens too voiced similar opinions, with many saying Persons of Indian Origin (POI) will come back to India from the US. A user on X wrote "EO on birthright citizenship just encapsulated H1B visa holders too. Good luck keeping tech companies at bay.'



14 Naxals killed along Odisha-Chh'garh border

Union home minister Amit Shah on Thursday said 14 Naxals were killed in a joint operation by the CRPF, Special Operation Group of Odisha and Chhattisgarh Police along the Odisha-Chhattisgarh border. Describing it as another mighty blow to Naxalism, he said, "With the resolve for a Naxalfree India and joint efforts of security forces, Naxalism is breathing its last today". "Another mighty blow to Naxalism. Our security forces achieved major success towards building a Naxal-free Bharat. The CRPF, SoG Odisha, and Chhattisgarh Police neutralised 14 Naxalites in a joint operation along the Odisha-Chhattisgarh border," Shah wrote on

An official said the Naxals were killed in a fresh exchange of fire that took place late Monday and early Tuesday morning in a forest under the Mainpur police station area along the Chhattisgarh-Odisha border. A senior police officer of Raipur Zone confirmed the death toll, adding that a substantial cache of weapons was recovered from the site, including AK-47s, SLRs, INSAS rifles, and other automatic firearms.

Etala Rajendar Slaps Realtor Amid Land Dispute

In a heated altercation over a land dispute in Ekasilanagar, Pocharam IT Corridor, BJP MP Etala Rajendar was involved in an incident where he allegedly slapped a realtor. The dispute, between local plot owners and real estate agents, revolves around a 149-acre layout purchased by employees of various government departments in 1985. Police have registered a case against Rajendar and six others for wrongful restraint, causing hurt, criminal intimidation, and



insult.Rajendar, who was leading the plot owners, explained his actions by saying that he was compelled to act to protect the interests of the common people. "The circumstances made me act in order to protect 'dharma' and stand with the common man to safeguard their genuine rights," he later told Deccan Chronicle. He criticized the failure of revenue and police

officials to intervene, claiming he had to step in to address the lawlessness in the area. "I have never seen such lawlessness in my 25 years of political career," he added. The dispute traces back to the 1980s when 2,076 employees purchased the land, which was initially far from the city and filled with boulders and shrubs. As the land's value rose over time, some local real estate agents allegedly forged documents to claim the property as agricultural land. Court rulings in 2006 and 2011 favored the plot owners.

Adivasis Protest for Action on Pending **Tribal Welfare Issues**



Adivasis held a dharna seeking ROFR (Record of Forest Rights) documents and sought a road map for the same as promised by the government. They sought a discussion on the issue in the Assembly. Addressing the dharna near Indira Park here, Telangana Tribal Sangham state president Midiam Babu Rao, former Bhadrachalam MP, said, "Gutti koya tribals in Mulugu and Bhadradri Kothagudem districts are not getting caste certificates and are thus not able to avail any government schemes. Meetings of tribal advisory councils should be held along with ITDA councils at the district level and issues discussed to implement them."

The government should ensure tenders are called for proper collection of tendu leaves and payment of pending bonus payment for the same and payment of cash in the gram sabhas as the online system is being misused. Fake caste certificates should be verified by the ITDA and weeded out, he said. Officials responsible for their issue should be punished. Those responsible for denying loan waiver to tribals should be punished, he said and sought a mechanism of tribal welfare department, revenue and bankers to solve it.

A separate DSC should be conducted for the agency areas and vacant posts filled, he said and sought reinstatement of GO MS NO. 3 by writing to the centre. The leaders further sought declaration of villages with more than 50 per cent tribal population and their inclusion in the Fifth Schedule. They sought forest clearance for laying of roads, borewells for drinking water schemes

Kaleshwaram Project Bypassed Finance Dept: Key Revelations at Inquiry

The finance department

was reportedly kept out of crucial decisions taken by the then BRS government concerning the Kaleshwaram Lift Irrigation Scheme (KLIS), particularly in relation to the funds allocated for the project. This revelation surfaced during the cross-examination of Special Chief Secretary (Finance) K. Ramakrishna Rao by the Justice P.C. Ghose-headed commission of inquiry, which is probing various aspects of the KLIS barrages.Ramakrishna Rao, who has been heading the finance department since 2014 when the BRS assumed power, informed the commission



that a core committee of senior officials overseeing the project did not regularly update his department on its progress. When questioned about compliance with Government Order (GO) No. 2412, dated November 3, 2016, which mandated regular updates, Rao stated, "There is no record of the committee constituted by the GO apprising the progress of 'piece rate' system, wherein the government took charge of investigations, planning, and design, while contractors were responsible solely for execution. The finance department official was also questioned about the establishment of the Kaleshwaram Irrigation Project Corporation Limited (KIPCL), which was set up to fund the KLIS project. Rao revealed that KIPCL was initially provided with a corpus fund of Rs 100 crore and was tasked with generating further revenues. Revenue sources included the sale of water to industries, supply for drinking water purposes, and the development of tourism facilities at project sites.

Koppula Eshwar Criticizes Congress Government on Ration Cards and Dalit Welfare

Former Minister Koppula Eshwar, accompanied by former MLA Korukanti Chander and former Corporation Chairmen Ravinder Singh, Balaraj Yadav, and Lok Bapu Reddy, voiced sharp criticism against the Congress government at Telangana Bhavan. Eshwar highlighted the growing discontent among the public, particularly in Gram Sabhas, where

the Chief Minister and Ministers struggled to respond to challenging questions. He claimed that public representatives and officials were fleeing the Sabhas due to the mounting frustration from the citizens.

Eshwar took aim at the Congress government's handling of ration cards, accusing them of misleading the public. He pointed out that during the BRS regime, 6.47 lakh ration cards were distributed, with promises to clear any pending applica-

Xi and Putin discuss relations with Trump, Ukraine and Taiwan



New delhi WUT | Jan. 22

Russian President Vladimir Putin spoke with Chinese President Xi Jinping on ways to strengthen bilateral ties a day after Donald Trump was sworn in as the 47th president of the United States. The two leaders discussed their prospective contacts with Trump's administration during a wideranging video call that lasted more than one and a half hours, the

Kremlin said on Tuesday. Russian media reported that the two leaders spoke about boosting trade flows. China is the largest consumer of Russian energy and the single biggest oil export market for Russia. Xi and Putin "have indicated a willingness to build relations with the United States on a mutually beneficial, mutually respectful basis, if the Trump team really shows interest in this", Kremlin foreign policy adviser Yuri Ushakov told reporters in Moscow. "It was also noted from our side that we are ready for dialogue with the new US administration on the Ukrainian conflict." For his part, Trump has said he is willing to accommodate Russia's view that Ukraine's right to self-determination could be put aside in favour of peace and stability.Ushakov said Putin wanted longterm peace in Ukraine,

not a short-term ceasefire. No specific proposals for a call with Trump have been received, he said. On Taiwan, Ushakov said Russia had "confirmed its unwavering position of support for the one China principle". China regards democratically governed Taiwan as its own territory. In a New Year's speech, President Xi said that no one could stop China's "reunification" with Taiwan. Taiwan's government rejects Beijing's claims. Ushakov said the

Putin-Xi video call had been planned before Trump's inaugu-

China and Russia declared a "no-limits" partnership in February 2022 when Putin visited Beijing, days before he sent tens of thousands of troops into Ukraine. Putin has, in recent months, described China as an "ally".

Trump has said he will be tough on China and speak to Putin about ending the war in Ukraine. In remarks to reporters after his inauguration, Trump said Putin should make a deal to end the war because the conflict was destroying Russia.

Xi has called for talks to end the war in Ukraine and has accused the US of stoking the war with weapons sales to Kyiv, which has said it is ready to seek a negotiated solution that respects its interests.

At Davos, US Economist Explains What Will Make H-1B "Fantastic" For America

New delhi WUT | Jan. 22

A change in the H-1B visa policy for highly skilled professionals from India under Trump 2.0 would be "fantastic" for the US as it needs them, American economist Kenneth Rogoff told NDTV at the World Economic Forum (WEF) meeting in Davos.

Tesla and SpaceX chief Elon Musk, who works closely with US President Donald Trump, favours H-1B visas while allies in his Republican Party have splintered over the policy.

"... I think it would be fantastic for the United States. I don't know if it's fantastic for India," Mr Rogoff told NDTV, referring to India's brain drain problem. "And, you know, [Joe] Biden just seemed to follow Trump's policy on legal immigration. He didn't relax it at all. So, yes, we should have a much more relaxed policy on highly educated people who have a lot to contribute," Mr

Rogoff, who's also a former chief economist of the International Monetary Fund (IMF), told NDTV.

Joe Biden took over as US President in January 2021 after four years of Trump 1.0.

"I'm not saying that

there aren't people who have less education, who don't have a lot to contribute, but it should all be legal immigration, some rational system," Mr Rogoff added. On Day 1 of his second term, President Trump made several important announcements including pardoning 1,500 people involved in the US Capitol riots in January 2021, and "returning millions of criminal aliens back to places from where they

came". "I think there are some people who shouldn't be pardoned. Probably a lot of them should be. The Democrats did a lot of lawfare in their period, and I think he is pulling back on some of it. But where people hurt someone or someone died, that's different," Mr Rogoff said.



He said the Joe Biden-Kamala Harris border policy was "insane." "I've never heard anybody explain it to me," the economist said. "Legal immigration is great. But you know what? My graduate students who get a PhD, get an offer from a great university or a great job, can't stay because they can't get a green card. But if you come across the Mexican border illegally, and at least nine million people did, maybe 15 million people under Biden, it was no prob-

lem. That needs a realignment."

"In his first term, Trump cut back on both. Elon Musk seems to be persuading him that we need talented engineers from India and elsewhere. So it is a crisis on the southern border. That was the single craziest policy that Biden had. He [Trump] is not going to stop immigration. The border is huge. It was, I think, two million people cumulatively under him [Trump 1.0]. But certainly sending a message to try to slow

it down," Mr Rogoff said.

On Trump's announcement that he recognises only two sexes - male, and female, Mr Rogoff agreed it was a step backward and "we have gone to another extreme."

"His extreme is also not acceptable. And I don't think most American people support that. I think most American people supported transgender rights. But it was taken to an extreme where they didn't. And so trying to find some middle ground. I don't

know what he's really going to do," Mr Rogoff said. "I don't think you can turn the clock back. But, you know, clearly he's saying things that are very hurtful to many people. And that's ugly and, you know, not welcome," he added. The five-day meeting at Davos that began on Monday is exploring how to relaunch growth, harness new technologies and strengthen social and economic resilience, according to the World Economic Forum. The global meeting is seeing participation by nearly 3,000 leaders from over 130 countries, including 350

India's participation at Davos aims to strengthen partnerships, attract investment, and position the country as a global leader in sustainable development and technological innovation. India sent five Union ministers, three chief ministers, and ministers from several other states to the WEF this time.

Parliamentary Panel Considers NRI Representation in Parliament

The Parliamentary Committee on External Affairs is deliberating on the representation of Non-Resident Indians (NRIs) in the Parliament, in light of their increasing numbers and unique concerns. On Tuesday, the committee heard testimonies from various diaspora organizations during its examination of the subject "Indian diaspora overseas, including NRIs, PIOs,

OCIs, and migrant workers: their conditions, welfare, and the status of the Emigration Bill."Organizations such as Norka Roots (Kerala), the Department of NRI Affairs (Punjab), the People of Indian Origin Chamber of Commerce and Industry (PIOCCI, Delhi), and the Centre for Dias-



pora Studies (Gujarat) presented their views. They proposed that creating a quota for NRIs in Parliament would help address their issues more effectively. The organizations also emphasized the need to streamline the immigration process for skilled workers and curb illicit activities, including desperate attempts to migrate abroad.Congress MP Deepender

Singh Hooda drew parallels with countries like Italy, which reserves seats in its legislature for overseas citizens, advocating for similar NRI representation in India's Parliament.Earlier, the Ministry of External Affairs informed the committee that a Bill focusing on emigration issues is under consideration by the government. The standing committee, led by Congress MP Shashi Tharoor, noted that state governments have requested to be consulted on the matter. In 2016, BJP MP Poonam Mahajan introduced a private member's Bill seeking to reserve eight seats in the Lok Sabha for NRIs.The discussion highlights the growing attention to the welfare and representation of India's global diaspora.

WB govt moves Calcutta HC for death penalty in R G Kar case

The West Bengal government has moved the Calcutta high court seeking the death penalty to Sanjay Roy, the convict who was awarded life imprisonment by the Sealdah court in the rape and murder of an-duty woman doctor at R.G. Kar Medical College and Hospital on Monday. The state government's step came a day after chief minister Mamata Banerjee declared her government would move the high court seeking capital punishment to Sanjay Roy while expressing shock at the trial court's treatment of the crime as "not rarest of the rare" and its order of life imprisonment in the quantum of punishment for the convict.

On Tuesday, state advocate-general Kishore Dutta asked the division bench of Justices Debangsu Basak and Md Shabbar Rashidi for permission to file a petition against the trial court judgment in the case. The division bench allowed Mr Dutta to file the plea. In his order, first additional district judge Anirban Das of the Sealdah court stated on Monday: "In the realm of modern justice, we must rise above the primitive instinct of 'an eye for an eye' or 'a tooth for a tooth' or 'a life for a life'. Our duty is not to match brutality with brutality, but to elevate humanity through wisdom, compassion and a deeper understanding of justice."

He added: "Referring to the landmark Bachan Singh case, which established guidelines for imposing the death penalty, it is evident that this case does not meet the stringent criteria for being classified as 'rarest of the rare'. The Supreme Court has consistently emphasised that the death penalty should be used only in exceptional circumstances where the collective conscience of the community is so shocked that it expects the holders of judicial power to inflict the death penalty. Given these considerations, it would be inappropriate to accede to the prosecution's request for the death penalty."

TRUMP'S UN AMBASSADOR PICK SAYS ISRAEL HAS **'BIBLICAL RIGHT' TO WEST BANK**

Elise Stefanik, President Donald Trump's nominee for U.S. Ambassador to the United Nations, has expressed strong support for Israel's "biblical" claim over the West Bank, aligning with far-right Israeli leaders Bezalel Smotrich and Itamar Ben Gvir. During her confirmation hearing before the Senate Foreign Relations Committee on Tuesday, Stefanik confirmed her stance when asked about the issue, stating, "Yes," in response to whether she agreed with the belief that Israel has a divine right to the entire West Bank.In her opening statements, Stefanik out-

lined her commitment to implementing Trump's "America First" policy, emphasizing national security leadership on the world stage. If confirmed, she promised to audit U.S. funding to the UN and work to counter China's growing influence at the international body while reaffirming staunch U.S. support for Israel.Stefanik's remarks on the West Bank signal a stark contrast with the Biden administration's approach, particularly regarding Israeli settlements, which are considered illegal under international law. The Biden administration had consistently opposed settlement expansion, though it

also maintained strong support



for Israel at the UN.When pressed by Democratic Senator Chris Van Hollen on her position regarding Palestinian self-determination, Stefanik sidestepped the question but acknowledged that Palestinians "deserve human rights," though she attributed their plight to "terrorist leaders."This marks a continuation of the Trump administraraeli-Palestinian issue, as Trump's first term saw a surge in settlement activity and the removal of U.S. policies recognizing settlement expansion as illegal. Furthermore, Trump's administration had lifted sanctions on Israeli settler groups accused of violence against Palestinians.Stefanik's confirmation hearing also highlighted her vocal stance against anti-Semitism. In 2023, she gained national attention for her questioning of university leaders over alleged anti-Semitism, which led to resignations at major institu-

tions. She has since positioned

herself as a leader in combat-

tion's policy shift on the Is-

ing anti-Semitism in higher education. Throughout the hearing, Stefanik reiterated the U.S. position that Israel is unfairly targeted at the UN, condemning what she described as "anti-Semitic rot" within the organization. She also vowed to ensure that U.S. funds at the UN would serve American interests and pledged to oppose any funding to the UN Relief and Works Agency for Palestine Refugees, an entity that provides essential support to Palestinians. Stefanik's confirmation hearing took place just hours after former Senator Marco Rubio, Trump's pick for Secretary of State, was sworn in, marking the first confirmation

SMART OR STUPID FOR 2025?

"If we are so smart, why are we so stupid?" This striking remark by Israeli historian Yuval Noah Harari has gained the atten-

tion of millions worldwide, sparking diverse reactions and reflections on the state of contemporary human intellect. My brief exploration into this question led me to realise that Harari is not the first great mind to express such a sentiment. Similar notions have been echoed by intellectuals and geniuses across history. For instance, there's a popular saying that, 'scientists should stop analysing animal intelligence and start studying human stupidity.' This perspective is often (though not definitively) attributed to Argentinian Nobel laureate César Milstein. Existential Questions

In the same manner, Albert Einstein once humorously quipped, "Two things are infinite: the universe and human stupidity; and I'm not sure about the universe." Einstein's words remind us to be mindful of our own fallibility when attempting to understand and master the unknowns of the cosmos. Harari's statement reflects this lineage of thought. Like Milstein and Einstein, he underscores the importance of questioning, rethinking and facing our ignorance, even as we invent, discover, and innovate.

A few days ago, I watched an intriguing interview in which journalist Andrew Ross Sorkin spoke with Harari. In this conversation, Harari raised numerous existential questions about the

trajectory of technological advancements — are they for the good or the detriment of humanity? His most emphatic observation was a haunting one: how can humans, capable of showcasing amazing scientific and technological achievements, also exhibit such profound stupidity that they risk self-destruction?

Harari's latest book,

Nexus: A Brief History of Information Networks from the Stone Age to AI, released in September 2024, delves into the hidden dynamics of information networks, which are truthful and deceptive, that form the foundations of artificial intelligence (AI) systems. He warns that these networks can lead to unpredictable and potentially catastrophic consequences, including scenarios like an AI-

Child Sexual Abuse Cases Within Families Raise Serious Concerns

Child sexual abuse within families remains a serious concern despite stringent punishments under the Protection of Children from Sexual Offences (Pocso) Act. According to legal and mental health experts, such crimes often go undetected for long periods, leaving children traumatised for a lifetime. "Half of the Pocso cases involve family members, mainly fathers or uncles," additional public prosecutor Ram Reddy told Deccan Chronicle.

He said that such instances are more against those with underprivileged backgrounds. "While dealing with such cases, a major challenge is the reluctance of mothers (who normally are the complainants) to fully cooperate in the prosecution of the offender, particularly when the perpetrator is the family's breadwinner," Ram Reddy pointed out. "Fear and economic dependence often lead them to seek bail for the accused regardless of the initial complaint," he said.

In one instance, a case was filed against a man for alleged sexual assault of his minor daughter. The girl's mother filed a complaint alleging that he had sexually abused their daughter on several occasions. However, the victim and her sister did not cooperate during the prosecution. Since the prosecution could not establish the victim's age at the time of the offence, the accused was acquitted for want of ev-

Similarly, a case against a man for sexually assaulting his 14-year-old step-daughter also resulted in acquittal. Though the mother initially filed a complaint, she, the victim, and her brother did not cooperate during the trial, leading to his acquittal. A lawyer explained that the fear of threat often silences victims. "There's a high chance of the victim receiving death threats. Even during trial, the victim is scared to open up," the lawyer said.

Meanwhile, Dr. Manchala Hrishikesh Giri Prasad, associate professor, department of child psychiatry, Niloufer Hospital, while speaking about the longterm psychological impact of such sexual abuse, said, "If the victim is a girl, she goes through internalisation disorder where she suffers from anxiety and depression for a longer period of time and will

Etala Rajendar Slaps Realtor Amid Land Dispute in Ekasilanagar

WUT | Jan. 22

In a heated altercation over a land dispute in Ekasilanagar, Pocharam IT Corridor, BJP MP Etala Rajendar was involved in an incident where he allegedly slapped a realtor. The dispute, between local plot owners and real estate agents, revolves around a 149-acre layout purchased by employees of various government departments in 1985. Police have registered a case against Rajendar and six others for wrongful restraint, causing hurt, criminal intimidation, and insult.Rajendar, who was leading the plot owners, explained his actions by saying that he was compelled to act to protect the interests of the common people. "The circumstances made me act in order to

the common man to safeguard their genuine rights," he later told Deccan Chronicle. He criticized the failure of revenue and police officials to intervene, claiming he had to step in to address the lawlessness in the area. "I have never seen such lawlessness in my 25 years of political career," he added. The dispute traces back to the 1980s when 2,076 employees purchased the land, which was initially far from the city and filled with boulders and shrubs. As the land's value rose over time, some local real estate agents allegedly forged documents to claim the property as agricultural land. Court rulings in 2006 and 2011 favored the plot owners.Rajendar alleged that real estate agents, backed by a political party, had been ob-

structing plot owners' access to their land and demanding money for them to vacate the area. The agents even hired goons and used aggressive tactics, including threats and abuse, towards the landowners,

especially women. Rajendar, as

Novak Djokovic battles past Carlos Alcaraz, advances to Australian Open semifinals



Novak Djokovic refused to let anything stop his pursuit of a record 25th Grand Slam trophy in the Australian Open quarterfinals. Not a problem with his left leg. Not an early deficit. And not the kid across the net, Carlos Alcaraz, who was making things difficult and eyeing his own bit of history.

Djokovic overcame it all, just as he has so often along the way to so many triumphs, moving into the semifinals at Melbourne Park for the 12th time with a 4-6, 6-4, 6-3, 6-4 victory over Alcaraz in a scintillating showdown Tuesday night between a pair of stars born 16 years apart and at opposite ends of their careers. The action was non-stop, the shot-making brilliant, even as the match stretched on for more than 3 1/2 hours and nearly to 1 am — never more so, perhaps, than when Alcaraz saved a break point that would have put Djokovic ahead 5-2 in the fourth set, allowing him to serve for the win.

The 33-stroke exchange was the longest of the evening, and when it ended with Djokovic sailing a forehand long, the capacity crowd at Rod Laver Arena went wild. Djokovic reached for his bothersome leg and yelled toward his entourage; Alcaraz, his chest heaving, leaned on a towel box and grinned.

Turned out that only delayed the final result. With his wife, son and daughter cheering in the stands, the No. 7-seeded Djokovic prevailed thanks to the sort of remarkable returning and no-mistakes-made ground-strokes against Alcaraz that now-retired rivals Roger Federer and Rafael Nadal dealt with for years. Djokovic enjoyed some of his own best efforts in the

Djokovic enjoyed some of his own best efforts in the latter stages, pointing to his ear, blowing kisses and spreading his arms while puffing out his chest. There was the forehand winner on a 22-stroke point that earned the break for a 5-3 lead in the third set.

It hurts to think that I have not done well, Suryakumar Yadav admits ODI struggles



Explosive batter and T20 skipper Suryakumar Yadav on Tuesday said he has accepted his exclusion from the Champions Trophy squad but what hurts him more is that he could not perform well in the ODI format and the ones chosen for the ICC event deserve to be on the team.

The selectors ignored Suryakumar for the 15-member CT squad but he remains in-charge of the side that will take on Jos Buttler's England in the five-match T20I series beginning here Wednesday.

With his repertoire of strokes, Suryakumar is one of the most devastating T20 cricketers but that form has not translated into runs in 50-over cricket with the middle-order batter scoring 773 runs in 37 ODIs at an average of 25.76.

Asked whether was hurt by his non-inclusion, SKY, as he is fondly addressed, said, "Why would it hurt? If I do well, I would have been in the Champions Trophy. If I don't do well, it's important to accept that." "And at the same time, if you see the (CT) squad, it's looking really good. Whoever is there, they are all good performers. They have done relatively well in that format for India and also playing domestic cricket and I am very happy for them.

"It hurts to think that I have not done well. And if I had done well, I would have stayed there. If I haven't done well, someone who deserves to have done really well, deserves to be there." He said Jasprit Bumrah and comeback-man Mohammed Shami are a "lethal combination" for any rival if they are fit for the Champions Trophy.

Bumrah has not bowled since the Sydney Test and is not available for at least the T20Is due to back spasms. "They have played a lot of cricket together. They are experienced bowlers. And whenever you play for India, it's a different feeling, different emotion. Added responsibility and you love playing.

"So, it will be fun to see them bowling together again. Like we saw in the 2023 ODI World Cup. They bowled really well. And hopefully, we will see the same bowling in the Champions Trophy."

TG govt, MEIL sign MoU for three projects



he state government on Tuesday signed memoranda of understanding (MoU) with Megha Engineering and Infrastructure Limited (MEIL) to establish three major projects, with a total investment of Rs.13,000 crore, during the World Economic Forum in Davos. MEIL, the Hyderabad-based infrastructure company, will set up a 2,160 MW pumped storage project with a proposed investment of RS.11,000 crore.
