## Indian students fear as **Canada tighten rules**

anada has introduced stricter immigration rules allowing officers to cancel temporary resident documents, including work and study permits, under certain conditions. The changes have sparked anxiety among Indian immigrants, particularly students and workers.

According to Immigration, Refugees and Citizenship Canada (IRCC), officers can now revoke electronic travel authorisations () and temporary resident visas (TRVs) if an individual becomes "inadmissible," provides false information, has a criminal record or is deemed unlikely to leave Canada after their authorised stay.


The regulations also extend to permanent residents, allowing authorities to cancel residency if a document was issued in error or the individual has passed away. The stricter rules have unsettled many Indian students in Canada, many of whom fear the impact of these stricter regulations. Mohd. Fazal, a 24-year-old student from Hyderabad studying in Vancouver, said, "My family invested so much to send me here. It's scary to think they can cancel our residency and send us back."



## **AP Already Used More** Than Its Share, **Telangana Tells KRMB**

#### **New delhi** WUT | Feb. 22

Telangana has demanded that the Krishna River Management Board (KRMB) immediately stop Andhra Pradesh from drawing any more Krishna river water from the Nagarjunasagar and Srisailam reservoirs. In a letter to KRMB chairman Atul Jain on Friday, Telangana's irrigation principal secretary Rahul Bojja said: "As on today, AP has already utilised (Krishna water) far in excess of its entitlement as per KRMB records and therefore the state (AP) cannot draw any waters from the common reservoirs.

The letter followed a meeting Bojja, Telangana irrigation department engineer-in-chief (general) G. Anil Kumar, and chief engi-



**IITH launches** data offload research unit



Technology Hyderabad (IITH) launched the world's first data acceleration and offload research facility to tackle data transfer delays — a major inefficiency in artificial intelligence (AI) and machine learning (ML) processing. AI and ML systems require vast amounts of data, but a significant portion of processing time is lost as these systems wait for data to move across networks. Research suggests that up to one-third of AI processing time is wasted due to these delays. The new facility at IITH aims to address this by improving the speed, security, and efficiency of data movement, a critical factor in AI-driven applications.

The centre, set up in collaboration with Marvell Technology, will provide researchers, students, and industry professionals with access to advanced semiconductor technologies, including data processor units (DPUs), network interface controllers (NICs), compute express link (CXL) processors, and high-performance switches. These technologies manage how data moves between servers, processors, and storage devices, playing a crucial role in AI, cloud computing, and cybersecurity, the university said


# **Telangana Urges KRMB to Halt Andhra** Pradesh's Krishna Water Drawal

Telangana has demanded that the Krishna River Management Board (KRMB) immediately stop Andhra Pradesh from drawing additional Krishna river water from the Nagarjunasagar and Srisailam reservoirs. In a letter to KRMB chairman Atul Jain on Friday, Telangana's irrigation principal secretary Rahul Bojja stated that Andhra Pradesh had already ex-

as per KRMB records and should not be allowed to withdraw more water from the common reservoirs. The letter followed a meeting between Bojja, Telangana irrigation department engineer-in-chief (general) G. Anil Kumar, and the chief engineer of the Nagarjunasagar project with the KRMB chairman on Friday. Although the board had called for an urgent meeting with both states on the same day, Andhra Pradesh

ceeded its entitlement



informed KRMB that it could not attend and requested a postponement. The formal meeting was rescheduled to Monday. Telangana also sub-

mitted its indent for Krishna water usage until July, stating that it would require 90 TMC ft for irrigation until the end of May and an additional 17

TMC ft for drinking water needs until May 31. Furthermore, the state estimated a need for another 9 TMC ft for drinking water purposes from June 1 to

July 31, bringing the total request to 116 TMC ft.

Earlier this week, KRMB stated that Telangana had the option of utilizing 131 TMC ft of Krishna water, while Andhra Pradesh was allocated 27 TMC ft. However, the combined water availability in the Srisailam and Nagarjunasagar reservoirs is currently around 90 TMC ft before reaching the minimum drawdown level (MDDL). With mounting pressure from Telangana farmers for

water releases to save standing crops, the state also accused Andhra Pradesh of drawing 10,000 cusecs of water from the Nagarjunasagar right canal.

As water levels continue to drop in the reservoirs, the issue has sparked a political controversy. The ruling Congress party, along with the opposition BRS and BJP, have engaged in a heated debate, accusing each other of failing to safeguard Telangana's water interests.

Despite promises to benefit 17 lakh Dalit families, only 1.73 lakh were selected, and only ₹9,894 crore was sanctioned out of the required ₹83,850 crore.Education and employment funds were underutilized. Out of ₹15,233 crore allocated for SC students in 2023-24, only ₹10,396 crore was spent, leaving thousands without scholarships.

# Bhatti Urges Quick Use of Rs 3k Cr for SC, STs

### Deputy CM Bhatti Vikramarka Directs Officials to Expedite Pending Schemes, Clear Arrears, and Develop Forest Land for Irrigation

#### **Hyderabad** WUT | Feb. 22

In a significant move aimed at improving the welfare of marginalized communities, Telangana Deputy Chief Minister Mallu Bhatti Vikramarka has instructed officials to ensure the completion of pending selfemployment schemes and developmental projects worth ₹3,000 crore for Scheduled Castes (SCs) and Scheduled Tribes (STs) within the next two months. During a pre-budget review meeting with officials

from the Backward Classes (BC), SC, ST, and minority welfare departments, Bhatti underscored the state government's commitment to the upliftment of these communities. He pointed out that under the previous Bharat Rashtra Samithi (BRS) government, youths from the SC, ST, and BC communities faced severe hardships due to delays and lack of proper implementation of welfare schemes. The current administration, he assured, is dedicated to rectifying these issues and ensuring the smooth execution of welfare programs without unnecessary

delays. Bhatti emphasized the need for officials to clear pending arrears related to rent and diet charges of social welfare hostels across the state. He sought comprehensive details on the outstanding dues for social welfare hostels, residential schools, and gurukuls, instructing officials to submit bills to the finance department regularly. This, he said, would prevent further backlogs and ensure that the institutions responsible

for the education and wellbeing of SC and ST students function efficiently. To ensure the effective implementation of welfare measures, Bhatti directed ministers, MLAs, and senior officials to conduct routine inspections of social welfare hostels and gurukuls. Regular visits, he stressed, would help identify gaps in infrastructure, food quality, and other essential facilities while ensuring that necessary improvements are made without delay. Bhatti also urged officials

of the SC and ST departments to focus on securing funds under the sub-plan act, which mandates specific budget allocations for the development of these communities. TRUMP CALLS 'VOTER TURNOUT' GRANT KICKBACK, INDIA SAYS PROBE IS ON



## EDITORIAL TOXICITY OF BODY STANDARDS

From fairness cream commercials to Bollywood's obsession with slim figures, we've grown up in a world that defines 'perfect' in narrow, often unattainable ways. This fixation isn't new; ancient texts often glorified physical beauty as a sign of virtue, and colonial influences equated fairness with power and privilege (Vijaya & Bhullar, 2022). In modern times, the media continues to amplify these rigid ideals and shape a society where appearance often overshadows individuality and self-worth. These standards aren't just unrealistic; they're damaging (Gelles, 2011). A recent Netflix documentary on Yo Yo Honey Singh, a name that transformed India's music

scene, sheds light on just how brutal these expectations can be.

Honey Singh's story is one that millions can relate to, even if they aren't celebrities. At the peak of his career, he was loved by fans. But when he took a break due to mental health issues and gained weight from medication, everything

changed. His fans began trolling him mercilessly. Social media was flooded with derogatory comments, mocking memes, and hashtags that questioned his relevance and talent. Instead of empathy, he was met with criticism and hate comments.

This painful chapter of his life reveals the toxic relationship we have with body image. In this article, we will explore body image issues in India through the lens of Honey Singh's journey as depicted in the Netflix documentary.The documentary shows how Honey Singh struggled with bipolar disorder and alcoholism. "When I looked in the mirror, I didn't see myself anymore," he said in the film. He wasn't just battling his mind; he was also fighting the world's expectations. But perhaps the saddest part was his reaction. In-

part was his reaction. Instead of focusing on healing for himself, he decided to lose weight to please the public and look 'acceptable' again. While getting healthy is always good, the reason behind his decision makes it complicated. It is a multilayered complexity where the action of losing weight was positive, but the intention behind it was rooted in external pressure rather than self-motivation (Puhl & Suh, 2015).

A two-judge panel of the Telangana High Court refused to entertain a writ appeal by employees of security printing press in Hyderabad on payment of overtime allowance. The panel, comprising acting Chief Justice Sujoy Paul and Justice Renuka Yara, heard a writ appeal filed by retired employees. The appellants filed a writ petition challenging an award passed by the central government industrial tribunal, Hyderabad. The writ petitioners also sought a consequential prayer against Security Printing and Minting Corporation of India Limited to compute and release the arrears of amounts payable towards overtime under the Factories Act. It is the case of the petitioner that in spite of their overtime work, payment of allowances and in its lieu, special allowance was denied to the petitioners. It is the further case of the petitioners that the government had highhandedly and contrary to the express provisions of the Factories Act, issued a memorandum stating that the petitioners, on reaching a particular stage in the pay scale attached to the post held by the petitioners, would cease to get the benefit of Section 59 of the Factories Act. The Union government referred the dispute to the tribunal, when the petitioners sought invocation of the provisions of Section 10 of the Industrial Disputes Act for adjudication of the dispute on merit. However, the tribunal held that the petitioners may not be called as workmen as defined under Section 2 (s) as there is no industrial dispute as defined under Sec. 2(k) of the Industrial Disputes Act, 1947, because the instant case related to the claim for overtime allowance does not come under category of industrial dispute mainly related to even any difference between the employer and the employees over the point of their employment. A single judge junked the challenge to the said order. The single judge, while dismissing the present claim, also pointed out that the 1998 award of the industrial tribunal-II, Hyderabad, has attained finality and few petitioners challenged the same by way of writ petition, which upheld the award. It held that the petitioners are not workmen as defined under the Industrial Disputes Act and Factories Act and then in their writ appeal the appellant sought to withdraw the same with a liberty to approach the appropriate authority under the Factories Act. It was contended by the respondent authorities that petitioners have no locus-standi to agitate the very same issue which has attained finality. While dismissing the claim, the panel speaking through acting Chief Justice Sujoy Paul pointed out that the issue raised in the present ap-

peal stood decided in an earlier round of litigation.

#### New Delhi WUT | Feb. 22

The Supreme Court on Friday said the National Medical Commission (NMC) guidelines requiring students with specified disabilities to have "both hands intact" to pursue MBBS course was "completely antithetical" and reeked of "ableism". A bench of Justices B R Gavai and K V Viswanathan observed the guidelines prescribed "both hands intact, with intact sensations, sufficient strength and range of motion" to be essential for eligibility in the medical course.

"This prescription of 'both hands intact...' is completely antithetical to Article 41 of the Constitution; the principles enshrined in the United

the Rights of Persons with Disabilities and the salutary provisions of the RPwD Act (Rights of Persons with Disabilities Act, 2016)," said the bench.

The court went on to add, "It also indicates a classification which is overbroad and glorifies 'ableism'. It propagates that persons with typical abilities and with faculties similar to what the majority may have or somehow superior." This was precisely what the Directive Principles of State Policy, the United Nations Convention and the 2016 Act abhor, it added. The top court referred to its verdict passed in October last year which asked the NMC to issue revised

lines in supersession of the guidelines of May 13, 2019 with regard to admission of students with specified disabilities under the Act with respect to MBBS course. It said pursuant to the verdict, the NMC assured the top court in another matter that it would constitute a new committee of domain experts to

comply with the judge-

ment. "We direct this matter to be posted on March 3, 2025 to consider whether the National Medical Commission has formulated the revised guidelines in accordance with the judgments of this court...," it said. The bench in the meantime directed the NMC to file an affidavit explaining the current status. The top court delivered its verdict on an appeal against a September 2024 order of the Punjab and Haryana High Court, which rejected the claim of a disabled aspirant and upheld the denial of his admission to MBBS

course.

The top court said it had on December 12, 2024 ordered the appellant's admission in the Government Medical College, Sirohi, Rajasthan against a seat reserved for Persons with Disabilities (PwD) (OBC) category. The bench gave its reasoning in the judgement delivered on Friday. It referred to the guidelines over the admission of students with "specified disabilities" under the 2016 Act in MBBS course which constituted appendix H-1 to the Graduate Medical Educa-

tion Regulations (Amendment), 2019, notified on May 13, 2019. The bench noted while the appellant's disability of 58 per cent rendered him eligible for the course under the PwD quota, the requirement to have the requirement of having "both hands intact, with intact sensations, sufficient strength and range of motion" made him ineligible. "The 'both hands intact...' prescription has no sanctity in law as it does not admit of a functional assessment of the individual candidate, a matter which is so fundamental in protecting the rights of persons with disabilities," it held. Such a prescription, said the bench, reeked of ableism and had no place in a statutory regulation."In

fact, it has the effect of denuding the rights guaranteed under the Constitution and the RPwD Act and makes a mockery of the principle of reasonable accommodation," it said.

The bench observed at the time of hearing the matter in November last year, the top court asked the Director of the All India Institute of Medical Sciences, New Delhi, to constitute a committee to examine whether the disability suffered by the petitioner would come in the way of his pursuing medical studies. The bench said of the six members of the committee, five said they were unable to declare the appellant fit to join the MBBS course and the current NMC guidelines needed revision.

## Bar associations accuse bar council of interference in election process

#### Hyderabad WUT | Feb. 22

A legal dispute has erupted between multiple advocates' bar associations across Telangana and the Bar Council of Telangana over the latter's alleged interference in their election processes. In a move led by the Bar Association of Rangareddy District

Court, approximately 25 bar associations have col-

lectively approached the Telangana High Court, challenging the regulatory measures imposed by the Bar Council.

The primary point of contention is the directive issued by the Bar Council of Telangana, which mandates the implementation of uniform model bylaws for all 110 bar associations operating within the state. Many of these associations have long funcl- tioned under their own set

of bylaws and are independently registered under the Societies Registration Act. The imposition of these standardized bylaws has sparked opposition, with associations arguing that it disregards their autonomy and established governance structures. Adding to the discontent, the Bar Council of Telangana has also rejected a proposal put forth by the

executive bodies of var-

-🛞

ious bar associations, which had sought an extension of the tenure of their executive committees from one year to two years. The associations argue that an extended term would ensure better administrative continuity and facilitate smoother governance. However, the Bar Council remained firm in its decision, dismissing the request and instead issuing a memo instructing all bar associations to conclude their election processes by March 31.

Challenging what they perceive as excessive control by the Bar Council, the affected bar associations have petitioned the Telangana High Court, seeking relief from the imposed regulations. The case was taken up on Friday by Justice B. Vijaysen Reddy, who heard the arguments presented and subsequently ad-

journed the matter to February 25. The court has directed the Bar Council of Telangana to file its counter-submissions by then, after which further deliberations will take place.

The outcome of this case is being closely watched by legal professionals across Telangana, as it could set a precedent for the functioning and autonomy of advocates' bar associations in the state.

## India interested in hosting 2030 Commonwealth **Games: Source**




ndia is "interested" in hosting the 2030 Commonwealth Games and also conduct all those disciplines that were axed from the 2026 edition to ensure that the country's medal tally is not affected when the event is held in Glasgow, a source in the sports ministry revealed on Friday. The last date to submit an 'Expression of Interest' to host the 2030 CWG is March 31 and the ministry source said the process will get underway soon.

"We are interested in hosting the 2030 Commonwealth Games and a formal interaction has taken place with the Commonwealth Games Federation on this. We have also proposed that all the disciplines that have been removed from the 2026 CWG be held in India." the source said. India last hosted the CWG in 2010. The ministry's push to have the axed events of the 2026 edition in India is a way to ensure that the CWG remains a high medal-yielding competition for the country.

Last year, in a huge blow to India's medal prospects, key sports such as hockey, badminton, wrestling, cricket and shooting were dropped from the programme by host city Glasgow, which announced a pruned roster of 10 disciplines to keep the event budget-friendly. "We are merely looking to ensure that our medal tally does not suffer. An informal proposal (to have axed disciplines in India) has been put across, we will see how the host city responds to it," the source said.

India had given a similar proposal for the archery and shooting competitions of the 2022 CWG in Birmingham and the CGF, along with the host city, had even approved it by agreeing to add the medals won to the finally tally. However, the idea could not be executed due to the COVID-19 pandemic.

After hitting Venkatesh Prasad for a boundary, Sohail pointed towards the direction of the shot in an act of provocation. However, Prasad had the perfect reply, clean-bowling Sohail on the very next delivery, sending the Bengaluru crowd into a frenzy and swinging the momentum in India's favor.

3. Inzamam's Altercation with a Fan (1997, Toronto) A rare off-field controversy saw Pakistan's Inzamamul-Haq lose his cool against an Indian fan in Toronto. Standing at the boundary, Inzamam was continuously heckled with chants of "Aloo" (potato) mocking his physique. Frustrated, he grabbed a bat and stormed into the stands to confront the heckler before security intervened. The incident led to disciplinary action, with Inzamam later admitting that the taunts were deeply personal.

4. Gambhir-Afridi Verbal Clash (2007, Kanpur) During a heated encounter in 2007, India's Gautam Gambhir and Pakistan's Shahid Afridi were involved in an ugly exchange. Gambhir hit Afridi for a boundary, leading to verbal abuse between the two. The altercation escalated when the batter and bowler collided mid-run, intensifying the tension. The onfield umpire had to step in to separate them. Even post-retirement, both cricketers have continued their rivalry through social media spats.

5. Akhtar vs. Harbhajan Face-Off (2010 Asia Cup, Dambulla)

Pakistan's Shoaib Akhtar was never one to shy away from a contest, and his duel with India's Harbhajan Singh in the 2010 Asia Cup was no exception. After bowling a dot ball to Harbhajan, Akhtar taunted the Indian tailender. In response, Harbhajan smashed a six off Mohammad Amir in the final over to seal an Indian victory, celebrating aggressively in front of Akhtar. The two later re-enacted the moment.

## Six-Year-Old Boy **Rescued After Being** Trapped in Lift

A six-year-old boy, identified as Arnav, was rescued after being trapped between a lift and the wall of an apartment complex in Shantinagar, Hyderabad, on Friday. The incident, which occurred around 1:30 PM, created panic among residents, who immediately alerted the authorities.

The Hyderabad Fire Department and Disaster Response Force (DRF) teams, along with doctors, rushed to the scene. A Hyderabad police official stated, "The boy was trapped between the lift and the wall, between the ground and first floors." Using welding machines, the rescue teams forced open the lift doors, successfully freeing the child after nearly three hours.

Arnav sustained minor injuries and was immediately shifted to Niloufer Hospital. However, doctors suspect internal bleeding due to abdominal compression between the lift and the wall. He is currently undergoing surgery.

This incident follows a similar occurrence in Hyderabad, where three students were trapped inside a lift at Uppal Skywalk for nearly 45 minutes before being rescued by the police.


