

Prime Minister Narendra Modi, on Monday (April 14, 2025), launched a scathing attack on the Congress party, accusing it of misusing the Constitution to retain power and implementing reservations based on religion in Karnataka. He condemned the party's "appeasement politics," stating that it has harmed the Muslim community and betrayed the vision of Dr. B.R. Ambedkar. Modi alleged that Congress has consistently disregarded the spirit of the Constitution and the rights of SCs, STs, and OBCs. He criticized the party for amending the Waqf law in 2013 for political gains and challenged them to appoint a Muslim as their party president to prove their commitment to the community.

## **Telangana Becomes First State** to Implement SC Categorisation

Telangana made history on Monday by issuing a government order (GO) to implement the categorisation of Scheduled Castes (SC), becoming the first state in India to do so officially. This move follows the recommendations of the Justice Shameem Akther Commission, which suggested dividing 59 SC communities into three groups for reservations in government jobs and education. The GO, which coincides with the birth anniversary of BR Ambedkar, was published in the Telangana Gazette on April 14, 2025, after receiving the Governor's assent on April 8, 2025. The categorisation is as follows: Group I: 15 socially, economically, and educationally disadvantaged SC



# Bhu Bharati portal to provide permanent solution to land issues: CM Revanth Reddy

Emphasising the urgency to resolve landrelated issues in the State, Chief Minister A. Revanth Reddy sought the cooperation of the Revenue department in the flawless implementation of the Telangana Bhu Bharati (Record of Rights in Land) Act 2025. He also urged the revenue officials, under the guidance of District Collectors, to strive to get rid of the disrepute they earned during the previous Bharat Rashtra Samithi (BRS) regime due to the thenrulers' attempts to portray them as 'thieves and looters'. Addressing Revenue officials after launching the Bhu Bharati portal and notifying the rules for the Bhu Bharati Act at Shilpakalavedika here on the occasion of Ambedkar Jayanti on Monday (April 14), Mr. Reddy said: "All struggles in the Telangana region are linked to land. many innocent people faced a lot of hardships due to shortcomings in the Dharani Act and portal, accusing the previous BRS government of enacting it to realise their vested interests. "It helped them usurp thousands of



acres of land," he alleged. The Chief Minister also criticised the BRS government for not notifying the rules for the Dharani Act for several years, prompting the public to face difficulties and resort to attacks against revenue officials.

"Instead of notifying the rules, the previous government tried to blame the Revenue department for their faults in the system," Mr. Reddy said. "Unfortunately, it led to a situation where even a Tahsildar was set on fire. The previous rulers planned to portray Revenue officials as thieves and looters." He emphasised his stance against portraying Revenue officials in a bad light.

"To benefit the poor, we introduced the new ROR Act and launched the portal to provide a permanent solution to land issues," Reddy explained. "We're implementing this as a pilot project in four mandals, aiming to bring in dispute-free land policies." He urged revenue officials to raise awareness about the Act through programmes (Revenue Sadassulu) in each village.

The Chief Minister announced plans to introduce the Bhudaar system, similar to Aadhaar, to check land issues completely. He ordered District Collectors to embark on an intensified awareness programmes at the field-level on the newly launched Bhu Bharati portal, which serves as a one-stop permanent solution for all land ownership issues of farmers. Earlier, Deputy Chief Minister Mallu Bhatti

Vikramarka also flayed the previous government for 'playing havoc' with innocent people's lives due to issues in the Dharani portal. He announced the revival of assignment committees to help Dalits, tribals, and marginalised communities get lands allotted by the government. Revenue Minister Ponguleti Srinivas Reddy attributed the BRS's loss of power to the Dharani Act, which enabled one family to amass lands.

## Telangana first to implement SC Categorisation after Supreme Court verdict, says Uttam Kumar Reddy

Irrigation and Civil Supplies Minister Capt N Uttam Kumar Reddy on Monday announced that Telangana had created history by becoming the first state in the country to legally implement Scheduled Caste (SC) categorisation after the Supreme Court's verdict on August 1, 2024.

Speaking on Ambedkar Jayanthi at the Dr B.R. Ambedkar Telangana Secretariat, Uttam Kumar Reddy, along with ministers Damodar Raja Narasimha and Ponnam Prabhakar and MP Balram Naik, said that the Congress Government had transformed a long-pending demand into law through a transparent and legally sound process. "We have officially released the Government Order today and handed over the first copy to Chief Minister A Revanth Reddy. The categorisa-

Chief Minister Revanth Reddy, Deputy Chief Minister Bhatti Vikramarka Mallu, and other senior ministers were unanimous in their view that the court verdict must be translated into immediate action. A Cabinet Sub-Committee was promptly constituted to give shape to Rahul Gandhi's vision of social justice and en-

sure that the most marginalised among SC communities received their due share.

He credited the visionary leadership of Rahul Gandhi for making this Act possible. "Rahul Gandhi's firm stand on social justice and his consistent support for marginalised communities laid the ideological foundation for this bold step. His commitment to equitable development empowered the Congress Government in Telangana to carry this Act forward with moral clarity and political conviction," he said. The Act, unanimously passed by the Telangana Legislative Assembly on March 18 and approved by the Governor, reorganised the existing 15% SC reservation into three distinct groups based on the socio-economic status of SC sub-castes: Group I, the most disadvantaged 15 sub-castes (3.288% of SC population), received 1% reservation. ## Indians' Wait for US Green Cards Gets Longer

### New delhi WUT | Apr . 15

Indian applicants under the EB-5 visa programme are set to face further delays as the United States government has once again retrogressed the visa cut-off date, citing a surge in applications. This move is expected to push back green card approvals by at least six months, prolonging the wait for many applicants who were nearing the final stages of the process.

As per the latest visa bulletin released by the U.S. Department of State (DoS), the EB-5 visa cutoff date has been retrogressed from November 1, 2019, to May 1, 2019, effectively delaying green card issuance for Indian investors by another six months. This follows a previous retrogression in April, where the cut-off date was moved back by more than two yearsfrom January 1, 2019 to November 1, 2019. Retrogression is a common occurrence when the number of applicants in a specific visa category ex-

## BJP, RSS Enemies of Ambedkar: Congress

ings. Choksi, 65, was traced to Belgium in November 2023, where he had reportedly arrived for medical treatment. He had been residing in Antigua and Barbuda since 2018, after fleeing India just before the scam was exposed.

Despite taking citizenship in the Caribbean nation, Indian authorities maintain that his Indian citizenship remains valid.Sources said that at least two openended arrest warrants-issued in 2018 and 2021 by a Mumbai special courthave been submitted to Belgian authorities as part of India's extradition plea. Belgian officials confirmed that Choksi is currently in detention, with access to legal counsel, pending further judicial proceedings.His



lawyer, Vijay Agarwal, confirmed the arrest and said that while Belgium does not allow for direct bail applications, an appeal will be filed seeking his release from detention during the extradition hearing.

The legal defense is expected to argue that Choksi is not a flight risk, is undergoing cancer treatment, and that the extradition request is politically motivated. They are also likely to raise concerns about prison

conditions in India. The Interpol red notice against Choksi was reportedly deleted earlier following his legal representation to the global police body. Since then, Indian agencies have been pursuing the extradition route.Choksi, along with his nephew Nirav Modi—also a prime accused in the PNB fraud case—allegedly orchestrated one of the biggest banking scams in India's history.

The duo, along with several family members, employees, and PNB officials, were booked by the CBI and ED in 2018.According to investigators, Choksi's firm Gitanjali Gems fraudulently obtained 165 Letters of Undertaking (LoUs) and 58 Foreign Letters of Credit (FLCs) from PNB's Brady House branch in Mumbai between March and April 2017.

These documents were issued without sanctioned limits or cash margins and were kept off the bank's central records, thereby avoiding scrutiny. Based on these LoUs, multiple foreign banks-including SBI (Mauritius and Frankfurt), Allahabad Bank (Hong Kong), Axis Bank (Hong Kong), Canara Bank (Manama), and Bank of India (Antwerp)disbursed loans to

crore when Choksi's companies defaulted. The ED has so far attached or seized assets worth ₹2,565.90 crore linked to Choksi and has been permitted by courts to initiate monetization of these properties.Nirav Modi, declared a fugitive economic offender, remains jailed in London since his arrest in 2019. He continues to contest his extradition to India.Meanwhile, Indian agencies remain hopeful that the long-standing extradition treaty between India and Belgium will facilitate Choksi's return. The arrest marks a major development in India's efforts to bring fugitive economic offenders to justice.

## IAF Aircraft Faced GPS Spoofing During Relief Mission to Earthquake-Hit Myanmar

New delhi WUT | Apr . 15

Indian Air Force (IAF) transport aircraft carrying relief materials to earthquake-affected Myanmar last month encountered GPS spoofing attacks, raising serious security concerns. According to military sources, the incidents were reported during 'Operation Brahma', under which India extended humanitarian aid to the neighbouring country. The first instance was reported on March 29 when a C-130J Super Hercules aircraft, flying over Myanmar's airspace, ex-

perienced GPS signal tampering. The pilots swiftly switched to the backup inertial navigation system to maintain safe flight operations, sources told PTI.In total, India deployed six military aircraft-including C-130Js and C-17 Globemaster heavy-lift planes-to Myanmar, transporting relief materials, field hospitals, and rescue teams. A majority of these aircraft reportedly experienced GPS spoofing during the mission.GPS spoofing is a form of cyberattack that involves broadcasting fake GPS signals, misleading navigation

systems and posing significant risks to aircraft. Experts explain that spoofing can displace the aircraft's perceived position by dozens to hundreds of miles."Most likely, the GPS spoofing was carried out by an adversary in the region," a source stated, though no specific nation was named. Five aircraft landed in Yangon and Nay Pyi Taw on March 29 and 30, while a sixth aircraft flew to Mandalay on April 1. After the first incident, subsequent pilots were alerted about the GPS spoofing risk

It also gives the US President - the commander-and-chief of the US armed forces - complete powers to decide if, when, and where to deploy US troops within the United States of America. The Insurrection Act however, is somewhat different from a martial law. While a martial law gives complete control of administration and running of the states affairs to a military general usually the chief of defence staff or the army chief - the Insurrection Act keeps the powers of the state and administration with the US President, who selective uses military powers to enforce law and order.

## "Confident SC Won't...": Union Minister On Challenge To Waqf Act

#### New delhi WUT | Apr . 15

Minority Affairs minister Kiren Rijiju, refering to the legal challenge to the amended Waqf law, told NDTV today that he is "confident" that the Supreme Court would not "venture into legislative matter". He also said Bengal Chief Minister Mamata Banerjee's declaration that the amended law will not be implemented in the state raises questions on whether she has any moral authority or the Constitutional right to occupy that position.

The minister's comment comes amid an escalating row over the law, which has been challenged in the Supreme Court by multiple individuals and organisations, and the staunch assertion of Ms Banerjee in Bengal. The Supreme Court will hear the petitions on Wednesday. "I am confident that the Supreme Court will not venture into a legislative matter," the minister told NDTV. "We have to respect each other. If tomorrow the government interferes into judiciary, it won't be nice. The separation of powers is well defined," he said. "I have not seen any other bill being scrutinised so

bill," he added. Earlier, the Supreme Court had made it clear that it would not trespass into the domain of the legislature. But as the final arbiter on issues involving constitution, it has agreed to hear out the petitioners, who claim the amended law tramples on several fundamental rights, including the right to equality and the right to religious freedom. In Bengal meanwhile, Mamata Banerjee -- who refused to implement the Citizenship Amendment Act, National Register of Citizens and Uniform Civil Code last year -- has

now announced that the amended Waqf law will also join that category. Asked about her stance, Mr Rijiju said it could indicate that Ms Banerjee does not believe in the Constitution of India. "What kind of bizarre statement is that?" Mr Rijiju told NDTV. "Does Mamata or anybody not care for the people? They treat Muslims as mere vote bank. It will be a black day, the moment they defy ... Anybody who says they will not obey the act passed by the Parliament of India does he or she have any moral authority and Constitutional right to occupy that position and hold the Constitution book? Do they respect Ambedkar?

What kind of message do they want to send? Very unfortunate," he added. While the implementation of the law rests in the hands of the state governments, the BJP has said the states have no power to bypass the Central laws.

"We want to make it clear that after the 73rd and the 74th amendments in the Constitution, powers of the Centre, state and district-level governments are clearly defined. No district panchayat can go beyond the law passed by the state assembly and no state can bypass the law passed by the Centre (Parliament)," said BJP spokesperson and Rajya Sabha MP Sudhanshu Trivedi.

## MANIPUR CONFLICT IS A SETBACK FOR ACT EAST POLICY

EDITORIAL

India initiated the Look East Policy in the 1990s to explore economic prospects outside of South Asia in response to the financial problems posed by the dissolution of the Soviet Union and the Gulf crisis of 1990-1991. This policy was in line with liberalisation, globalisation and privatisation (LPG) activities. By adopting the Act East Policy in 2014, the NDA government improved India's standing and level of international participation. However, there has been a great deal of violence in the ongoing Manipur conflict, which began in early May 2023, between the Kuki and Metei communities. The continuous battle reached a new level with the use of highly sophisticated weapons like drones and rocket-propelled grenades (RPGs) to bomb civilian residences. After over a year and a half of fighting, more

than 226 people have died, and 60,000 have been rendered homeless. Significant decisions were made in the State and the Centre during this battle. For example, the 16 km Free Movement Regime (FMR) was removed, and the 1,643 km Indo-Myanmar border was fenced.

Progress has been hampered by these contentious choices and the continuous unrest in the region, which harms ASEAN and Myanmar's relations with India. Hence, this impedes the smooth execution of diverse socio-economic initiatives associated with various Act East Policy initiatives. Free Movement Regime, Fencing

## Ganja worth ₹53.28 lakh seized by Kuravi police

Warangal WUT | Apr . 15

Kuravi police on Monday arrested four persons involved in illegal transportation of ganja and seized 106.96 kg of the contraband worth ₹53.28 lakh. The seizure took place during a routine vehicle inspection near the SRSP Canal in Kuravi mandal. Disclosing the details, DSP N. Tirupathi Rao said the operation was carried out following instructions from Dis-



Madkami (31), and Ramachandra Madi (29) — and one local. Banoth Mahender (36), from Thandadharmaram village in Maripeda mandal, currently residing in Hyderabad's LB Nagar. The accused were found transporting the ganja in three large sacks, allegedly procured from Chitrakonda in Odisha and routed through Visakhapatnam and Khammam with the intent to sell it in Hyderabad.

Police also recovered five mobile phones from their possession. All four have been taken into custody. SP Sudheer Ramnath Kekan, while appreciating the efforts of the police team, warned of strict action against drug traffickers. He voiced concern over the rising instances of youth falling prey to drug addiction in the district, which has severe social and health repercussions.

(HCA) for insisting on Aadhaar OTP verification from a minor cricket player as a condition for registration to the BCCI's Under-16 tournaments. The judge declared such a demand was unjustified, illegal and violative of the minor's right to privacy and directed the HCA to immediately register the player and allow him to participate in official tournaments. The writ plea, filed by Master Shiva Ramakrishna Terli, a 15-year-old cricketer who previously captained the Hyderabad U-14 team, contended that he was unfairly barred from playing due to HCA's insistence on Aadhaar OTP sharing, despite already having provided multiple valid identity and residence documents, including a passport, birth certificate and school records. The OTP was demanded over a phone call late at night on October 3, 2024, allegedly with threats that non-compliance would jeopardise his future in cricket. Subsequently, a first information report was filed against HCA officials under the BNS, the Aadhaar Act and the Information Technology Act for unauthorised access and threats. Despite the High Court issuing an interim order on November 6, 2024, restraining the respondents from enforcing the OTP requirement and directing them to permit the petitioner's registration, HCA did not comply. The association defended its action by citing an anonymous complaint alleging the petitioner had two different birth certificates and had possibly manipulated his age. The court found that no proper inquiry or show-cause notice had been issued, and the association had acted in breach of its own grievance redressal mechanisms under Rule 41. The judge reiterated that Aadhaar OTP verification was not a mandatory requirement for registration with BCCI or HCA. Citing a UIDAI circular and multiple judgments, the court emphasised that Aadhaar can only be used to establish identity and not as conclusive proof of date of birth. For players in the Under-16 category, age eligibility is determined based on the TW3 bone maturity test, which the petitioner had cleared. The report of this test was in HCA's possession, but the association failed to produce it before the court.

# Two Suspected Leopards Spotted at ICRISAT Campus in Patancheru; Forest Officials Await

### Hyderabad WUT | Apr. 15

Two suspected leopards were reportedly sighted on the campus of the International Crops Research Institute for the Semi-Arid Tropics (ICRISAT) in Patancheru on Monday, prompting forest authorities to initiate precautionary measures.According to ICRISAT officials, grainy visuals cap-

tured through drones and mobile phones showed what appeared to be two large cats roaming the premises. "We sought assistance from the forest department to identify the animals. We have alerted all staff and initiated safety protocols. We are awaiting official identification," said Tahira Natalie Carter, Head of Communications at



ICRISAT.Chief Wildlife Warden Elusing Meru stated that the visuals shared so far were inconclusive. "We cannot confirm if the animals are leopards based on the current footage. Trap cages and camera traps have been

sent to the site. If confirmed, veterinary teams with tranquiliser guns will be deployed to sedate and capture the animals," he said.All ICRISAT employees have been advised to remain alert, and internal safety procedures have been activated. This is the third such leopard sighting at ICRISAT since 2014. On previous occasions in 2014 and 2019, two

male leopards were eventually captured after months of effort by forest officials. However, this is the first time two big cats have reportedly been seen together on the campus — a rare occurrence in any urban area of Telangana.Interestingly, forest officials had also received a report of a possible leopard sighting from the ICRISAT area three days ago, which

was later identified as a jungle cat. A similar incident occurred in October 2024 near the Miyapur Metro Station, where what was initially believed to be a leopard turned out to be a jungle cat.Forest officials continue to monitor the situation closely as they work to verify the species and ensure the safety of both the campus residents and the animals.

## Salman Khan Receives New Death Threat

### Mumbai WUT | Apr. 15

Bollywood actor Salman Khan has once again received a death threat. The threat came via a message sent to the WhatsApp number of Mumbai's Transport Police Department in Worli, warning of killing the actor by entering his house and also threatening to blow up his car with a bomb. According to the police, the unidentified person sent the message at around 6.30 am Sunday, threatening to enter Salman Khan's residence



and kill him. The police said the sender also threatened to plant a bomb in the actor's vehicle and detonate it. "The message stated that they will definitely kill the actor. It was sent to the traffic police's helpline number, after which the matter was reported to us and a case

was registered," said a senior police official. Mumbai Police have registered a complaint and are investigating it now. The police also said they were trying to locate the suspect. Meanwhile, security around Salman's Bandra residence, Galaxy Apartments, has been

significantly beefed up. Last year in April, shots were fired at Salman's house by shooters associated with the gangster Lawrence Bishnoi gang, following which the actor's security was beefed up. He was upgraded to Y+ security after the firing incident. The Bollywood star, who has been on Bishnoi's hit list over the 1998 Blackbuck poaching case, has received multiple threats directly or indirectly through the Mumbai police in recent months. Bishnoi's gang had claimed responsibility for last year's firing

in a Facebook post and also said it was responsible for former Maharashtra Minister Baba Siddique's murder, who was known to be close to Salman Khan. A case was registered against 18 members of the Bishnoi gang for allegedly hatching a conspiracy to kill the Bollywood star. Lawrence Bishnoi is currently lodged in a Gujarat prison. In November last year, Salman Khan had received a death threat over a song linking his name to Bishnoi.

# carnage as they take on Knight Riders

Reeling from a demoralizing defeat at the hands of Sunrisers Hyderabad, a beleaguered Punjab Kings unit will look to regroup and bounce back when they take on the formidable Kolkata Knight Riders (KKR) at the Maharaja Yadavindra Singh Stadium in Mullanpur on Tuesday.In a rare and painful occurrence, Punjab found themselves on the losing side despite posting a mammoth 245-run total in their previous outing. The architect of their downfall was the explosive Abhishek Sharma, whose jawdropping 141 off just 55 balls blew the Punjab bowling unit to smithereens. The match, held in Hyderabad on a flat Uppal pitch, turned into a run-fest and highlighted serious chinks in Punjab's bowling

Iyer's valiant 36-ball 82 proved insufficient in the face of Abhishek's relentless assault, leaving the skipper visibly amused yet helpless at the post-match presentation.With that stunning defeat fresh in memory, Punjab now face another stern test against a balanced KKR side. The match will be played on their home turf at Mullanpur, a venue which too has proven to be a haven for batters. Both previous matches at this ground have seen first-innings totals exceeding 200, a fact that raises significant concerns for a Punjab bowling unit desperately searching for form and confidence.The most glaring concern lies in the performance of their spin duo — Yuzvendra Chahal and who together conceded 96 runs in just



seven overs during the Hyderabad clash. Chahal, in particular, has struggled to make an impact, conceding runs at an alarming rate of 11.13 per over across five matches, with only two wickets to show for his efforts. His traditional loopy leg-breaks, often pitched wide outside off stump, have failed to trouble batters. The coaching staff, led by Ricky Ponting, now face a tricky conundrum: whether to persist

with a flat battingfriendly wicket that has yielded big totals, or request a slower, grippier surface in hopes of aiding their spinners. However, even that approach comes with risks, as KKR possess spin aces of their own. Varun Chakravarthy, one of India's most improved T20 bowlers, thrives on such tracks, and the experienced Sunil Narine remains a potent threat, particularly in slower

conditions.KKR, riding high after their commanding victory over Chennai Super Kings at Chepauk, have looked comfortable on all kinds of surfaces. Their batting depth, spearheaded by Narine, Rinku Singh, and Venkatesh Iyer, makes them a wellrounded unit capable of adjusting to any challenge.For Punjab, the batting department has shown promise. Captain Shreyas Iyer has led from the front with 250 runs and three half-centuries in five games. Young Priyansh Arya has been a revelation, contributing 194 runs and emerging as one of the finds of the season. Alongside him, Indian batters Nehal Wadhera (141 runs), Prabhsimran Singh (133 runs), and Shashank Singh (108 runs) have provided stability and firepower in the middle and lower order.However, it is the overseas players who have underwhelmed. Glenn Maxwell has scored just 34 runs, while fellow Australian Marcus Stoinis has managed 59 runs in the tournament so far. The franchise will be hoping for a muchimproved show from the duo, especially when up against spinners of the calibre of Chakravarthy and Narine.Adding to the woes is South African pacer Marco Jansen, who, with an economy rate of 11.33, has leaked runs and failed to deliver consistent spells.As Punjab Kings gear up to face KKR, their biggest task will be to rediscover their bowling rhythm and seek better performances from their overseas contingent. A victory on Tuesday could help restore confidence and revive their campaign, but it will take a near-perfect allround performance to overcome a confident

## **Shia Community in Hyderabad Demands Reconstruction of Jannat-ul-Baqi Shrine**

In a powerful display of solidarity and religious devotion, hundreds of Shia Muslims, accompanied by religious scholars and community leaders, staged peaceful protests at multiple locations across Hyderabad on Sunday, demanding the reconstruction of the historic Jannatul-Baqi cemetery in Medina, Saudi Arabia. Holding placards and banners, the demonstrators

expressed deep anguish over the demolition of the revered Islamic site in 1926 by Saudi authorities. They called on the Kingdom of Saudi Arabia to restore the shrine, which once housed the graves of several prominent figures in Islamic history, including Bibi Fatima Zahra (SA), the daughter of Prophet Muhammad (PBUH). Speakers at the rallies condemned what they termed as the continued neglect and indifference of the Saudi government towards

the restoration of a site considered sacred by millions of Muslims around the world. They emphasized that Jannat-ul-Baqi holds immense spiritual, historical, and emotional significance-particularly for the Shia community. Established around 622 CE, Jannat-ul-Baqi served as the final resting place for many members of the Prophet's family, close companions, and respected Islamic scholars. The cemetery was once marked with mausoleums

A large protest rally was held by Shia Muslims from Hussainia Nawab Inayath Jung to Azakhana-e-Zahra, Darushifa, demanding the immediate reconstruction of Jannatul Baqi. Organized by Mazloom Hussain (AS) ke Azadaron, the rally saw participation from prominent Shia scholars, leaders, and community figures including Moulana Syed Luqman Hussain Moosvi Qibla, Moulana Hyder Agha Qibla, Moulana Syed Hasham Qibla, Moulana Ali Hyder Frishta Qibla, Moulana Mir Askari Ali Khan Qibla, Moulana Kamran Hyder Qibla, and others. Syed Layak Ali, SDO President, and Mir Inayat Ali Baqari were also present.

and intricately designed tombs, all of which were demolished during the rise of Wahhabism in the early 20th century. The destruction sparked decades of sorrow and protest from the global Muslim community. Protesters in Hyderabad underscored that their demand is not just about historical restoration but about fulfilling a religious responsibility. They urged the Saudi authorities to allow the reconstruction of the demolished shrines and facilitate respectful

visitation by pilgrims. The protest also brought to light ongoing tensions between heritage preservation and the Saudi government's modernization policies, which critics say often come at the cost of Islamic cultural and religious landmarks. Organizers concluded the protest with a renewed call for international Muslim solidarity and urged the global community to advocate for the preservation of Islamic heritage sites,

including Jannat-ul-Baqi.

## MLA Kaushik Reddy Alleges Massive Scam in Group-1 Results, Demands CBI Inquiry

MLA Padi Kaushik Reddy, speaking at Telangana Bhavan, alleged that the recently announced Group-1 results were the "biggest scam in the country." He questioned the integrity of the process, stating that candidates were issued one hall ticket during prelims and a different one for mains—an unprecedented anomaly.Highlighting discrepancies, he claimed 21,093 candidates appeared for the exam, yet results were announced for 21,103-raising questions about the origin of the extra 10 candidates. "654 candidates securing

the exact same marks is suspicious," he added, pointing to irregularities in paper evaluation that, according to him, was fast-tracked in 60 days instead of the usual 4-5 months.Kaushik Reddy said only 69 out of 10,000 candidates from certain centers secured jobs, while at two centers (18 & 19 in Koti Women's College), 74 candidates were selected out of 1,494 women. He also pointed to favoritism, alleging that

former MLC Ramulu Naik's daughter-in-law, who secured ST first rank, appeared from the same center.In Urdu medium, 7 of 9 candidates got jobs, while in Telugu medium only 70 of 7,800 were selected. He questioned the selective success. Reddy demanded a judicial and CBI probe, criticizing both Congress and BJP for silence. "If Revanth Reddy arrests me, I'm not afraid," he declared, claiming crores exchanged hands.He urged the cancellation of the Group-1 exam, slamming **BJP-Congress collusion** and demanding justice for Telangana's unemployed youth.



Minister remains silent on rampant deforestation and environmental destruction in BJP-ruled states. He alleged that PM Modi, who failed to allocate even a single rupee extra for Telangana's development, is in no position to comment

on the state's affairs. He advised the Prime Minister to verify facts before making public statements and to avoid being misled by the BJP leaders' claims. Highlighting the Con-

gress government's performance, Mahesh Kumar said Telangana has seen rapid development and welfare initiatives since the party came to power. He pointed out that over 60,000 government jobs

have been filled so far, and women now travel free in TSRTC buses. He added that the state government has waived farm loans and is offering financial support to farmers under the Rythu Bharosa scheme.

Criticising the Centre, he recalled that the Modi government had promised to create 2 crore jobs annually, a commitment that remains unfulfilled even after four years.

## **Rowdy-sheeter brutally murdered in Dabirpura**

Tension gripped the Dabirpura area of the Old City late last night after a 29-year-old rowdysheeter, Mohammad Masiuddin, was brutally murdered in public just three days before his wedding.

According to police, Masiuddin, a resident of Fa-

laknuma, had gone to Dabirpura in a four-wheeler around 1 am to distribute wedding invitation cards. As he reached near the Dabirpura flyover, unidentified assailants intercepted his vehicle. When he stepped out to speak to them, two attackers held him while others stabbed him multiple times with knives.

Mirchowk ACP N Venka-

teshwar Rao said the attackers inflicted more than nine stab wounds on Masiuddin's face, neck, abdomen, and other parts, resulting in his immediate death. The gruesome murder sparked panic in the area.

Police and forensic teams rushed to the scene and shifted the body to Osmania General Hospital for a post-mortem. Officials

confirmed that Masiuddin was a rowdy-sheeter with multiple criminal cases against him.

Preliminary investigations suggest the murder may have been the result of personal enmity. Police suspect Arif Khan, Aamir Khan (both brothers), Sheru, and Ibrahim were involved in the attack. Sources revealed that the accused had been tracking the victim's movements for some time. Special teams have been formed to trace and arrest the culprits.

The victim's brother alleged that some individuals paid the assailants to carry out the murder. Heavy police deployment has been arranged in the area to prevent any untoward incidents. Further investigation is ongoing.
