

United Muslim Forum Urges Massive Turnout for Protest Rally Against Waqf Amendment Act

Hyderabad WUT | Apr. 19

The United Muslim Forum has called upon citizens, especially members of the Muslim community, to participate in large numbers in a protest public meeting against the controversial Waqf Amendment Act. The rally, organized by the All India Muslim Personal Law Board, is scheduled to take place on Saturday, April 19, at Dar es Salaam. In a joint statement issued by the forum, key religious leaders and public figures, including Maulana Mufti Syed Sadiq Mohiuddin Fahim (President), Maulana Syed Shah Ali Akbar Nizamuddin

Hussaini Sabri, Mr. Syed Muniruddin Ahmed Mukhtar (General Secretary), and several others, expressed strong opposition to the amended Act. They criticized the central government's intent and legal strategy, stating that the postponement of the law's implementation and selective nonenforcement are mere tactics to weaken public resistance. The forum argued that the government is attempting to divide the Muslim community by raising issues related to backward classes and sectarian differences, while distracting from the core

issues of constitutional justice and minority

rights. The statement emphasized that the court has not stayed the law but accepted the government's undertaking not to implement certain provisions temporarily. "This is an attempt to buy time and cool down public sentiment," the forum said, urging people to continue the struggle with full intensity. The rally aims to send a strong message that Muslims, along with justice-loving citizens across faiths, stand united in demanding the withdrawal of what they termed a "black law." The forum called on the public to ensure the Dar es Salaam rally becomes a symbol of resistance and unity.

BRS Leader Krishank Manne Alleges Harassment by Congress Govt Over Forest Land Row

BRS social media convenor Krishank Manne appeared for the third time at Gachibowli Police Station on Saturday in connection with four FIRs filed against him regarding his online campaign on the Kancha Gachibowli forest land issue. After eight hours of what he described as aimless waiting, he has been asked to appear



again on April 23 for further questioning. Krishank accused the Congress government of using police summons as a tool of political harassment, especially with the BRS party's 25-year celebrations approach-

ing. "In just nine days, I've been called four times. They didn't even question me properly. Like on April 15, I was only made to sit for hours," he said, alleging

deliberate attempts to obstruct his political

work.

Citing the Supreme Court's Central Empowered Committee (CEC) report, Krishank claimed that the apex court confirmed illegal activity on the forest land, including the death of deer at the University of Hyderabad and unauthorized mortgaging of the land. "1,524 trees were cut down under the Revanth Reddy-led Congress government. This is not development, it's environmental destruction," he asserted.

He also criticized the Congress for allegedly dismissing the Supreme Court's findings as social media propaganda, saying it reflects their disregard for the environment and judicial process. Krishank vowed to legally fight what he called "politically motivated targeting" and said he won't be silenced by intimidation.



Kamalakar announced this while interacting with media persons after inaugurating a paddy purchase centre in Karimnagar rural mandal on Friday. The Narayanapur reservoir was the main water source for Karimnagar constituency. However, there was no water in Narayanapur. Though farmers

were facing troubles with regard to irrigation, the State government was least bothered about their issues. To mount pressure on the government, the padayatra would be taken out very soon, he said. Earlier, Kamalakar said officials should purchase paddy that arrived at the centres and shift it immediately to mills since there was a possibility of hailstorms in the coming days. Farmers, who were already suffering due to lack of Rythu Bandhu, irrigation water and crop

loan waiver, would suffer a huge loss if the crop was soaked in the rains. So, the government should immediately start the purchasing of paddy, he demanded.

Farmers suffered a huge loss by selling the crop to millers at low prices as the State government failed to start the procurement centres at the right time, he said, recalling that during the BRS regime, procurement used to start in the second week of March. Even soaked and discolored paddy was also procured providing MSP, he said.Farmers informed the MLA that officials had allocated long distance rice mills instead of the nearest ones for them to shift the crop after procurement.

Waqf Meet 'Cong's Plot to **Create Unrest': Bandi Sanjay**

Union Minister of State Bandi Sanjay Kumar on Friday launched a scathing attack on the Congress government in Telangana, alleging that the upcoming meeting organized by AIMIM chief Asaduddin Owaisi and the All India Muslim Personal Law Board (AIMPLB) at Darussalam on Saturday was a Congresssponsored programme intended to incite communal unrest

Speaking at a press conference, Sanjay warned that the situation in Telangana could deteriorate into chaos similar to that witnessed in Murshidabad and parts of West Bengal if such gatherings were



not curtailed. He held the Congress government squarely responsible for any potential law and order disturbances.

The minister alleged that the protests, being carried out under the pretext of opposing the Waqf Act, were part of a larger conspiracy to disrupt peace. Referring to official data, he pointed out that out

of the 77,000 acres of Waqf land in Telangana, only 16,000 acres—or about 20 per cent-were under the control of dargahs and masjids. "Who controls the remaining land?" he asked, accusing the Owaisi brothers of encroaching on Waqf properties for running hospitals, schools, and offices, thereby depriving poor Mus-

lims of their rightful resources

Sanjay demanded that the state government release a white paper detailing the income generated from Waqf land, how it is utilized, and whether the benefits reach the poor and Pasmanda Muslim communities. He estimated the value of Waqf land in Telangana to be over ₹5 lakh crore, adding that there was no transparency in the revenue generated and its expenditure.

He also highlighted that more than 4,000 Waqf-related cases are pending in courts, blaming the Waqf Board for deliberately delaying proceedings by not filing counter affidavits. The Dharani portal introduced by the previous BRS government

was also criticized for facilitating title changes on thousands of acres of Waqf land. On the National Herald case, Sanjay defended the ongoing investigation, stating that it began in 2012 before the BJP came to power. "Sonia Gandhi and Rahul Gandhi are out on bail. The court issued notices in 2013 and ordered a CBI probe," he said. He further questioned Congress protests at the Enforcement Directorate's office, suggesting they protest at Sonia Gandhi's residence instead. He also condemned the use of abusive language by Congress leaders, including former MP Anjan Kumar Yadav, and defended Union Minister G. Kishan Reddy against what he termed base-

Iran's Foreign Minister Abbas Araghchi has expressed growing concerns about the intentions of the United States, casting doubt over the U.S. commitment to a fair and peaceful resolution just a day before a new round of nuclear talks between the two nations. These talks, set to take place in Rome, follow a series of highlevel negotiations between the two countries, which represent the highest-level talks since U.S. President Donald Trump unilaterally withdrew from the 2015 nuclear deal three years ago. Since that time, Iran has gradually escalated its nuclear activities, including enriching uranium to levels up to 60 percent purity-near weaponsgrade levels of 90 percent. In a press conference held in Moscow on Friday, Araghchi was candid about the serious doubts Iran has regarding the United States' motivations in these negotiations. Despite these reservations, he made it clear that Iran would still participate in

The Russian Foreign Minister Sergey Lavrov also participated in the Moscow press conference, offering Russia's support in facilitating the ongoing negotiations. Lavrov stated that Russia was prepared to play any role deemed helpful by Iran and acceptable to the United States in the negotiations. He emphasized

that any potential agreement between Iran and the U.S. should focus strictly on the nuclear issue, warning against complicating the talks by introducing non-nuclear issues that could derail progress. Lavrov stressed that adding additional topics, such as Iran's missile program or its regional influence, could create unnecessary risks and hinder the chances of reaching a successful agreement. Iran's stance on the nuclear talks has remained firm. The country has drawn clear red lines regarding its nuclear program, particularly the enrichment of uranium. Araghchi specifically stated that Iran would not discuss uranium enrichment, especially in light

of U.S. negotiators pushing for a complete halt to Iran's enrichment activities. Additionally, Iran has made it clear that its missile program and regional influence are not open for negotiation, considering these areas to be beyond the scope of the nuclear talks. This hardline position is in line with Iran's long-standing rejection of what it perceives as unreasonable demands from the U.S. in past negotiations. Araghchi noted that while Iran is ready to engage in talks, there must be realistic expectations from both sides. He emphasized that if the United States refrains from making what he termed "unrealistic demands," an agreement could indeed be reached.

However, Iran has made it clear that it requires strong guarantees that the U.S. will not abandon any deal again, as Trump did in 2018 when he pulled the U.S. out of the 2015 deal without cause. Despite Iran's willingness to engage in dialogue, there remains a significant level of mistrust surrounding the negotiations. This mistrust is particularly evident among the Iranian public, where skepticism about the United States' intentions persists. At the same time, Iranian officials, including Araghchi, expressed a mix of cautious optimism and doubt as the talks approach. The Iranian government is steadfast in its desire to protect its sovereignty, particularly in regard to its nuclear advancements and military capabilities, which it believes are essential for national security. US Revokes 1,000+ Student Visas, Lawsuits

Wasington WUT | Apr . 19

In a move that has triggered alarm across the academic community, more than 1,000 international students have had their visas or legal status revoked in recent weeks, with many now facing the threat of detention or deportation. According to an Associated Press review, at least 1,024 students from 160 colleges and universities have been impacted, ranging from prestigious institutions like Harvard and Stanford to large public schools such as Ohio State and the University of Maryland.Several affected students have filed lawsuits against the

U.S. Department of Homeland Security

(DHS), claiming the government denied them due process and failed to provide valid reasons for the termination of their legal status. The American Civil Liberties Union (ACLU) and other legal advocates argue the DHS appears to have enacted an unwritten, nationwide policy targeting student visas en masse, often over minor infractions or for unclear reasons.In some cases, students have lost status over issues as trivial as old traffic violations. Colleges and universities have expressed concern over the arbitrary and opaque nature of the revocations,



noting a lack of communication from the federal government. DHS has so far not provided public comment on the situation.Student visas, typically issued under the F-1 category, require recipients to maintain academic enrollment and financial support. While these visas are issued by the State Department, legal status inside the U.S. is monitored by the Student and Exchange Visitor Program under DHS. Traditionally, students who

lost their visas could still legally remain in the U.S. to complete their studies. However, the recent terminations also revoke legal residency, placing students at risk of arrest.Legal challenges are underway across sev-

eral states. A federal judge in New Hampshire recently blocked the removal of a Dartmouth student, and similar cases are being heard in California and Georgia.Higher education leaders have condemned the lack of transparency, warning that these developments could deter future international enrollment. "These actions are creating fear and confusion," said Sarah Spreitzer from the American Council on Education. Meanwhile, colleges are urging students to carry immigration documents at all times and are calling on the federal government for clarity and accountability.

Have you ever wondered where your old smartphone goes after you toss it? That tiny device — filled with valuable metals and toxic chemicals — doesn't just vanish. More often, it ends up in landfills or is dismantled under hazardous conditions in developing countries. With technology evolving

rapidly, devices are being replaced at an alarming rate, fueling a growing e-waste crisis. E-waste, or electronic waste, includes discarded gadgets like smartphones, computers and TVs. While no universal definition exists, it generally covers expensive, durable products used for data processing, communication and entertainment. As lifespans shrink due to rapid innovation, global ewaste surged to 62 million tonnes in 2022 and is pro-

jected to hit 82 million

tonnes by 2030 (Statista,

informal processing and

2025). Poor recycling rates,

age per capita e-waste production was 7.8 kilograms. While Asia generated the largest quantity of e-waste overall, Europe and Oceania had the highest per capita rates, producing 17.6 kilograms and 16.1 kilograms per person, respectively. This shows that e-waste is not evenly distributed worldwide, and different regions handle it in different ways.

Within this vast waste stream, valuable metals such as gold, silver and platinum can be found in recoverable amounts. Valuable metals in e-waste were worth \$9.6 billion in 2022 and could reach \$13.6 billion by 2029. However, only 22.3% was properly recycled, while 48 million tonnes were informally handled, with 29% likely ending up in landfills.

SC to Hear Plea on Termination of **Telangana Law Officers on May 5**

Plea seeks fresh list for MPTC poll

ustice T. Madhavi Devi of the Telangana High Court took on file a writ petition challenging the final list of mandal parishad territorial constituencies (MPTCs) published by the district collector and district election authority in PA Pally mandal, Nalgonda district. The judge was hearing a writ plea filed by Palle Satyanarayana, an ex-sarpanch of PA Pally, and five others, assailing the action of the respondent authorities in publishing the final list of MPTCs without first issuing a draft notification or inviting objections, as required under the relevant administrative guidelines. The petitioners contended that the final list issued by the district collector and district election authority through proceedings dated February 3, 2025, was arbitrary and in direct violation of the instructions issued by the principal secretary, panchayat raj and rural development department, under Memo dated January 30, 2025. The petitioners contended that the respondent authorities had failed to publish the draft MPTC list and did not dispose of the objections already submitted, thereby denying them a fair opportunity to participate. The petitioners sought a direction to set aside the final publication and to direct the authorities to follow due process by first issuing a draft notification, inviting and considering objections, and only then publishing the final MPTC list in accordance with the official guidelines. The judge directed the government pleader for panchayat raj to get instructions from the respondent authorities and posted the matter next week.

The Supreme Court has scheduled a hearing on May 5 to consider a plea challenging the termination of several state law officers in Telangana following the formation of the Congress-led government. These law officers, who were appointed by the previous Bharat Rashtra Samithi (BRS) government to represent

the state at various judicial forums, have moved the apex court against the Telangana High Court's verdicts that upheld their dismissal. The plea has been filed by Yendala Pradeep and others.On April 17, a bench comprising Justices Ahsanuddin Amanullah and Prashant Kumar Mishra heard the matter briefly before deferring it. The court allowed the adjournment after the

counsel for the Telangana government sought time to seek fresh instructions in light of the arguments presented."After hearing senior counsel for the petitioners, when called upon, counsel for the state submitted that in view of issues which have emerged during the course of arguments, she would be required to take fresh instructions, specifically on such issues," the bench noted while

adjourning the matter. The legal challenge pertains to a government order issued in June 2024, shortly after the Congress came to power following the Assembly elections in November 2023. The new administration terminated the services of law officers appointed under the previous regime, prompting a legal dispute over the validity of such action. The petitioners argue that

a change in political leadership does not alter the constitutional identity of the state and claim that their services were unfairly terminated solely due to political reasons. They are seeking reinstatement and all consequential service benefits.However, both a singlejudge bench and a division bench of the Telangana High Court had dismissed their petitions. The High Court ruled that

law officers serve at the pleasure of the government and are not regular employees, adding that their appointments are contractual in nature and may be terminated with a month's notice or honorarium.The court also observed that the appointments were not made through a formal selection process and reaffirmed the government's authority to choose its legal representatives

Telangana High Court Continues Hearing on Plea **Against Govt's Stance on AICTE-Approved Intake**

The Telangana High Court on Friday continued hearing a batch of writ petitions challenging the state government's stance on student intake for the academic year 2024-25 in AICTE-approved institutions. Justice K. Lakshman is presiding

over the case, which includes petitions filed by MGR Educational Society and others.

The petitioners have contested the applicability of Section 20 of the Telangana Education Act, 1982, arguing that it is unconstitutional and ultra vires when applied to approvals granted under the AICTE Act, 1987.

They urged the court to strike down a government memo issued in August 2024, calling it arbitrary, unlawful, and violative of constitutional provisions. According to the petitioners, their institution had received full approvals from both the All India Council for **Technical Education** (AICTE) and Jawaharlal Nehru Technological University (JNTU) for its courses, including an increased student intake for 2024-25. However, the state government's reliance on Section 20 and the subsequent issuance of the memo allegedly prevented the institution from admitting students to its full sanctioned capacity. The plea also sought

directions from the court to recognize the petitioner college as duly approved for the current academic year and to permit admissions either through a fresh mop-up round of TG Eapcet counselling or via spot admissions. Earlier in September 2024, the High Court had declined to grant interim relief, citing the

completion of admissions and the commencement of the academic session in August. The court had also dismissed interim prayers to suspend the impugned memo and to direct authorities to notify all approved courses and intake during the mop-up and spot admission phases of TG Eapcet 2024-25.

ITC had acquired a 26.5 per cent stake in D2C company Mother Sparsh in 2022. About SNBPL, ITC said it will be an all-cash deal, and the cost of acquisition

is up to Rs 472.50 crore on a cash-free, debt-free basis.

"The share purchase agreements, comprising Rs 400 crore payable upfront at closing and up to Rs 72.50 crore payable in the next 24 months," it said. SNBPL's portfolio comprises a wide range of over 100 organic products, spanning branded grocery staples, spices and condiments, edible



Royals in for a clash against Lucknow Super **Giants at Jaipur**



n inconsistent Rajasthan Royals will be desperate to plug the holes across departments and halt a three-match losing streak when they host Lucknow Super Giants in the Indian Premier League here on Saturday.

With just two wins from seven games, the Royals are languishing at eighth on the table and come into the contest on the back of a gut-wrenching Super Over defeat to Delhi Capitals.

As the league hits the halfway mark, they'll need to shake off the heartbreak quickly if they hope to upstage Rishabh Pant's men and climb out of the bottom half.

Plagued by inconsistency in both batting and bowling, RR's campaign has struggled to find momentum. To make matters worse, skipper Sanju Samson suffered a side strain in the previous match and had to retire hurt, though he later said he was feeling "alright."

The Royals' batting, built around Indian mainstays, has misfired far too often, leaving the middle order exposed and under pressure.

Opener Yashasvi Jaiswal, however, seems to have shaken off his rustiness with back-to-back half centuries against Royal Challengers Bengaluru and DC. But it will have to be seen if he carries the momentum into Saturday's match. Samson is yet to produce a defining knock, with the 66 he made in RR's first match against Sunrisers Hyderabad being his best so far. A lot will depend on his and Jaiswal's form regarding how RR fare against the likes of Shardul Thakur, Avesh Khan, Digvesh Rathi and Ravi Bishnoi. Riyan Parag and Dhruv Jurel have not made much contribution so far in the batting front, and the duo need to fire if RR have to post or chase down a big total. Nitish Rana came back to form with a 51 against DC after the 81 he made against Chennai Super Kings last month, and he needs to carry on the momentum.

On the bowling front, Jofra Archer has slowly gotten into his groove. But the Royals' attack as a whole has been toothless. Apart from Sandeep Sharma, their other bowlers have struggled to control the scoring rate. Sri Lankans Wanindu Hasaranga and M Theekshana have not done much really with seven wickets from as many matches while conceding lot many runs.

India fields strong squad for Asian Boxing, reflecting bright future

Punjab Kings beat RCB in rain-hit match

After reducing the hosts to a total of 95 runs with crafty bowling

In a rain-affected IPL encounter that commenced unusually late at 9:45 PM, Punjab Kings delivered a disciplined allround performance to secure a convincing fivewicket victory over Royal Challengers Bengaluru (RCB) at the M. Chinnaswamy Stadium on Friday. The match was reduced to 14 overs per side due to persistent evening showers, but that did little to dampen the intensity of the contest.

Punjab's bowlers laid the foundation for the win by executing a near-perfect strategy with the ball, restricting RCB to a belowpar 95 for 9. Despite a few hiccups in their chase, the Kings over-

hauled the target in 12.1 overs, finishing at 98 for 5 and moving to second place on the points table with 10 points-just behind leaders Delhi Capitals. Meanwhile, RCB's woes at home continued as they remain winless on

their turf this season. Punjab Kings skipper Shreyas Iyer's decision to bowl first after winning the toss proved to be spot on. The pitch, fresh from the rain and offering considerable bounce, turned



into a tricky surface for stroke-making. The RCB innings got off to a disastrous start as Phil Salt was dismissed in the very first over. Attempting an aggressive shot off Arshdeep Singh, Salt only managed to get a faint edge that was safely pouched by wicketkeeper Josh Inglis. The early loss of Salt was just the beginning of RCB's troubles. Star batter Virat Kohli followed soon after, falling to a well-directed delivery from Arshdeep. Marco Jansen covered significant ground to take a brilliant catch in the deep, sending the crowd

into stunned silence. RCB found themselves reeling at 26 for 3 by the end of the powerplay, with Liam Livingstone also falling cheaply.

The middle order failed to provide any real resistance. Yuzvendra Chahal, returning to his former IPL home ground, made an immediate impact by dismissing Jitesh Sharma and later accounted for Rajat Patidar. Patidar had looked promising during his short stay, stroking 23 off 18 balls, including a stunning pick-up shot for six over mid-wicket, but he too succumbed to the pressure. Marco Jansen, combining pace and bounce effectively, struck twice in an over to dismiss Krunal Pandya and impact substitute Manoj Bhandage. With wickets tumbling at regular intervals, it was

Tim David who stood tall amidst the ruins. David, coming in at a precarious moment, played a brilliant lone hand for RCB. The Australian all-rounder remained unbeaten on 50 off just 26 balls, striking powerfully and cleanly to give his team a fighting chance. His most impressive moment came against left-arm spinner Harpreet Brar, whom he took for three consecutive

sixes in a lone display of aggression. Thanks to his knock, RCB managed to reach 95 for 9, a total that looked far from sufficient but still defendable on a testing surface.

Brar, despite being hit by David, had a commendable outing with two crucial wickets, while Arshdeep (2/23), Jansen (2/10), and Chahal (2/11)

shared the honors in what was an all-round bowling effort from the Kings. Punjab Kings' chase began with a bit of uncertainty. Their in-form and explosive opening pair of Privansh Arya and Prabhsimran Singh looked unsettled against the bounce and movement generated by the RCB pacers. Arya, who had impressed earlier in the tournament, struggled to time the ball and eventually fell to a

mistimed lofted shot off Josh Hazlewood, caught by Tim David. Hazlewood, RCB's standout bowler on the night with figures of 3 for 14, then sent back skipper Shreyas Iyer for a low score. Iyer, attempting a cut shot to a delivery too close to his body, edged it behind to wicketkeeper Jitesh Sharma. Prabhsimran and Josh Inglis also departed cheaply, and with the

Starc as Gujarat takes on Delhi Capitals

Mitchell Starc's mastery at the death and Mohammed Siraj's resurgence with the new ball will be the centrepieces of a blockbuster topof-the-table IPL showdown as Delhi Capitals take on Gujarat Titans in what promises to be a high-octane clash on Saturday. The Capitals, who currently sit comfortably at the top with 10 points from six matches, come into the encounter riding a wave of momentum. Their dramatic Super Over victory against the Rajasthan Royals in their previous outing has only added to the team's confidence. Starc, the architect of that triumph, delivered a spell of high-class fast bowling under pressure - including an unforgetta-

ble Super Over filled with toe-crushing yorkers — to seal the win. The Australian speedster, having skipped the Champions Trophy to recharge after a demanding Border-Gavaskar Trophy, looks fresher and sharper than ever. With 10 wickets to his name and an economy rate just over 10, Starc has led Delhi's pace attack with intent, ably supported by



Mukesh Kumar and Mohit Sharma. The upcoming battle between Starc and Gujarat's top order could very well shape the outcome of the match. Gujarat's batting has revolved around the consistency of skipper Shubman Gill, the dependable Sai Sudharsan, and the ever-dangerous Jos Buttler. At least one among them has scored

a half-century in every game so far, making them the backbone of the Titans' runscoring engine. However, their middle order remains relatively untested, and when finally exposed against the Lucknow Super Giants, they stumbled, resulting in a loss. If Delhi's pacers, led by Starc, can dismantle the top order early, it could leave

Gujarat vulnerable and swing the game in Delhi's favor.On the flip side, Gujarat's bowling spearhead Mohammed Siraj has undergone a transformation of his own. After an underwhelming Test series and missing India's Champions Trophy campaign, Siraj took time off to work on his craft ---and it's paying dividends. With 10 wickets at an economy rate of 8.50, he has become the driving force of Gujarat's pace battery. Siraj has particularly excelled in the Powerplay, using his Test-match lengths and lateral movement to trouble batters.Siraj's battle will be against a relatively inexperienced Delhi opening pair — Jake Fraser-McGurk and Abishek Porel. Fraser-McGurk has yet to find rhythm in this IPL, while Porel has shown glimpses of promise. Both will be tested not only by Siraj but also by the in-form Prasidh Krishna, who has quietly had an outstanding season. Should Delhi lose early wickets, they will look towards the experience of KL Rahul and Karun Nair to stabilize their innings. Axar Patel, who plays for Gujarat in domestic cricket, will be keen to

make an impact on his home ground. His recent return to form with both bat and ball adds depth to the Capitals' lineup.Spin is expected to play a significant role as well. Gujarat have a reliable spin duo in Rashid Khan and Sai Kishore, who've regularly tied up opposition batters. Delhi's spin threat has come from Kuldeep Yadav, who's been instrumental in the middle overs alongside young left-arm spinner Vipraj Nigam. However, Kuldeep's availability remains uncertain after he walked off with a shoulder injury in the previous game. His absence would be a major blow to Delhi's bowling plans, and the franchise is yet to provide a fitness update.With two well-balanced teams clashing, each boasting world-class pace and spin options, and explosive batting lineups, this encounter could be a defining moment in the race for the IPL playoffs. The key will lie in the fine margins — whether Starc can break Gujarat's top order early, or if Siraj can dent Delhi's fragile opening combination — setting up what promises to be a thrilling contest.

Fierce Thunderstorm Batters Hyderabad, Brings Relief and Chaos

A sudden and intense thunderstorm swept through Hyderabad on Friday evening, catching residents off guard and disrupting daily life across the city. The storm, marked by heavy rain, gusty winds, and even hail in some areas, brought much-needed relief from the recent heatwave but left behind widespread chaos.

According to the Telangana Development Planning Society, the highest recorded rainfall was 80.5 mm at the Owaisi Community Hall in Kanchanbagh. Several other localities, including Bahadurpura and Yakutpura, also reported rainfall ex-



ceeding 60 mm. The weather system began forming around 5:45 PM in western Hyderabad and rapidly intensified. Dark clouds rolled in swiftly, followed by strong winds and a heavy downpour. Localities such as Nallakunta even witnessed a brief hailstorm. Neighbourhoods like Gachibowli, Nanakramguda,

Manikonda, Narsingi, and Bandlaguda were the first to be hit. The storm then spread across the city, affecting areas including Shaikpet, Kokapet, Hitec City, Alwal, Sainikpuri, Malakpet, LB Nagar, Ameerpet, Paradise, and several others.

The downpour caused severe waterlogging, with vehicles seen navigating

knee-deep water. Traffic snarls and signal failures were reported at several key intersections during the evening rush hour. Fallen trees added to the gridlock, with at least 48 tree-fall complaints received by the Hyderabad Revenue and Disaster Management Authority. Areas like Saroornagar, Kukatpally, BN Reddy Nagar, and Sultan Bazaar were among the worst affected.

Power outages were reported in parts of Khairatabad, Saidabad, and nearby localities. GHMC's Disaster Response Force (DRF) teams were deployed to clear debris, pump out water from flooded streets, and restore normalcy. Operations con-

tinued late into the night, especially in trouble spots like Raj Bhavan Road, Pragathi Bhavan, and Shilparamam.

The Indian Meteorological Department (IMD) has issued a yellow alert for Hyderabad and 16 adjoining districts, forecasting thunderstorms, lightning, and gusty winds up to 50 km/h over the next 3-4 days. The storm was caused by a weather system pulling moisture from the southern Bay of Bengal, leading to atmospheric instability. While the rain offered temporary relief from the scorching heat, temperatures are expected to climb back to around 40°C in the coming week, meteorologists warned.

KTR Urges PM to Probe Rs 10k Cr Scam in Kancha Lands

BRS working president K.T. Rama Rao urged Prime Minister Narendra Modi to order a swift investigation into the destruction of the Kancha Gachibowli forest and an alleged Rs 10,000 crore financial scam. In a public appeal on X, he accused the Congress-led state government of orchestrating a massive fraud. Rama Rao described it as an environmental catastrophe and a grave financial fraud. The BRS leader alleged that the Telangana government mortgaged the 400 acres of land --lacking legal title — to raise a Rs 10,000-crore loan through intermedi-



aries, bypassing environmental clearances and forest department approvals. "This is not just about biodiversity loss. It's a 10,000 crore scam by the Congress government," he averred. He claimed that the Supreme Court's Central **Empowered Committee** (CEC) had confirmed financial irregularities and recommended probes by Central agencies. The BRS has submitted evidence to support these

claims, he said. Referring to the Prime Minister's April 14 remarks in Haryana condemning deforestation in Telangana, Rama Rao urged Modi to expedite investigations to demonstrate his commitment to environmental protection and dispel perceptions of BJP-Congress collusion. "It's time to show Telangana that BJP and Congress aren't working together and that you truly care about protecting the environment," he said. He also criticised Chief Minster Revanth Reddy's claim that there was no wildlife in Kancha Gachibowli, pointing to a Telangana High Court Registrar's report confirming the presence of diverse fauna in the area.


