## UK, India Seal Historic Trade Deal



In a significant diplomatic development, Sir Oliver Robbins, Permanent Under-Secretary at the UK's Foreign, Commonwealth and Development Office or FCDO, arrived in India on Tuesday to review the progress of the UK-India Comprehensive Strategic Partnership. During his visit, Sir Oliver met India's Foreign Secretary, Vikram Misri, in New Delhi for the annual UK-India Foreign Office Consultations.

The meeting marked a crucial milestone in the bilateral relationship between the two nations, with both sides welcoming the significant breakthroughs achieved across the entire gamut of the partnership since the last consultations in London. One of the major highlights of the partnership is the historic trade deal announced between the two countries, which is expected to boost economic ties and open up new avenues for

cooperation.

## India Folded Up Pak Plan in Just 8 Hours: CDS

Chief of Defence Staff stresses outcomes over losses and highlights India's precise strikes

New delhi WUT | June. 4

The Chief of Defence Staff (CDS) Gen. Anil Chauhan on Tuesday asserted that Operation Sindoor showed that India is not going to live under the shadow of terror and nuclear blackmail. The CDS said professional military forces are not affected by setbacks, as overall outcomes are more important than losses during conflicts. Calling the terror attack on tourists in Pahalgam a "profound cruelty", Gen. Chauhan said that "our adversary's (Pakistan) approach is to bleed India by a thousand cuts" but India drew a new red



line against cross-border terrorism by conducting the Operation Sindoor.
"On May 10, at about 1 am, their (Pakistan) aim was to get India to its knees in 48 hours. Multiple attacks were launched... They have escalated this conflict...we had actually hit only terror targets... Operations which they thought will

hours. They picked up the telephone and said they wanted to talk," said CDS. He said Pakistan Army Chief Gen. Asim Munir spewed venom against India and Hindus just weeks before what happened in Pahalgam. Responding to queries over his acknowledgement that India lost an unspecified number of combat jets during the initial phase of the operation, the CDS said, "When I was asked about losses on our side, I said these are not important, as results and how you act are important." ## I.N.D.I.A Bloc Leaders Demand Parliament Session

New delhi WUT | June. 4

I.N.D.I.A. bloc leaders on Tuesday signed a petition demanding a special session of Parliament on Operation Sindoor in June. Speaking after the meeting, Congress MP Deependra Singh Hooda said 16 Opposition parties had written to PM Modi for the session.

"From Pahalgam to Operation Sindoor to America's announcement of the ceasefire to delegations going across the world, we should have discussions on them in the Parliament... We should also discuss how to eradicate terrorism and our further strategies in Parlia-

ment.

When the Government of India is putting forward its views in front of the world, I think the government should do the same in the Parliament as well," Hooda said, The Aam Aadmi Party distanced itself and the Nationalist Congress Party (SP) of Sharad Pawar was not among the parties. The DMK could not join the meeting as it coincided with Karunanidhi's birth anniversary.

Sanjay Raut said, "Sharad Pawar sahab is also with us. This letter has signatures of floor leaders... Supriya Sule ji is out of the country. I will talk to him when I go to Mumbai,"

#### 44 Dead As Flood Situation Remains Grim In Northeastern States

In Assam, over 6.33 lakh people were affected by the floods and rains in 21 districts.

The overall flood situation in Assam and other northeastern states remained grim on Tuesday, as the death count in seven states of the region climbed to 44, officials said.

Prime Minister Narendra Modi on Tuesday called the Chief Ministers of Assam and Sikkim, as well as Manipur Governor Ajay Kumar Bhalla, to take stock of the flood situation in the northeastern states and offered all possible assistance in dealing with

Revanth Reddy has convened the state Cabinet meeting on June 5 to deliberate on several key issues, including approvals for the Hyderabad Metro Rail phase-2 (part-B), pending matters related to state government employees, Rajiv Yuva Vikasam scheme and action on NDSA, Vigilance Commission reports concerning the Kaleshwaram

project. According to official sources, key issues on cabinet agenda include approval of detailed project reports (DPRs) for the Hyderabad Metro Rail phase-2 (part-B), covering the Medchal and Shamirpet corridors. These DPRs were prepared and cleared by the Hyderabad Airport Metro Limited (HAML) Board on May 8 and will be forwarded to the Centre for financial assistance once approved by the Cabinet. The proposed JBS Station-Medchal



route will span 24.5 km as

a fully elevated corridor with 18 stations, while the JBS Station-Shamirpet route will stretch 22 km, comprising 14 stations, with a 1.65 km underground section near the Hakimpet Indian Air Force Station. The RGIA-Future City route, up to Skill University, will extend over 39.6 km, including underground, elevated, and at-grade sections. The inauguration of train services will mark the linkage between the Kashmir Valley and the rest of the country. The Vande Bharat train will operate between Katra and Baramulla. Initially scheduled for April 19,



the inauguration of train service was postponed due to unfavourable weather conditions. The unveiling was further delayed after the April 22 Pahalgam terror attack and thereafter Operation Sindoor. CONT:P4

## Pakistan Dossier Shows India Hit More Targets Than Revealed

Pakistan has named seven more cities that were allegedly hit by Indian missiles and drones during Operation Sindoor. A Pakistani dossier has maps showing Indian strikes at Peshawar, Attock, Gujrat, Jhang, Bahawalnagar, Hyderabad and Chhor.



Peshawar is deep inside Pakistan, over 1,000 km away from the Line of Control. Though India ensured the strike remained on military infrastructure alone, Pakistan has tried to portray these strikes on civilian areas. A response is awaited from the Indian government but the possibility of Pakistan trying to build up a case

against India for attacking its civilian areas cannot be ruled out as these places were not in the list of cities, airbases or military infrastructure that the Indian side has claimed to have bombed during Operation Sindoor. India had claimed attacks on the Nur Khan airbase in Rawalpindi, Muridke in Punjab, Shorkot (PAF base

Rafiqui) in Jhang, Sargoda and Rahim Yar Khan bases in Punjab, Bholari, Jamshoro, Sukkur, Jacobabad in Sindh. India had also hit Muzaffarabad and Shakargarh. Pakistan claims India also hit Malir military base at Karachi, where air defence sites and signal units are believed to be destroyed while India has not said much about Karachi. An Indian Navy officer said during a briefing during Operation Sindoor that Karachi was among the targets. However, Hyderabad, Chhor, Bahawalnagar, Jhang, Gujrat and Attock targets remain unclaimed by the Indian side. Pakistan also claimed that Indian long-range missiles targeted

parts of Afghanistan, a fact denied by both the Indian and Afghanistan governments instantly. The spokesperson in the Afghan ministry of defence, Inayatullah Khawarizmi, said "there is no truth to such claims". Pakistan even claimed that India violated Pakistani airspace during a period CONT:P4



#### Dalit, Tribal, BC Groups Demand Removal of **Gurukul Secretary Over Forced Labor Allegations**

WUT | June . 4

National Ambedkar Sena National President Manne Sridhar Rao, State President Taluka Rajesh, and Jaibhim Sena Fight for Rights Founder P. Balwant Rao have demanded the immediate removal of Gurukul Secretary Alugu Varshini following allegations of forced labor and caste discrimination against Dalit, tribal, and BC students in Guru-

kuls. The leaders condemned recent media reports exposing orders requiring SC, ST, and BC students to clean toilets, bathrooms, hostels, and rooms at Gurukuls, calling the orders unconstitutional and deeply



offensive to the sentiments of Dalit communities. They highlighted that the removal of sanitation staff at Gurukuls effectively forces students into menial labor, which they labeled as a blatant insult and a form of caste-

based discrimination. The protestors stressed that such practices amount to forced child labor and deny these students their right to education. Various

Alugu Varshini is not removed from her post, the Revanth government would face severe consequences.

Under the banner of

several organizations, hundreds protested outside the Social Welfare Bhavan police station, demanding Alugu Varshini's dismissal. A petition was submitted to Additional Secretary Dr. Kiran Mai by TGSWREiS representatives. Complaints demanding atrocity and criminal case registrations against Alugu Varshini were also lodged at the Masab Tank police station. The protests highlight growing outrage against caste discrimination and forced labor practices in Telangana's Gurukuls.

### AIDSA Raises Concern Over Biomedical Waste Charges for Dental Clinics

**Hyderabad** WUT | June. 4

The All India Dental Students and Surgeons Association (AIDSA) has urged the Telangana State Pollution Control Board (TSPCB) to reconsider the biomedical waste management fees charged to dental clinics across the state. In a formal representation to Mr. G. Ravi, IAS, Member Secretary of TSPCB, AIDSA highlighted that dental clinics, especially small setups with one or two chairs, are unfairly burdened with high, uniform



charges similar to large hospitals that generate far more biomedical waste. Dr. MD Manzur Ahmed, AIDSA's National & Founder President, stressed that this "onesize-fits-all" approach is unjust and threatens the viability of many small dental practices. Key issues raised include:

• Disproportionate fees unrelated to actual waste volume. · Financial strain on small and new dental clinics.

· Absence of a differ-

entiated fee structure based on clinic size. AIDSA recommends a clear fee categorization by clinic size: one-chair, two-chair, and three-chair or larger clinics. This, they argue, would promote fairness, transparency, and sustainable waste management without penalizing smaller dental providers. Dr. Ahmed emphasized, "We seek fairness and equity, not exemption from regulation. Dental clinics must be fairly treated in biomedical waste policies."

AIDSA has called on TSPCB to audit waste collection agencies and implement a rational, transparent fee system reflecting true waste generation levels. The association remains committed to collaborating with authorities to ensure policies that are clinically relevant, economically viable, and environmentally responsible, hoping for swift action to support Telangana's dental community.

#### Six more temple bulls die; toll rises to 26 in Rajanna-Sircilla



**Hyderabad** WUT | June. 4

Six more kodelu (bulls) at the Sri Rajarajeshwara Swamy temple goshala died on Tuesday. With this, the total number of deaths has risen to 26.

District Veterinary Officer Ravinder Reddy, in a statement, said 14 more bulls were suffering from illhealth. Improved treatment was being provided, with veterinarians brought in from the erstwhile Karimna-

gar district. According to the vets, the deaths were occurring because both calves and aged bulls were being kept in the same enclosure. Reddy advised devotees to donate kodelu that were more than one-and-a-half years old.

On the first day, eight kodelu died due to ill-health caused by unseasonal rains. Five more died the next day, followed by four on the third day. Three died on Monday, and five more on Tuesday.

#### Koppula Eshwar Slams Congress Over Banner Removal

**Hyderabad** WUT | June . 4

Former Minister Koppula Eshwar has strongly criticized the Congress-led Telangana government for allegedly removing banners and hoardings installed in Hyderabad to mark the birthday of former Minister T. Harish Rao. Eshwar accused Chief Minister Revanth Reddy of personally directing officials to take down the displays overnight, calling it an act of political vendetta. Describing the move as "petty politics," Eshwar said, "Removing birthday banners for sadistic satisfaction reflects the Congress government's



low-level and vindictive political behavior." He contrasted this with what he called the visible double standards of the administration, pointing out that banners featuring the Chief Minister and other Congress leaders remain untouched for months. Eshwar questioned the Congress party's confidence, asking, "If the

government fears a few banners, what does that say about their governance?" He alleged that the ruling party is resorting to such actions because it is unable to answer public criticism over its inefficiency and negligence. He emphasized that no amount of banner removal will reduce public admiration for Harish Rao, a key



figure in the Bharat Rashtra Samithi (BRS). "The Congress party is using undemocratic methods to silence the opposition," he said.

Concluding his remarks, Eshwar asserted that the BRS will soon return to power and that KCR would be reinstated as Chief Minister. He warned Revanth Reddy to "refrain from indulging in cheap political stunts" and focus instead on governance.

The Cabinet is also expected to address pending demands of government employees, especially the clearance of at least one or two of the pending five dearness allowances (DAs) yet to be disbursed. Discussion is likely on the issuance of new job notifications, which were on hold since August 2024 due to the Supreme Court's sub-categorisation case, resolved in April this year. Another key focus will be the Rajiv Yuva Vika-

sam scheme aimed at providing selfemployment to unemployed youth. The distribution of sanction letters for financial assistance, originally scheduled for June 2, was postponed to allow for careful beneficiary selection, following an overwhelming 16.23 lakh applications for five lakh sanctioned units. Financial aid under this scheme ranges from `50,000 to `4 lakh, depending on the self-employment category. The Cabinet is expected to discuss NDSA and Vigilance Commission reports on the Kaleshwaram project. The National Dam Safety Authority (NDSA) submitted a 378-page report on April 24 this year, highlighting that the lack of a proper Operations & Maintenance manual contributed to failures at the Medigadda, Annaram, and Sundilla barrages. The report also faulted the previous BRS government for initiating construction before DPR approval by central agencies.

## CM Revanth Reviews Monsoon Preparedness, Directs Emergency Response Measures

#### Stresses 24/7 emergency response, flood prevention in Hyderabad's Core Urban Region

With the southwest monsoon expected to bring significant rainfall to Telangana in the coming days, Chief Minister A. Revanth Reddy chaired a crucial high-level review meeting today to assess the state's preparedness for the upcoming monsoon season. The meeting, held at the Command Control Centre in Hyderabad, brought together senior officials from key departments to discuss flood mitigation strategies, emergency response mechanisms, and infrastructure readiness. The Chief Minister underscored the urgent need for a proactive and coordinated approach to handle heavy rainfall and its associated challenges, especially in Hyderabad



and surrounding urban areas. He stressed that the safety of citizens must remain the topmost priority and directed officials to ensure that 24/7 emergency services are activated and ready to respond swiftly, particularly in flood-prone and low-lying zones across the capital city.

Reviewing the status of the city's stormwater management systems, CM Revanth Reddy specifically sought updates on the construction of rainwater harvesting wells at 141 critical waterlogging points previously identified by civic authorities. He emphasized that these

harvesting wells, once fully operational, would play a key role in reducing surface flooding. To this end, he directed that automatic pump systems be deployed to channel excess rainwater efficiently into these wells, preventing stagnation and easing pressure on existing drainage networks. Given the Indian Meteorological Department's (IMD) forecast of substantial rainfall over the next few weeks, the Chief Minister instructed that all preventive measures be implemented without delay. He proposed the establishment of a real-time rainfall and flood monitoring system at the Command Control Centre.

This system, he said,

should be capable of

tracking rainfall intensity,

flood levels, and water ac-

cumulation in real-time,

thus enabling timely and data-driven responses by disaster management teams.

CM Revanth Reddy also highlighted the importance of seamless coordination among departments during the monsoon. He issued strict instructions to the Police Department, Traffic Police, Greater Hyderabad Municipal Corporation (GHMC), and the Hyderabad Road Development Agency (HYDRAA) to remain on high alert and maintain close inter-departmental communication. These agencies were asked to work in tandem to ensure uninterrupted vehicular movement during downpours, clear waterlogged roads quickly, and respond efficiently to public distress calls.

A key focus of the meeting was the review of in-

complete drainage works and ongoing desilting efforts across Hyderabad. The Chief Minister called for their immediate completion, warning that any delay could worsen flood risks. He also directed officials to map high-risk zones known for frequent flooding and develop localized mitigation strategies, including temporary shelters, mobile emergency units, and prepositioned relief materi-

The rapid urban expansion within the Outer Ring Road (ORR) area referred to as the Core Urban Region—received special attention during the meeting. Revanth Reddy acknowledged the pressure that unplanned development is placing on the city's natural drainage systems and infrastructure.

#### Adi Srinivas: BRS-BJP Merger Inevitable, Harish Rao Misleading Public

Adi Srinivas, Government Whip of the Congress Legislative Party, addressed the media today accusing the Bharat Rashtra Samithi (BRS) leadership of misleading the public about political alliances. He highlighted recent statements by Harish Rao, who denied any plans of BRS forming alliances, calling Rao "innocent" and questioning his authority within the party. Srinivas alleged that efforts to merge

For families whose homes are still intact but damaged, she called for targeted financial assistance or interest-free loans for repair and modernization.She also advocated for the establishment of two reserved Assembly constituencies for the community to ensure political representation."This issue goes beyond politics and touches the core of our collective conscience. It is a moral imperative and societal responsibility to ensure our Pandit brothers and sisters return in a dignified, secure, and sustainable manner," Mufti said in her letter.She noted that all political parties in Jammu and Kashmir have consistently supported the return of the Pandits and called for an all-stakeholders approach rooted in empathy, mutual trust, and ground realities.

## India Folded Up Pak Plan in Just 8 Hours, Says CDS

Chief of Defence Staff (CDS) General Anil Chauhan has asserted that Operation Sindoor marked a turning point in India's stance against terrorism and nuclear blackmail, sending a strong message to Pakistan. Speaking on Tuesday,

he said the operation
reflected India's refusal

readiness to respond
decisively.Calling the
Pahalgam terror attack
on tourists a "profound
cruelty," Gen. Chauhan
said Pakistan continues
its strategy to "bleed
India by a thousand
cuts." However, Operation Sindoor demon-

strated India's capability and resolve. "Their aim was to bring India to its knees in 48 hours. But the conflict wrapped up in just eight hours, and they called for talks," he revealed. The CDS condemned Pakistan Army Chief Gen. Asim Munir for hateful rhetoric just before the attacks. Despite the initial loss of

some combat jets, Gen. Chauhan downplayed the setbacks.

"In professional forces, morale and adaptability matter more than counting losses," he emphasized. Using a cricket analogy, he said India inflicted an "innings defeat" on Pakistan, highlighting the scale of India's success. He

added that the operation wasn't about retribution but about defining limits on tolerance to cross-border terrorism.Gen. Chauhan noted the air strikes penetrated deep into Pakistan's well-defended areas, marking a historic moment in air warfare. He said Pakistan's quick move to seek talks showed the

fear of prolonged escalation. He clarified India didn't seek a long war, recalling the costly experience of Operation Parakram and post-Balakot mobilization. Instead, Operation Sindoor was swift, effective, and showcased India's offensive precision and preparedness.

#### 44 Dead As Flood Situation Remains Grim In Northeastern States

New delhi WUT | June.4

The overall flood situation in Assam and other northeastern states remained grim on Tuesday, as the death count in seven states of the region climbed to 44, officials said. Prime Minister Narendra Modi on Tuesday called the Chief Ministers of Assam and Sikkim, as well as Manipur Governor Ajay Kumar Bhalla, to take stock of the flood situation in the northeastern states and offered all possible assistance in dealing with the flood menace, as

well as relief and rehabilitation efforts.

According to the officials of

different northeastern states, out of 44 deaths during the current spell of rain and floods since May 29, at least 17 people were killed in Assam, followed by 12 in Arunachal Pradesh, six in Meghalaya, five in Mizoram, two in Tripura and one each in Nagaland and Manipur. Disaster management officials of the seven northeastern states, excluding Sikkim, said that the deaths were reported due to drowning, landslides, waterlogging and

other calamity-related mishaps.
In Assam, according to the report of the Assam State Disaster Management Authority (ASDMA), over 6.33 lakh people were affected by the floods and rains in 21 districts. The ASDMA report said that over 14,739 hectares of crop lands were af-

fected in 1506 villages under

In Mizoram, five deaths have been reported in landslides, house collapse and other calamities triggered by heavy rains in the last 10 days. The State's Disaster Management and Rehabilitation department official said that three Myanmar refugees died in Champhai district and one each in Aizawl and Serchhip districts due to the collapse of houses and walls caused by landslides and flash floods. During the past

10 days, the mountainous state reported 552 landslides in several districts, while 152 houses have collapsed or have been damaged due to rain during the same period. Over 300 families have either abandoned their houses due to landslides or house damage, or have been evacuated by the authorities in view of the calamities. Of the total of 11 districts, East Mizoram's Champhai district, which shares a border with Myanmar, is the worstaffected region in the ongoing monsoon with 209 landslides and 10 houses

#### CM Naidu Calls for Protection of Kolleru Lake, to Resolve Land Issues

**Vijayawada** WUT | June. 4

Chief Minister Nara Chandrababu Naidu has stressed the need to protect Kolleru Lake and resolve the land issue with a humane approach. Naidu held a review meeting with the senior officials and public representatives on Kolleru Lake here on Monday. The chief minister called for protection of the environmentally significant lake. Referring to a series of issues pertaining to the lake, like court rulings, regulations, central directives, local conditions and ecological and contour related issues, he noted that nearly three lakh people lived in the Kolleru contour region. "They are facing hardships for several years," he said, and recalled how the then TDP government made significant efforts to resolve those issues. He said that in 2018, the National Board for Wildlife recommended the exclusion of 20,000 acres of jirayat and D-Patta lands from the Kolleru sanctuary and even proposed new boundaries. He pointed out that a recommendation to that effect was sent to the Central Empowered Committee to act accordingly, for which "it then raised certain objections and sought clarifications from the state government."

## PM Modi To Inaugurate Kashmir Rail Project On June 6 Nation

New delhi WUT | June. 4

TIn a landmark event following Operation Sindoor, Prime Minister Narendra Modi will visit Jammu and Kashmir on June 6 to inaugurate the much-awaited Kashmir rail project. The highlight of his visit is the dedication of the world's highest railway bridge—the Chenab Bridge, a key component of the Udhampur-Srinagar-Baramulla Railway Link (USBRL).

The Chenab Bridge, standing at 369 metres—taller than the Eiffel Tower—is built to endure harsh weather, strong winds over 250 km/h, and seismic activity. It is hailed as a proud symbol of India's engineering brilliance and vision. The USBRL, which was first initiated in 1997, faced numerous delays due to diffi-



cult geological and topographical conditions. After several phases of construction, the 272-km railway line is now complete at an estimated cost of over ₹41,000

As part of the ceremony, PM Modi will travel by train from the newly inaugurated section, inspecting another engineering marvel en route—India's first cablestayed railway bridge over Anji Khad. He will also interact with railway engineers, including retired staff

who contributed to this decades-long project. At Katra, the base camp for

Mata Vaishno Devi pilgrims, Modi will flag off two Vande Bharat Express trains—one from Katra to Baramulla and another in the reverse direction—establishing a direct rail connection between Kashmir and the rest of the country. However, passengers will still need to switch trains at Katra for the time being.

The inauguration comes after two postponements—

first due to bad weather on April 19, and later following the April 22 Pahalgam terror attack and Operation Sindoor. The Kashmir Valley now joins the Indian railway map with a modern and robust transport system.

#### "D Gukesh Was Blindly...": Magnus Carlsen's First Reaction After Loss To Indian GM

New delhi WUT | June. 4

A day after his stunning defeat to D Gukesh in Norway Chess, Magnus Carlsen said the reigning world champion's "energy" and "fighting qualities" earned him the triumph and that on a "normal dav" he would have won the contest. Carlsen, 34, lost to 19vear-old Gukesh in Round 6, vented his frustration by banging his fist on the table which threw the pieces in disarray. Disbelief and frustration writ large on his face as he shook hands with Gukesh before placing the pieces back on the board and walked away patting the winner.

"I think, like, I remember being that age myself, and sometimes kind of your energy, like fighting qualities, and just the optimism is sometimes, you know, bigger than the quality of your moves," said Carlsen here on Monday.

But the Norwegian was far more composed after winning the Armageddon tie-break against American World No. 2 Hikaru Nakamura but the effects of Sunday night were still clearly visible on his face. "So, I think, for a long time he (Gukesh) was just more or less blindly pushing. And then, yeah, on a normal day, of course, I win that game, and things

look quite differently," the five-time world champion added. Carlsen, however, praised Gukesh's fighting qualities, saying the Indian was always game for grabbing his chances, which he did despite being in a disadvantageous situation for most part of the Round 6 game.

"What he (Gukesh) does

well, as I alluded to, is he really fights very, very well, and he was there to take his chance, so he deserves credit for that.
"But that's the kind of chance that I really, really have to put away. Otherwise, I have no chance," the Norwegian world No.1 opined. Carlsen also indicated that he just might be having a re-think on playing the Norway Chess next season.

"I think I'll play the last three games (in Norway Chess), and then I will have to make some decisions about next year here or potential other tournaments later, because, yeah... I just don't enjoy (Classical chess) that much," said Carlsen. He also hinted that Classical chess for him might be on its way out.

"It's possible, yeah. I'm not going to sit here and say that I'm not going to play Classical events ever again, but right now it doesn't," said Carlsen, when asked if he was thinking about the possibility of concentrating on Freestyle.

#### Pakistan Dossier Shows India Hit More Targets Than Revealed

New delhi WUT | June.4

Tensions between India and Pakistan remain high following the Pahalgam terror attack and subsequent Indian military action under Operation Sindoor. In a fresh development, Pakistan has named seven additional cities—Peshawar, Attock, Gujrat, Jhang, Bahawalnagar, Hyderabad, and Chhor—allegedly struck by Indian missiles and drones. These names feature in a newly updated dossier released by the Pakistan military on May 19, during the peak of cross-border tensions. The dossier includes maps and claims that India's strikes extended deep into Pakistani territory, including Peshawar, which lies over 1,000 km from the Line of Control. While India maintains that its strikes were limited strictly to military infrastructure, Pakistan alleges civilian areas and even religious sites were targeted. India had earlier confirmed strikes on Nur Khan airbase (Rawalpindi), Muridke, Shorkot (PAF Rafiqui), Sargodha, Rahim Yar Khan, Bholari, Jamshoro, Sukkur, Jacobabad, Muzaffarabad, and Shakargarh, but made no mention of Hyderabad, Chhor,

Gujrat, or Attock. Pakistan also claims that India's long-range missiles briefly crossed into Afghan airspace, a claim strongly denied by both India and the Afghan government. Afghan defence spokesperson Inayatullah Khawarizmi labeled the allegation "baseless". A key accusation in the dossier is that India launched strikes while 57 commercial aircraft, including international flights from Qatar, UAE, China, South Korea, and Thailand, were flying through Pakistani airspace—putting thousands at risk. India has countered that Pakistan deliberately kept its airspace open, possibly to use civilian flights as shields. India has not yet issued an official response to Pakistan's updated claims. Meanwhile, two Pakistani delegations have been dispatched to press their case internationally. One, led by former FM Bilawal Bhutto Zardari, will visit London, New York, Washington DC, and Brussels. Another, headed by PM's aide Syed Tariq Fatemi, is en route to Moscow. The dossier concludes by accusing India of a "dangerous and irresponsible" pattern of behaviour, while calling Pakistan's response "swift, precise, and within international

#### Trump Signs Order To Hike US Steel, Aluminum Tariffs To 50% From Today

The United States will double its tariffs on imported steel and aluminum starting Wednesday, according to the White House, as it published an order signed by President Donald Trump.

The move marks a latest salvo in Trump's trade wars, bringing levies on both metals from 25 percent to 50 percent. But








#### ADIEU VALMIK, THE TIGER'S BEST FRIEND

**Hyderabad** WUT | June. 4

The tiger could not have asked for a better champion than Valmik Thapar, whose passing at the age of 73 on Saturday is being mourned by conservationists and tiger activists. Thapar earned his stripes as a young man in the Ranthambore forest and became one of the foremost wildlife conservation experts. He was an inspiration to countless people who took up the cause of the tiger and the forests of India. Thapar served on several government panels, 150 at last count, including the Central **Empowered Committee** of the Supreme Court on environmental issues.

Although closely associated with Ranthambore, his influence

extended far, as evident in the work that led to the revival of the Tadoba-Andhari tiger reserve in Maharashtra. One not known to mince words, or hold back on his suggestions or opinions, Thapar was one of the strong voices against the introduction of the cheetah in Kuno. Thapar also presented a dissent note to the UPA-era Tiger Task Force report on the disappearance of the big cats from the Sariska tiger reserve, saying it was overly optimistic about the coexistence of tigers and humans.

Thapar was among the early proponents of the engagement of communities around protected areas as partners in conservation. His NGO, Ranthambhore Foundation, has worked with people in about

100 villages around the Ranthambore tiger reserve. He pushed for tougher anti-poaching rules and efforts to protect tiger habitats. Thapar was a supporter of creating an exclusive space for tigers — a minimum area that should be managed in its natural form. For all the time he spent on various committees, Thapar's first love was always the wild, especially Ranthambore. He was the author of several books and presented a number of documentary films. The booming voice, spoken gently, was the one everyone heard when the documentary, The Land of The Tiger, was aired on television many years ago. Today, the land of the tiger is poorer by his passing.

#### Land for Apartments Also Comes Under LRS

ustice T. Vinod Kumar of the Telangana High Court dismissed a writ plea filed Sri Sai Builders and Modi Ventures, real estate developers challenging the levy of about Rs 25 lakh as layout regularisation scheme (LRS) charges. The judge upheld the action of the municipal authorities in demanding the charges under the LRS framework for an apartment project in Mallapur, Kapra of Rangareddy district. The petitioners contended that it initially purchased four acres of land in Survey No.s 93, 94, and 95 and constructed five apartment blocks after securing due approvals. Later, they acquired an adjoining parcel of 1.18 acres in the same survey numbers, intending to build two more apartment blocks. The writ petitioners said that for this new construction, they applied to the municipal authority for permission in April 2008. The authority, via a letter issued on November 25, 2008, demanded payment of ₹55 lakh under various heads, including ₹25.54 lakh specifically under 'Layout Regularisation Scheme charges'. The developers protested the demand, arguing that the LRS charges were only applicable to unauthorised or unapproved layouts where land was divided into individual plots and sold without approvals. Counsel for the petitioner cited government orders and argued that newly acquired land was not plotted or sold as individual units, but intended for group housing. He contended that despite their representation contesting the charge, the municipal authority reiterated its demand through a follow-up letter in January 2009, warning of application closure if the amount was not paid. Faced with this ultimatum and the urgency to proceed with construction, the developers paid the charges and later filed the writ petition seeking refund of the amount with 18 per cent interest, claiming the demand to be arbitrary, illegal, and outside the scope of the GHMC Act, 1955. In a detailed judgment, Justice T. Vinod Kumar analysed the legal framework and clarified that the concept of an "unapproved/illegal layout" under GO Ms. No.902 included any subdivision of land into plots with or without developed infrastructure and without the approval of the competent authority.

## HC reinforces property rights of daughters

**Hyderabad** WUT | june. 3

Justice T. Vinod Kumar and Justice P. Sree Sudha of the Telangana High Court, sitting in vacation bench, reinforced the rights of daughters in ancestral property disputes by allowing civil miscellaneous appeals filed by the eldest daughter which alleged that multiple sale and gift deeds were executed without her consent, in violation of her lawful share. The appeals arose out of interlocutory orders in a partition suit pending before the IX Ad-

ditional District Judge, Rangareddy district at LB Nagar. The appeals were filed by a woman challenging the trial court's refusal to grant interim injunctions sought against her father, sister, and brother-in-law (respondents). The appellant, the elder daughter of the respondents, sought partition and separate possession of ancestral properties, claiming a one-third share for herself, her father, and her sister. The crux of her plea included a prayer to declare multiple property transactions including a registered gift settlement

deed (2007), a development agreement-cum-irrevocable GPA (2016), and subsequent sale and ratification deeds as null and void, alleging they were executed without her consent and in violation of her lawful share. She sought interim injunctions to prevent further alienation or change in the nature of the subject properties. The trial court dismissed her applications, prompting the present appeals. The panel, after examining the nature of the claims, observed that the appellant had raised serious triable issues regarding the validity of the disputed transactions and the status of the properties as joint family assets. The panel held that maintaining the status quo was necessary to prevent irreversible changes pending adjudication. Accordingly, the panel allowed the civil miscellaneous appeals, set aside the trial court's orders, and granted the appellant interim relief by restraining the respondents from alienating or altering the nature of the subject properties until final disposal of the suit.

## Issue show cause notice first: HC

**Hyderabad** WUT | June. 4

In a significant development, the Telangana High Court, while upholding the fundamental principles of natural justice, set aside a demolition notice issued by the Panchayat Secretary of Madnoor in Kamareddy district. The ruling came from Justice J. Sreenivas Rao, who was presiding over the vacation bench of the High Court. The case pertains to a writ petition filed by Gaddamwar Saheb Rao, a resident of Madnoor village, who challenged the demolition notice issued by the local panchayat authorities. The impugned notice had directed the petitioner to demolish the third floor of his residential building within five days. The petitioner approached the High Court, contending that the notice was arbitrary, unlawful, and in gross violation of the Constitutionally guaranteed principles of natural justice. In his petition, Mr. Saheb Rao submitted that he had purchased the plot of land through a registered sale deed in the year 2007. Subsequently, he constructed a residential house on the said land after securing requisite permissions from the local gram panchayat. He further asserted that he had been diligently paying property taxes to the concerned authorities, thereby substantiating

the legality and legitimacy of his ownership and construction. The petitioner further contended that the demolition notice was issued without any prior intimation, show cause notice, or opportunity of being heard. He argued that the actions of the panchayat officials were not only arbitrary and high-handed but also appeared to be motivated by extraneous influences, including local political pressure. The absence of any explanation or inquiry before initiating such an extreme action, the petitioner argued, violated his constitutional rights and principles of fair hearing.On behalf of the respondent authorities, the standing counsel for the panchayat argued that the petitioner had undertaken unauthorized constructions, particularly the third floor, despite being warned orally by the authorities. The counsel further justified the issuance of the notice under the relevant provisions of the Telangana Panchayat Raj Act, claiming that the construction exceeded the approved plans and warranted immediate corrective action. After hearing both parties, Justice J. Sreenivas Rao observed that the authorities had failed to comply with the basic procedural safeguards before issuing the demolition notice. The Court noted that the panchayat authorities had directly issued a demolition order without first serving a show

cause notice or providing the petitioner with an opportunity to explain his position. This omission, the judge observed, amounted to a serious violation of the cardinal principles of natural justice. Consequently, the Court ordered that the demolition notice dated by the Panchayat Secretary be set aside and instead be treated as a show cause notice. The judge granted the petitioner a period of three weeks to file a detailed explanation in response to the notice. In a balanced approach, the Court further directed the Panchayat authorities to consider the petitioner's explanation on merits and pass a reasoned order within six weeks of receiving the response. Importantly, the judge directed the authorities to afford the petitioner a personal hearing during the course of the proceedings to ensure fairness and transparency. Until a final decision is rendered by the panchayat authorities, the High Court restrained the respondents from taking any coercive or demolition-related steps against the petitioner. At the same time, the Court also directed the petitioner not to carry out any further construction on the disputed third floor until the matter is conclusively adjudicated. The judgment serves as a reminder to local bodies and statutory authorities to adhere strictly to due process of law and respect citizens'

# Serial Killer Evades Law for Years Police sources, Ramulu,

**Hyderabad** WUT | june. 4

A typical average-looking middle-aged male construction worker, who regularly frequents toddy shops after his work, has a shockingly demonic criminal background. He is accused of killing 18 women since 2003. He was jailed four times and convicted thrice. Yet he hoodwinks the system to get free and pursue what has become his life goal: Use women and kill them mercilessly. The modus operandi of Miana Ramulu, is simple: Visit a toddy shop and look for a single woman. If he finds one, he befriends her, lures her to a remote place, assaults her sexually and murders her. He burns the face with alcohol to avoid identification.Ramulu has multiple cases of murder pending against him across Hyderabad and has multiple convictions. His first offence — a murder — was in 2003. But he was first arrested in 2006 for the murder of his brother in the Raidurg police limits. After he was released on bail, he was arrested in September 2009 by the Narsingi police. During the interrogation, he confessed to police that he had murdered six other people at Toopran in 2003, Sangareddy Rural in 2005, Dundigal in 2008, Narsapur in 2008, and Kukatpally in 2006

and 2009. According to

Sangareddy district, was married at the age of 21 in 2003 to a woman, who subsequently eloped with another man. After the failed marriage, Ramulu turned psychotic and began to target single women. For a murder that he committed in 2009, Ramulu was arrested and convicted to life imprisonment. Two years after his internment, he scripted a dramatic escape, worthy of a movie sequence. According to sources, he was placed in a separate cell after he started behaving psychotically with his inmates of the prison cell. When he continued to exat Erragadda for treatment, where he put up cember 2011. Sub-

hibit manic behaviour, jail officials shifted him to the Institute of Mental Health with five other patients. He escaped the hospital with all his inmates in Desequently, he killed five more women in the next two years. In 2013, he was again arrested and convicted for a murder. However, after spending five years in prison, he was released in 2018 for "good behaviour". His murder count, which started in 2003, reached 16 in 2019 — or the 11 years that he was out of prison. Ramulu's plot, however, unravelled in 2021, when he committed his 18th murder — of a woman — at Ghatkesar.

tain manner. The bench intervened, stating that the court had not asked the actor to apologise. The counsel for the actor maintained that while the court had not demanded an apology, the Karnataka Film Chambers of Commerce had. "We will discuss the matter with the film body. We will not release the movie 'Thug Life' in Karnataka," the counsel stated. The counsel further added that he had spoken to Kamal Haasan regarding the court's observations on the case that

morning and conveyed them to him. "Kamal Haasan has expressed his respect towards the Kannada language in his letter to the film body. The actor has not issued any statement showing the Kannada language in a poor light. He has not used any inappropriate words regarding the Kannada language. ## Novak Djokovic not a dark horse, says Zverev ahead of clash



or all of Novak Djokovic's titles (100 in all), Grand Slam trophies (24), and weeks at No. 1 (428 — more than anyone else in tennis history), for all of his talent and determination, the guy still can find himself worrying about what is going on with his game. It happened a little more than a month ago, even, when he was coming off three consecutive losses — his second skid of that length in 2025 — and was particularly concerned about being 0-2 on red clay this season as the start of the French Open approached.

So Djokovic decided to enter the Geneva Open — and what do you know? He hasn't lost since, going 8-0 heading into his quarterfinal matchup against No. 3 Alexander Zverev at Roland-Garros on Wednesday. After leaving Geneva with the championship, Djokovic has not only won his first four matches in Paris but has yet to drop a set.

"It happens if you lose a match or two consecutively, and then you don't feel you have enough match play, you start to maybe doubt your game. You don't want to be in that state of mind coming into Grand Slams," the 38-year-old Serb said.

"So I'm just glad it all turned out to be perfect for me, in that sense." He and Zverev, a 28-year-old German, know each other quite well, on a court and off.

This will be their 14th head-to-head contest on tour dating to 2017 — Djokovic holds an 8-5 advantage — and the first since meeting in the semifinals at the Australian Open in January. That one ended after just one set: Djokovic stopped playing because of an injured hamstring, drawing boos from the ticket-buyers, and Zverev defended him. Their only previous encounter in Paris came back in 2019, and Djokovic won their quarterfinal in three sets. When Zverev, who credits Djokovic with serving as something of a mentor, looked ahead to Wednesday, he said: "It's always a privilege to be on court with him." The other quarterfinal Wednesday will be No. 1 Jannik Sinner against unseeded Alexander Bublik, the first man from Kazakhstan to get this far at any Grand Slam tournament.

## RCB Win Maiden IPL Title After 18-Year Wait

Royal Challengers Bengaluru win Indian Premier League title.

In what will be remembered as one of the most emotional nights in IPL history, Royal Challengers Bengaluru (RCB) finally laid their hands on the elusive Indian Premier League trophy, defeating Punjab Kings (PBKS) by a thrilling six-run margin in the 2025 IPL final. The victory ended an 18-year-long wait filled with heartbreaks, near misses, and unrelenting hope from one of the league's most passionate fanbases. Under the floodlights

of a packed stadium and amidst deafening cheers of "Ee Sala Cup Namde," RCB showed steel and resilience in a contest that tested their nerves till the final ball. Despite a modest total of 190/9 on the board, it was their bowling unit that rose to the occasion, holding off a spirited Punjab Kings lineup in a nervewracking finish. Kohli Anchors, But RCB Falter in Middle Overs Sent in to bat first,

Kohli Anchors, But RCB Falter in Middle Overs Sent in to bat first, RCB's innings was a story of starts that never blossomed into big knocks. Virat Kohli, the face of the franchise for over a decade and a half, played the role of anchor with a cautious 43 off 35 balls. While his intent was steady, his innings lacked the acceleration typically expected in a final, managing just three boundaries and striking at a rate of 122.85. The powerplay yielded

55/1, but the middle overs saw RCB slow down drastically, managing only 42 runs between the 6th and 11th overs. Phil Salt's early dismissal after a brisk start derailed momentum, and contributions from Mayank Agarwal (24), Rajat Patidar (26), and Liam Livingstone (25) were promising but short-lived.

Punjab's bowlers, led

by the tall and crafty Kyle Jamieson, kept RCB in check with regular breakthroughs. Jamieson picked up three crucial wickets and used his variations smartly to stifle the run flow. However, a late burst by Jitesh Sharma, who struck 24 off just 10 balls, helped RCB push past the 190-run mark — a total that looked slightly below par on a good batting surface.

Chasing 191 in a final always brings pressure, and RCB's bowlers ensured Punjab felt it early. Josh Hazlewood set the tone with a tight opening spell, including the early dismissal of Priyansh Arya, courtesy of a stunning effort in the deep by Phil Salt. The Englishman sprinted from square leg, held the catch reverse-cupped, and maintained balance as he narrowly avoided the boundary ropes — a moment that electrified the crowd and swung momentum toward RCB.

Punjab Kings stayed in the hunt with contributions from their top and middle order. Josh Inglis struck a quickfire 39 off 23 balls, and Prabhsimran Singh added 26, but Krunal Pandya's spell in the middle overs was pivotal. The left-arm spinner choked the run flow and picked up Inglis with a smart catch at long-on, finishing with miserly figures of 4-0-17-2 in the highpressure contest. Romario Shepherd, too, delivered a crucial blow when he dismissed Punjab captain Shreyas Iyer — who was riding high on a brilliant knock in Qualifier 2 — with a tame edge to the keeper. It was a turning point that drained Punjab's momentum and boosted RCB's belief.

With 44 needed off the final three overs, the match was still in balance. But RCB's experienced campaigners held their nerve. Bhuvneshwar Kumar bowled a match-turning 17th over, dismissing Nehal Wadhera and Marcus Stoinis within three deliveries to snuff out Punjab's hopes. Yet, Shashank Singh, known for his lateorder heroics, kept the chase alive with a blistering unbeaten 61 off just 30 balls, including six towering sixes. As the equation came down to 29 needed from the final over, RCB fans held their breath.

Josh Hazlewood, calm

and composed under pressure, bowled two consecutive dot balls to begin the final over effectively sealing the win for RCB. Despite Shashank's valiant effort, Punjab Kings finished at 184/7, falling agonizingly short. As the final ball was bowled, players in red erupted in joy, fans waved flags and wiped tears, and the longstanding chant of "Ee Sala Cup Namde" finally turned into reality. For RCB, this was more than a trophy — it was redemption. Years of ridicule, near misses in 2009, 2011, and 2016, and the weight of being the perennial underachievers of the IPL

were washed away in one unforgettable night. RCB's victory was not built on individual brilliance alone but a collective effort — from Kohli's anchoring role to Salt's athleticism, Pandya's miserly spell, Hazlewood's calm under fire, and Bhuvneshwar's experience. It was a win stitched together by belief and years of perseverance.

As celebrations erupted across Bengaluru and fans flooded the streets in red and gold, the city — and the franchise — could finally say, with pride and relief: "This time, the cup is ours."



### One Dead, 70 III in Erragadda Institute Food Poisoning Scare

A tragic incident occurred at the Mental Health Institute in Erragadda on Tuesday morning, where a patient identified as Karan was found dead, allegedly due to food poisoning. The incident has triggered alarm, with nearly 70 other patients

developing symptoms like vomiting and stomach pain.

The health scare began on Monday evening when patients started complaining of discomfort. They were initially given symptomatic treatment by the staff. However, the situation escalated by Tuesday morning, prompting urgent medical response.



Two patients in serious condition were shifted to Osmania General Hospital, while others received

treatment at the institute itself.

A medical team and am-

bulances from Osmania were rushed to the spot for emergency care. Health authorities have confirmed that the condition of the remaining patients is stable, and no fresh cases have been reported since 5 PM on Tuesday.

Samples of the food and water have been sent to the Institute of Preventive Medicine for analysis, and an investigation is currently underway to identify the source of contamination. Health Minister Damodar Rajnarsimha has taken cognizance of the incident and is closely monitoring the developments.
