**'PM is Compromised':  
Suspended MPs Protest  
Outside Parliament**

The Lok Sabha was adjourned on Wednesday following heavy sloganising by Opposition members over the suspension of eight opposition MPs during the ongoing Budget Session. The House will resume proceedings at 12 pm. The suspended MPs were seen protesting outside Parliament, holding posters reading "PM is compromised." Leader of Opposition Rahul Gandhi had made similar allegations while speaking to the media on the India-US trade agreement.

The MPs suspended for the remainder of the Budget Session include Congress members Hibi

**War of Words: Rahul Calls Bittu 'Traitor', Minister Retorts 'Desh Ke Dushman'**

Hours after Congress leader Rahul Gandhi hurled a "traitor" barb at Union minister Ravneet Singh Bittu, the BJP on Wednesday kicked up a firestorm over the remark, calling it a "slur on every Sikh", and demanded the Lok Sabha speaker take action against the Leader of Opposition. Reacting to the remark made when Bittu crossed Gandhi's path at the entrance of the new Parliament building, Union minister Hardeep Singh Puri said the Congress leader had crossed all limits of civility.

The BJP fielded its Sikh leaders, including Puri and Delhi minister Manjinder Singh Sisra, to accuse the Congress of harbouring the same "anti-Sikh mentality" that was on display at the height of the anti-Sikh riots of 1984. Sisra said the "real traitor" was the Gandhi family that desecrated the Golden Temple in Amritsar with tanks and guns and burnt Sikhs alive by putting tyres around their necks.



Leader of the Opposition Rahul Gandhi on Wednesday escalated the Congress's attack on the Narendra Modi government over the 2020 India-China border situation, alleging that the Centre was preventing parliamentary debate on national security. Speaking to reporters in the Parliament complex, Gandhi displayed what he said was an unpublished book by former Army chief Manoj Mukund Naravane and accused the government of denying its existence to avoid scrutiny. "The Speaker has said this book does not exist, the government has said it does not exist, and defence minister Rajnath Singh ji has said this book

does not exist," Gandhi said. "I want every youngster in India to see that this book exists." Gandhi alleged that the government was unwilling to allow discussion in Parliament as the memoir could raise questions about the response of the political leadership when Chinese troops were positioned along the Line of Actual Control. He did not cite specific passages but claimed the contents

related to transparency and decision-making during the crisis. Quoting Naravane, Gandhi said the former Army chief had written that he "felt really alone" and was "abandoned by the entire establishment". Referring to the account, he said the Prime Minister's reported message to the Army chief — "Do whatever you deem appropriate" — indicated that responsibility had been

left to the military leadership during a critical moment. Responding to a question, Gandhi said he did not expect Prime Minister Narendra Modi to come to the Lok Sabha, but added that if he did, he would hand over the book to him. He said the Prime Minister should read it so that the country could know "the truth" about the Ladakh standoff.

Backing the allegations, Congress general secretary and MP Priyanka Gandhi said the government was deliberately preventing Rahul Gandhi from speaking in Parliament. She alleged that the ruling establishment feared what the memoir might reveal about the leadership's response when China was "at our

West Bengal Chief Minister Mamata Banerjee on Wednesday vehemently urged the Supreme Court to intervene in the ongoing Special Intensive Revision (SIR) of electoral rolls to "save democracy", alleging the state is being targeted and its people are being bulldozed. The top court took note of Banerjee's petition and rare arguments ever advanced by a serving chief minister before it, and said "genuine persons must remain on the electoral roll".

A bench comprising



Chief Justice Surya Kant and Justices Joymalya Bagchi and Dipak M Pantholi issued notices and sought replies by February 9 from the Election Commission and the chief electoral officer of West Bengal on her petition. "West Bengal is being targeted," Banerjee alleged, asking why the same

yardstick was not applied in Assam. "They are targeting West Bengal to bulldoze its people," said the chief minister, who was permitted by the bench to supplement submissions of her lawyer and senior advocate Shyam Divan. "We are not getting justice anywhere. I have written six letters to the Election Commission," she said, seeking justice from the bench. At the fag end of the hearing, Banerjee conveyed her regards to the bench for the opportunity to argue and urged it to "save democracy".

## Caste Count in Second Phase of Census 2027: Centre

The Union government on Wednesday informed the Rajya Sabha that caste enumeration will be carried out in the second phase of Census 2027 and that questions, including those on caste, will be finalised and notified before the commencement of the Population Enumeration (PE) phase. In a written reply, Minister of State for Home Affairs Nityanand Rai said the Centre's intention to conduct Census 2027 has been formally notified. "Caste enumeration will



procedure before the start of the phase. Rai said several representations seeking caste enumeration had been received from organisations in different states, including Tamil Nadu.

The minister informed the House that the Census is conducted in two phases. In the first phase, the House Listing Operation (HLO), information on housing conditions, assets and amenities of each household is collected. The second phase, Population Enumeration, records demographic, socio-economic and cultural details of every individual.

Women in Iran can now formally obtain a licence to ride a motorcycle, local media reported Wednesday, ending years of legal ambiguity surrounding two-wheelers. The law previously did not explicitly prohibit women from riding motorbikes and scooters, but in practice, authorities refused to issue licences. Due to the legal grey area, women have been held legally responsible for accidents even when victims.

Iran's First Vice President Mohammad Reza Aref signed a resolution on Tuesday aimed at clarifying the traffic code, which was approved by Iran's cabinet in late January, the country's Ilha news agency reported. The resolution obliges traffic police to "provide practical training to female applicants, organise an exam under the direct supervision of the police, and issue motorcycle driver's licences to women", Ilha said.

Iran that were initially sparked by economic grievances but which grew last month into nationwide anti-government demonstrations. Tehran has acknowledged that more than 3,000 deaths occurred during the unrest, insisting that most were members of the security forces and bystanders.

Since Iran's 1979 Islamic revolution, women have faced several societal restrictions, with dress codes posing a challenge for those riding motorcycles.

## Congress Flag To Fly In All Municipalities: CM Revanth

CM highlights welfare measures, targets BRS at public meeting in Gudur

Chief Minister A. Revanth Reddy on Wednesday urged voters to assess the welfare schemes and development programmes implemented by the Congress government before casting their votes in the forthcoming municipal elections. He announced disbursement of Rythu Bharosa of Rs 6,000 per acre to farmers for ongoing Yasangi season soon after the municipal elections. He said Rs 9,000 crore will be disbursed to farmers.

He was addressing a public meeting after laying the foundation stone for a Young India Integrated Residential School at Gudur in Miryalaguda mandal of Nalgonda district. The Chief Minister asked voters, particularly

women, to recall welfare measures such as the supply of fine rice to ration card holders, free electricity up to 200 units for domestic connections, free bus travel for women in TGSRTC services, and the Indiramma housing scheme while standing in polling queues. He said electing opposition candidates in local body elections would not benefit towns, as such representatives would not be in a position to secure development funds from the state government.

Expressing confidence, Revanth Reddy said the Congress flag would fly up to 200 units.



# KT Rama Rao Alleges ₹6,000 Cr Scam by CM Revanth Reddy-Linked Firm

## HYDERABAD

BRS working president KT Rama Rao on Wednesday alleged a massive scam involving contracts worth around Rs 6,000 crore awarded to KLSR Infratech, a company allegedly linked to Chief Minister A Revanth Reddy and currently under insolvency proceedings. He demanded the immediate cancellation of these contracts, blacklisting of the company, and a thorough investigation by central agencies.

Addressing the media at Telangana Bhavan, Rama Rao said the party had consistently exposed irregularities under the

Congress government, including controversies surrounding the Musi River project, Lagacherla lands, AMRUT scheme tenders, Singareni coal allocations, and HILTP land deals. He claimed these revelations triggered retaliatory summonses against BRS leaders in the alleged phone-tapping case.

A deeper investigation by

proceedings were ongoing since 2023, without authorization from the interim resolution professional (IRP).

He alleged that between 2023 and 2025, KLSR received multiple high-value contracts, including the Kodangal-Narayapur Lift Irrigation Project, Young India Schools, AMRUT and Jal Jeevan Mission works, road contracts in Medak and Suryapet, Mission Bhagiratha supplies, and a veterinary college construction in Kodangal.

Rama Rao said, "The Supreme Court has questioned why a bankrupt company was entrusted with Rs 6,000 crore of public funds. If proven, this is not just governance

failure but abuse of power." He urged halting ongoing works, cancelling all contracts, and blacklisting KLSR until the court-ordered probe concludes. He also called for CBI, ED, and SFIO investigations, directly challenging Union minister G Kishan Reddy.

Rama Rao cited government records, IT raids, and company disclosures to allege fund diversions and attempts to influence the legal process. He also released photos showing Revanth Reddy using a luxury vehicle registered to the company before his tenure as Chief Minister, urging him and TPCC president Mahesh Kumar Goud to respond to the charges.

# BJP Fails Telangana, AAP Slams Centre Ahead of National President's Visit

The Aam Aadmi Party (AAP) has accused the BJP of neglecting Telangana and failing to release funds owed to the state. Leaders welcoming the BJP National President, the party says, are trying to hide the Centre's betrayal of Telangana people. State Working President Burra Ramu Goud and leader Pekshan Raj criticized the Centre for withholding funds collected from Telangana, calling it a "clear anti-Telangana stance."

AAP highlighted multiple pending projects and unfulfilled promises: Bayaram steel plant, Kacheguda railway coach factory, Hyderabad

Metro Phase II funding, backward region allocations, regional ring roads, and railway projects. Institutions like IIM and central schools remain absent, while the Palamuru lift irrigation scheme and the Samakka-Saralakka Jathara were denied national recognition. The Adilabad airport and cement factory funding are also stalled.

"Pre-election promises, post-election silence—

this is BJP governance," said AAP. Leaders must answer for these injustices before celebrating the National President, or the gestures will be seen as political theatrics masking betrayal. AAP reaffirmed its commitment to fight for Telangana's rights and ensure justice for its people, stressing that questioning the Centre is their duty and resisting discrimination is their responsibility.

# VISWAM.AI and SFLC.in Launch Draft License to Protect Open Source AI

VISWAM.AI, a joint initiative of Swecha and IIIT Hyderabad, in collaboration with SFLC.in, has released a draft license for public consultation aimed at addressing critical gaps in existing open source licenses for AI, particularly around data usage, attribution, and the definition of openness. The release was announced at the stakeholder roundtable "Understanding Trust and Safety in AI: From Code to Creativity" held at IIIT Hyderabad, organized alongside FOSS United and The Linux Foundation.

Community-driven dataset initiatives, such as VISWAM.AI's Telugu datasets, have gained momentum, yet the lack of appropriate licensing frameworks creates the risk of large corporations

exploiting these datasets without proper attribution or reciprocal contribution. Existing open source licenses, while effective for software code, do not protect training data—the essential fuel for modern AI—from appropriation.

VISWAM.AI and SFLC.in will conduct a series of online and in-person consultations to gather feedback, with the draft license available for discussion here.

Kiran Chandra Yarlagadda, Chief Technologist at VISWAM.AI, noted that existing licenses were created for a pre-AI world and never addressed

whether cultural or community data could be used to train neural networks, and this draft license ensures proprietary models cannot appropriate community work without attribution. Prasanth Sugathan, Legal Director at SFLC.in, emphasized that creators' rights must be protected so that big tech cannot exploit community contributions without acknowledgment. VISWAM.AI focuses on AI for social good, with projects including AI Chandamama Kathalu, Swecha OS, and Gonthuka, a Telugu automatic speech recognition system with 1.5 million voice samples, while SFLC.in works at the intersection of technology law, digital freedom, and public policy, advocating for privacy, civil liberties, and responsible adoption of technology.

# 12,993 Candidates in Fray for Feb 11 Civic Polls After 6,701 Withdraw

At least 12,993 candidates contested 2,996 wards across municipalities and corporations for the February 11 elections. On Tuesday, the final day for withdrawal of nominations, 6,701 aspirants pulled out. However, some candidates were unable to obtain their B-Forms from their respective parties and chose to continue in the fray as independents. The process highlighted both the intense competition and organizational challenges ahead of the civic polls. After the scrutiny of nomination papers, the State Election Commission will finalize symbols for independent candidates, allowing them to officially enter the electoral race. The exercise underscores the scale of participation and the procedural steps necessary before the elections can move forward smoothly.

# Workshop on "AI for Engineers" Empowers CBIT Students

The Department of ECE, CBIT, in collaboration with IETE-ISF, successfully conducted a three-day workshop on "AI for Engineers – Resilience, Innovation and Efficiency using AI" from February 2-4, 2026, under the AICTE-MIC IIC 8.0 initiative. The workshop began with an inaugural session highlighting AI's role in advancing engineering research and innovation. Sessions were led by Ms. Uma Desu, Chief AI Officer, who shared insights on AI's impact on electronics engineering, research workflows, and industrial practices.

Day 1 focused on AI-enabled automation and RPA tools such as UiPath and n8n, demonstrating

industrial applications in electronics and VLSI domains. Around 65 problem statements were provided, and students formed teams to develop AI-based solutions under expert guidance. Day 2 covered AI-driven system development, no-code platforms, prompt engineering, and applied machine learning, equipping participants to transform ideas into functional digital systems while exploring AI certifications and career pathways.

The workshop enhanced students' understanding of emerging AI technologies and prepared them for future research and industry challenges.

## Congress kidnapping BRS candidates out of fear, says Harish Rao

Former Minister T Harish Rao on Wednesday said the Congress party was kidnapping BRS candidates in the municipal elections, alleging that the ruling party had resorted to such tactics out of fear of defeat as public anger against the government continued to grow.

Addressing an election campaign meeting in Medak on Wednesday evening, Rao said voters across Telangana had turned anti-incumbent as the Congress government



failed to fulfil the promises it made during the elections. He asserted that the BRS would return to power within two years and that K Chandrashekhar Rao would once again assume office as Chief Minister.

Rao warned that those who were harassing BRS cadres and leaders after the Congress came to power

would be taught a lesson in due course. Recalling the sacrifices made by K Chandrashekhar Rao for the cause of Telangana, he said Chief Minister A Revanth Reddy was never a match for him, pointing out that while Chandrashekhar Rao resigned from his post multiple times for the Telangana movement, Revanth Reddy had refused to resign even once.

Highlighting the development achieved during the BRS regime, the former minister recalled that Medak received a railway station, a collectorate, an SP office and

several other facilities under the party's rule, which he said reflected the government's commitment for regional development.

Referring to the recent Union Budget presented in Parliament, Rao alleged that BJP leaders failed to secure anything substantial for Telangana despite the party having eight MPs and an equal number of MLAs in the State.

While Telangana received a raw deal in the Budget, he said, the Centre sanctioned multiple projects to the neighbouring Andhra Pradesh.

**War of Words Intensifies in Karimnagar's 42nd Division Ahead of Municipal Polls**



Karimnagar city is witnessing an intense political atmosphere as the municipal election campaign gains momentum. The 42nd Division has emerged as a major political battleground, with sharp verbal exchanges between the Congress and BRS parties. Congress Party Karimnagar Assembly Constituency In-charge Velichala Rajender Rao launched a scathing attack on former Mayor Sunil Rao, accusing him of large-scale corruption during his tenure. Addressing voters in the division, Velichala described Sunil Rao as a "big fraud and corruption whale" and urged the public to defeat him decisively in the elections. Velichala alleged that Sunil Rao amassed hundreds of crores of rupees illegally while serving as Mayor and constructed a highly luxurious bungalow equipped with 22 air conditioners. He questioned how a person who once travelled on a modest scooter could allegedly become the owner of massive wealth within a short span of time. On Wednesday evening, Velichala Rajender Rao inaugurated Congress party offices in several divisions of Karimnagar city, including Ganesh Nagar.

## Minister Vivek Criticises BRS, Urges Congress Victory in Medak Elections

Minister for Employment and Labour and Medak Parliament election in-charge, Vivek Venkataswamy, criticised the BRS and the Kalvakuntla family, accusing them of looting Telangana and plunging the state into massive debt during their decade-long rule.

Speaking to Congress candidates of Medak Municipality, he alleged that the family amassed enormous personal and party wealth, with BRS deposits reportedly at ₹800 crores and electoral bonds worth ₹400 crores received from Megha Krishna Reddy.

Vivek claimed that the BRS neglected the poor, failing to provide promised double-bedroom houses while the Kalvakuntla family constructed luxurious farmhouses on vast land. He also highlighted that the previous government left the state with a debt of ₹8 lakh crores, far exceeding its income of ₹1 lakh crore, and praised the

current Congress administration for beginning to correct the financial imbalance.

The minister emphasised Congress initiatives, including the free bus scheme for women, ration card distribution, pension provision, and supply of fine rice, with an overall expenditure of ₹13,000–23,000 crores for social welfare and women's self-help groups. He also announced a forthcoming scheme providing women ₹2,500 per month.

President's Address later in the day. Samajwadi Party MP Anand Bhaduria came out in defence of Rahul Gandhi, saying that the Leader of Opposition represents the voice of people who voted against the BJP. He accused the ruling party of attempting to silence the Opposition whenever issues related to national security are raised in Parliament.

A day earlier, Rahul Gandhi had stated that he would not quote from any magazine article based on former Army Chief General MM Naravane's unpublished memoir, but would speak briefly about Chinese actions during the Kailash Range standoff. The government main-

tained that he could not refer to an unpublished memoir or related article. The Chair directed Rahul Gandhi to resume his speech on the motion of thanks to the President's Address and adhere to the ruling already given. When the House resumed, BJP member Dilip Saikia, who was in the Chair, named eight opposition members. Parliamentary Affairs Minister Kiren Rijiju then moved a motion to suspend the eight MPs for the remainder of the Budget Session for violating rules and throwing papers on the Chair. The motion was adopted by the House amid protests from Opposition members.

Commenting on the Prime Minister's absence, Congress MP Priyanka Gandhi said he was "scared" and alleged that Union railway minister Ashwini Vaishnaw and Dubey "ran away like a bullet train". Leader of the Opposition Rahul Gandhi said the Prime Minister did not want to face the truth and reiterated the charge in a post on X. ## J&K Parties and Farmers Welcome Centre's Move To Halt Proposed Railway Lines

Political parties, farmer groups, and orchard-dependent communities across Jammu and Kashmir have warmly welcomed the Centre's decision to pause three proposed railway projects in the Valley. The move follows sustained objections from local residents, apple growers, and elected representatives, who warned that large-scale land acquisition would devastate orchards and threaten the livelihoods of thousands of families. Apple orchardist Abdul Razzak Wani, speaking over the phone from Shopian—one of the areas where vast stretches of farmland had been earmarked for acquisition—said the announcement brought immense relief. "All I can say is that we are finally breathing easier. For weeks we lived in anxiety, unsure about our future and that of our children. This decision has lifted a heavy burden from our minds," he said.



Ashwini Vaishnaw explained earlier in the day that although there had been a demand for additional railway lines beyond the existing Srinagar-Baramulla route, concerns raised by the J&K government and Members of Parliament prompted a reconsideration. They argued that the proposed alignments would cut through vast stretches of apple orchards—an economic backbone for south Kashmir. Acknowledging these objections, the Centre decided to place the projects on hold. The announcement comes after months of protests in Pulwama, Shopian, and Anantnag, where residents feared the loss of agricultural land, destruction of orchards, and potential

displacement. Throughout the past several months, villagers, growers, and civil society groups held demonstrations demanding that the government rethink the proposed routes. Many insisted on transparent consultation, fair compensation, and alternative alignments that would not jeopardise Kashmir's horticultural economy. Their message was consistent: development must not come at the cost of fertile land and generational livelihoods. Former chief minister and PDP president Mehbooba Mufti welcomed the Centre's decision, calling it a

much-needed relief for Kashmir's agrarian sector. In a post on 'X', she said, "The decision to put the Pahalgam and Shopian railway lines on hold brings much needed relief to Kashmir's agrarian economy. These projects threatened to destroy scarce fertile land and push over a million rural families into uncertainty. Development that uproots farmers is not progress."

Two others—Govindas Konthoujam of BJP and Kh Loken of National People's Party—were also sworn in as ministers. The ceremony was attended by sev-

eral BJP legislators, senior party functionaries, and top leaders of the NDA in the state. ## Gas Tanker Accident Chokes Mumbai-Pune Expressway

It was a literally nightmare experience to thousands of commuters, who were stuck for more than 24 hours at the Mumbai-Pune Expressway after a CNG tanker overturned in the middle of the road, triggering a massive traffic jam that stretched to almost 25 kilometres. The majority of commuters were left stranded on the Expressway since Tuesday evening, forcing them to spend the whole night in their cars without food and water. Help came only in the afternoon when Police distributed water and food to them.

According to officials, the incident occurred near the Adoshi tunnel in Raigad district at around 5 pm on Tuesday when the tanker, allegedly travelling at high speed, lost control due to the slope near the Adoshi Tunnel on the Mumbai-bound route and overturned. Soon after the accident, gas was found leaking from the tanker, causing panic among motorists. The tanker was carrying propylene gas, which is highly flammable. As soon as the leakage was confirmed, we implemented full emergency protocols," a senior highway police officer said. The chaos left hundreds of vehicles stranded and caused massive congestion on both carriageways. The vehicular movement in both directions came to a complete halt, with passengers—including women and children—deprived of food, water and toilet facilities.

He was part of our government; could he take such a decision without sharing these matters with us? I have no idea what talk he had with Sharad Pawar. As far as

we are concerned, we have no information regarding any such date," the Chief Minister had said earlier.

Responding to the remarks, Mr. Pawar said, "I don't think the Chief Minister has any right to mention me. He was nowhere in the merger discussions. My colleagues, Jayant Patil and Ajit Pawar, were discussing it. There is nothing more to it than that." The former Union minister said this was not the time to engage in political discussions. "Right now is the time to support family members. We are not discussing political issues with anyone," he said.

Earlier in the day, Mr. Pawar held a closed-door meeting with Ajit Pawar's sons, Parth and Jay, at Vidya Pratish-

than, an educational institution in Baramati.

The meeting lasted about one and a half hours. Reports suggested that the discussion revolved around a proposal to build Ajit Pawar's memorial on the Vidya Pratishthan premises.

### GNIT certificate row in HC

Justice N. Tukaramji of the Telangana High Court ordered notice to Guru Nanak Institutions of Technology (GNIT) in a writ petition filed by 35 engineering students questioning withholding of original certificates to compel recovery of fees. The judge was dealing with a writ petition filed by Narayandas Sai Vivek and 34 others. The petitioners pointed out that GNIT unlawfully retained vital academic documents, including SSC and Intermediate certificates, semester-wise marks memos, degree certificates, transfer certificates and bona fide

certificates. It was argued that such retention gravely impaired their ability to pursue higher education, seek employment and appear for competitive examinations. It was further contended that the action of the institution was in clear violation of the UGC Regulations, 2018, as well as relevant circulars issued by AICTE and JNTU Hyderabad. Emphasising that the students have been made to suffer for a prolonged period, counsel for the petitioners Narayandas Sai Vivek sought immediate release of the original certificates. The judge, after hearing preliminary submissions, ordered notice and posted the matter for further

### HC rejects custody habeas petition

A two-judge panel of the Telangana High Court comprising Justice Mousumi Bhattacharya and Justice Gadi Praveen Kumar dismissed a habeas corpus plea filed by a father seeking production and custody of his minor son. The panel was dealing with a plea filed by Abdul Raheem Uddin, who alleged that the mother was illegally detaining his eight-year-old son, Sheikh Tamim Uddin Thani, denying access and communication, and disobeying a visitation order passed in his favour by

the Family Court. He contended that such continued withholding of custody amounted to unlawful detention warranting habeas corpus relief. On the contrary, the state argued that the petitioner was, in effect, seeking implementation of a Family Court order through a writ of habeas corpus, which was impermissible. He further contended that the petitioner had not even approached the concerned police authorities with a complaint, and that disputed custody issues could not be agitated in a habeas corpus petition before a constitutional court.

Stocks worth about ₹4 lakh were seized during a raid conducted on February 3, 2026. Acting on credible information, DCA officials, along with officers from the Central Drugs Standard Control Organisation (CDSCO), carried out a surprise in-

spection and detected the illegal manufacture and distribution of a medical device named Patient Monitor (EYVA – Electronic Medical Device), claimed to be used for monitoring human vital parameters.

Officials found large quantities of the monitors manufactured and stocked for sale without a valid licence. User manuals and sale invoices were also seized. According to the DCA, medical devices falling under Risk Class A (sterile and measuring) and Risk Class B categories mandatorily require a manufacturing licence in

under the Fifth Schedule of the Medical Devices Rules, 2017. Products must also meet prescribed standards under the rules. The DCA warned that medical devices manufactured without a licence may not meet quality standards and could pose serious risks to public health. Manufacturing without the required licence is a punishable offence under the Drugs and Cosmetics Act, carrying imprisonment of up to five years. Officials said further investigation is underway and strict legal action will be taken against all those involved in the illegal activity.

Form MD-5, issued by the Drugs Control Administration. The seized product is classified as a medical device under the Drugs and Cosmetics Act, 1940, and the Medical Devices Rules, 2017. Authorities stressed that such devices must be manufactured only under a valid licence and in strict compliance with Quality Management System requirements prescribed

### Plea claims GHMC inaction

Justice Nagesh Bheemappa of the Telangana High Court admitted a writ petition filed by Maheshwara Medical College and Hospital, Patancheru challenging the rejection of its request for full enhancement of postgraduate (MD/MS) seats for the academic year 2025-26. The judge was dealing with a writ plea challenging the action of the ministry of health and family welfare (MoHFW) rejecting its second appeal under the National Medical Commission (NMC) Act, thereby upholding the decision of the Medical Assessment and Rating Board (MARB). It was contended that while MARB denied full enhancement of seats on the

ground of alleged "inflated clinical data," it simultaneously granted a partial increase. The college contended that the same clinical and faculty data relied upon to grant partial approval was rejected to deny full statutory entitlement, rendering the impugned order internally inconsistent and in violation of constitutional guarantees. The institution further contended that it has no deficiencies in infrastructure or faculty and operates a hospital with over 905 beds, maintains faculty attendance exceeding 95 per cent, duly verified through the Aadhaar Enabled Biometric Attendance System (AEBAS). It further argued that under prevailing PG regulations, seat entitlement is primarily determined by faculty strength.

### Telugu Varsity Staff Regularisation Under Review

Senior IAS Officer Yogitha Rana on Wednesday personally assured the High Court that regularisation of staff of the Telugu University is under active consideration. The senior IAS officer was present in court in a contempt case alleging that the authorities had wilfully failed to regularise the services of a class of employees despite directions to do so by the High Court. The panel comprising Chief Justice Aparna Singh and Justice G.M. Mohiuddin was dealing with a contempt case initiated by office subordinates of Potti Seeramulu Telugu



University alleging wilful disobedience of its order passed in 2020. The petitioners alleged that five years have elapsed since the order was passed directing them to regularise the services of the petitioners on a one-time basis from the date each of them completed 10 years of service on daily wages, without entitlement to monetary arrears. ### WILL 15% INCREASE IN DEFENCE BUDGET GIVE INDIA MORE BANG FOR THE BUCK?

Never before since the end of the Second World War has the world been so badly fractured as now, especially since Donald Trump's return to the White House in January 2025. That he, holding the most powerful office in the world, who should have been seriously working to uphold the global rules-based order, is doing just the opposite, has left most nations, including most long-term US allies, seriously worried. It is needless to say that some of his policies also impact India, in more ways than one, including in strategic matters.

Overall, as the strategic and security environment worsens the world over, including in South Asia, India needs to factor in its security calculus the manifold existing challenges and the newer ones emerging. Our own Operation Sindoor involvement

highlighted the nuances of a fragile and hostile geopolitical environment in our neighbourhood and the critical imperative of being operationally ready and better militarily prepared against our own adversaries at all times.

Unquestionably, adequate resources thus have to be allocated for ensuring security preparedness -- but are we doing it? India's finance minister, Nirmala Sitharaman, in her record ninth consecutive Budget presentation, and the Narendra Modi government's 13th Budget in the Lok Sabha on February 1, has allocated Rs 7.85 lakh crores for the defence budget in FY 2026-2027 -- a satisfying 15 per cent jump from last year's defence budget and which is two per cent of India's GDP. Last year's allocation was Rs 6.58 lakh crores for the defence ministry, which was around just 1.9 per cent of GDP. It may be noted that India's defence spending

## Amazon, IIT Roorkee Partner to Develop Packaging from Agricultural Waste

### CHENNAI

Amazon India today announced a collaboration with the Indian Institute of Technology (IIT) Roorkee to develop innovative packaging materials from agricultural waste. This project aims to create non-wood paper technology that diverts agricultural waste from burning while reducing pressure on virgin wood pulp. These lightweight yet strong packaging materials offer recyclable and home-compostable alternatives to traditional wood pulp paper or plastic bags.

The research will focus on converting crop residues such as wheat straw



and bagasse into high-quality pulp for paper mailers with performance comparable to conventional paper packaging. This helps reduce stubble burning in India by turning agricultural waste into valuable packaging material. It also reduces dependency on imported virgin wood pulp and could create additional income for farmers by providing a market for agricultural residues. The collaboration with

IIT Roorkee's Department of Paper and Packaging Technology will begin with lab-scale development and testing over a 15-month period. Subject to successful performance tests, Amazon will provide support to progress to industrial trials, process validation, and commercial production by mid to late next year. Abhinav Singh, Vice President of Operations at Amazon India said "At Amazon, we are building and man-

aging India's fastest, safest, and most reliable operations network, and we're committed to making it more sustainable. As part of this effort, we're partnering with IIT Roorkee to develop innovative packaging from crop residue. India generates nearly 500 million tons of this waste annually, and by repurposing it into packaging, we can support a more circular economy while reducing reliance on conventional materials."

Prof. Kamal Kishore Pant, Director IIT Roorkee said, "Sustainability is no longer a choice, it is an urgent national priority. This collaboration between IIT Roorkee and Amazon is a step towards

## Nvidia's Huang Dismisses Fears AI Will Replace Software Tools As Stock Selloff Deepens

Nvidia CEO Jensen Huang dismissed fears that artificial intelligence will replace software and related tools, calling the idea "illogical", after a significant selloff in global software stocks on Tuesday. The selloff, partly sparked by AI developer Anthropic's updated chatbot release last week that heightened fears of AI-driven disruption in the data and professional services industry, broadened on Wednesday, hitting software stocks in India, Japan and China.

Speaking at an artificial intelligence conference in San Francisco hosted by Cisco Systems Huang said



worries that AI will make software companies less relevant are misguided and AI will continue to rely on existing software rather than rebuild basic tools from scratch. "There's this notion that the tool in the software industry is in decline, and will be replaced by AI ... It is the most illogical thing in the world, and time will prove itself," Huang said. "If you were a human or robot, artificial, general

robotics, would you use tools or reinvent tools? The answer, obviously, is to use tools ... That's why the latest breakthroughs in AI are about tool use, because the tools are designed to be explicit." Shares of Indian IT exporters slumped 6.3% on Wednesday, tracking losses in global software stocks. Tech services firm Infosys was among the biggest losers, plunging 7.3%. China's CSI Software Services Index also fell 3%, while in Hong Kong, shares of software company Kingdee International Software Group tumbled more than 13%. In Japan, staffing agency Recruit Holdings and Nomura Research tumbled 9% and 8%, respectively.

## Anthropic's AI Plug-ins Shake India's IT Sector; Stocks Dive 6%

Indian IT stocks came under sharp selling pressure on Friday after US-based AI firm Anthropic launched new artificial intelligence software, sparking concerns over its potential impact on service-led technology jobs. The sell-off reflected growing investor unease that rapid advances in generative AI could disrupt traditional outsourcing and IT services models that Indian companies rely on.

Anthropic, best known for its Claude chatbot, announced the release of 11 open-source plugins for its Claude Cowork tool on January 30. The new offering is designed to automate and streamline a range of workplace tasks, intensifying fears that AI-driven platforms could replace or significantly reduce demand for



human-led IT and business process services. Following the announcement, the NSE IT index plunged more than 7 per cent during intraday trade and was down close to 6 per cent around 2 pm IST. All constituents of the index traded in the red, registering losses ranging between 3.84 per cent and 7.29 per cent. Heavy-weight IT stocks bore the brunt of the sell-off, with Tata Consultancy Services falling 6.95 per cent and Infosys declining 7.29 per cent. Wipro slipped 4.09 per cent, while HCL Technologies lost 4.86 per cent. Mid-tier players such as LTI Mindtree and

Cofoage also witnessed sharp declines of 5.93 per cent and 6.55 per cent, respectively. The weakness in Indian IT stocks mirrored a broader downturn in global technology markets. The Nasdaq Composite index dropped 1.43 per cent in overnight trade as investors turned cautious ahead of key earnings announcements from major AI-focused companies. Leading US tech stocks also ended lower, with Nvidia falling 2.84 per cent, Adobe sliding 7.31 per cent, Meta Platforms declining 2.08 per cent, Microsoft shedding 2.87 per cent and Amazon losing 1.79 per cent. Market participants said the sharp reaction underscores rising sensitivity to AI-related developments, as investors reassess long-term growth prospects and business models across the global IT and technology services sector.

## RBI's Gold Purchases Drops to 4 Tonnes in 2025 From 73 Tonnes in 2024

With gold prices rocketing in 2025, the Reserve Bank of India bought just 4 tonnes of gold in 2025, against 73 tonnes in 2024. Globally, the net purchases of central banks were reported to be 328 tonnes in 2025, a tad lower than the net purchases in 2025. RBI bought just 4 tonnes in 2025 and of this, 3.4 tonnes was purchased in the first quarter, 0.4 tonnes in the second quarter, 0.2 tonnes in the third quarter and zero tonnes in the fourth quarter, as per the data of World Gold Council. In 2024, RBI had purchased 73 tonnes and 16 tonnes were bought in 2023. In 2021, it had purchased 77 tonnes. Globally, central banks bought 19 tonnes of gold in December, taking



net purchases for the full year of 2025 to 328 tonnes. This is lower than the 345 tonnes of net purchases recorded in 2024. The National Bank of Poland was the largest reported net buyer in 2025, adding 102 tonnes to its gold reserves. Kazakhstan 57 tonnes, State Oil Fund of the Republic of Azerbaijan (SOFAZ) 53 tonnes, Brazil 43 tonnes, China 27 tonnes and Turkey 27 tonnes were the other significant buyers during the year. The largest net sellers for 2025 were Singapore 26 tonnes, Ghana 12 tonnes and Russia 6 tonnes.

## Desi, Wonder Hot Chillies Fetch Record Prices

Chilli prices registered a sharp rise this week at the Enumamula Agricultural Market Yard in Warangal, bringing relief to farmers after years of low returns. The indigenous 'Desi' variety touched a three-year high of Rs 41,200 per quintal on Tuesday, while 'Yellow Chilli' fetched up to Rs 44,000 per quintal. Market officials said such rates had not been recorded in the last three to four years. The highest price for the Desi variety was secured by a farmer from Kurnool district, who brought around six quintals of premium-quality produce to the market. Traders engaged in competitive bidding, citing superior colour, pungency and overall quality. Officials attributed the price surge to strong export demand



and reduced cultivation in major chilli-growing states such as Madhya Pradesh. Other varieties also saw gains. The 'Wonder Hot' variety rose by about Rs 5,000 in a single day to reach Rs 37,100 per quintal on Wednesday. The record price was realised by farmer R. Vinod from Neelampalli village in Palimela mandal of Jayashankar Bhupalpally district, through the Keerthana Adithi commission agency. Market officials said prices had remained

## Paytm Q3 FY26 PAT Rises to ₹225 Crore

Paytm (One 97 Communications Limited) reported its third straight profitable quarter in Q3 FY26, posting a profit after tax (PAT) of ₹225 crore, marking a year-on-year improvement of ₹433 crore. Operating revenue for the December 2025 quarter rose 20% YoY to ₹2,194 crore, driven by strong monetisation across payments and financial services, higher GMV, and growth in merchant subscriptions. EBITDA improved to ₹156 crore with a margin of 7%, reflecting a ₹379 crore YoY improvement due to operating leverage and revenue growth. Contribution profit increased 30% YoY to ₹1,249 crore, with con-



tribution margin expanding to 57%. Paytm continued to gain UPI market share for the third consecutive quarter. Consumer UPI GMV grew 35% over the last nine months, more than double the industry growth of 16%. Overall payments GMV rose 24% YoY to ₹6.2 lakh crore, while net payment revenue increased 25% to ₹613 crore. Merchant subscriptions grew by 27 lakh YoY to reach 1.44 crore. Payments services revenue grew 21% YoY to ₹1,284 crore. Distribution of financial services

revenue rose 34% YoY to ₹672 crore, supported by growth in merchant loans and wealth products, despite lower volumes under the Default Loss Guarantee programme. Indirect expenses declined 8% YoY to ₹1,092 crore, aided by lower employee costs and reduced provisions for doubtful debts. Cash balance stood at ₹12,882 crore at the end of December 2025. During the quarter, Paytm transferred its offline merchant business to Payments Services Limited (PPSL), a wholly owned subsidiary. PPSL received RBI approval to operate as an online, offline, and cross-border payment aggregator, and resumed onboarding of online merchants.

## Manoj Bajpayee's 'Ghooskhor Pandat' Sparks Outrage Over Casteism Title

The first look of Manoj Bajpayee, starrer Netflix film 'Ghooskhor Pandat' was released on 3rd February 2025. Despite the release date still being unannounced, the film has already triggered public outrage over its title. Based on the first-look teaser, the film appears to be a crime thriller in which Manoj Bajpayee plays a corrupt cop who gets a chance at redemption through a specific case. Despite not even being released yet, the film and its title have received immense backlash and are being accused of normalizing hatred and even caste discrimination.

The title has become the center of the controversy. On social media, the film announcement received severe criticism. On X, Sha-shank Shekhar Jha, a Supreme Court lawyer and political commentator, said, "Hello @NetflixIndia, normalisation of hatred against Pandits & Brahmins won't



be tolerated. I'll see you in Court." Reportedly, a case has been filed against the film. Famous political commentator Mr. Sinha also commented on X, saying, "Ghuskhor Pandat? What kind of title is this? Would it be acceptable if a movie or series were made with a similar 'Ghuskhor Mohamedan' title? This is not freedom of speech. This is bigotry driven by an agenda. Such content should not be allowed to release." These

reactions reflect the mass outrage and backlash the film has received. Following the controversy, several social media users criticized Netflix's decision to use 'Pandat' in the title. 'Ghooskhor Pandat' literally means 'Corrupt Priest.' Many users interpreted this as an attack on Brahmins and their identity. Others pointed out how, historically, Indian cinema has often stereotyped Brahmins and priestly characters as cun-

ning and selfish. A social media page called 'Gems of Bollywood' claimed it has formally filed a complaint against the film, alleging that the title is extremely offensive and casteist. The page also stated that the film attempts to vilify an entire social group in India. Another user added, "Funny how corruption has now become a religious caricature when it's convenient. 'Ghooskhor Pandat' isn't accidental. If corruption was the point, the title could have been Officer, Babu, or Netaji. But Bollywood's old habit remains—demonise Brahmins and dress it up as 'art'. Netflix India, you know exactly what you are doing, and this won't be tolerated anymore." Overall, this backlash highlights how deeply divided and segregated our society remains, where even a movie title announcement and the portrayal of fictional characters can become the center of intense controversy.

## 'Peddi' Delayed, Revamp in Progress

It's a very thin line," Dhoni told sports broadcaster Jatin Sapru during a YouTube interaction. "Often, you don't even feel that what you are doing is may be borderline wrong. You would always like to be on the other side where you are describing the game. If

## Do All Films Need 2 Parts?

It makes business sense," says filmmaker Hansal Mehta. "Who are we to decide? The audience decides. Money and the system follow suit." But what happens when the audience doesn't follow? The split-film strategy recently backfired with Anurag Kashyap's Nishanchi. When Part 1 failed at the box office, Part 2 was quietly pushed to OTT. In hindsight, Kashyap admits the split was a mistake. "The audience wanted the entire story at one go."

This raises a crucial concern: unlike epics such as the Ramayana, where chapters are clearly defined, films like Nishanchi or Dhurandhar or the Telugu film Akhanda 2... ask audiences to return to the same characters, doing the same things, after a long break.

### Marketing gimmick

Writer-director Manish Gupta is blunt. "Multi-part cinema today is a marketing gimmick to multiply ticket sales. It has little to do with storytelling. That said, films like Ramayana genuinely demand multiple parts be-



cause of their sheer scale." Echoing this caution, writer-director Kishore Belekar, whose silent stand-alone film Gandhi Talks recently released, says: "Splitting a film only works if the story truly requires that expansion. Otherwise, commerce dictates form — and when that happens, cinema loses its soul."

**When the story demands scale**

Baahubali producer Shobu Yarlagadda supports the format — but with conditions. "If the story demands it, as it did with Baahubali, it makes perfect sense. But if a film is deliberately stretched to create multiple parts, audiences sense the manipulation, and it sabotages the experience." Director Suparn Verma says: "Sequels and world-buildings began gaining ground

about a decade ago in India, though the West has done this for decades — from The Godfather to Lord of the Rings and Harry Potter."

He attributes audience acceptance to streaming culture. "Viewers today are comfortable with long-form storytelling. With Dhurandhar, the script itself was massive. During shooting, it became clear the story couldn't be compressed without loss." As for Animal, Verma believes Vanga is deliberately building a cinematic universe. "He finished one arc, teased another, and plans to continue. It's a new, expansive way of storytelling, creating richer characters and worlds."

### Up to the audience

Trade analyst Taran Adarsh says, "From both creative and commercial perspectives, splitting a film allows deeper storytelling without rushing emotions or plot. Big-scale narratives today are layered, and audiences are willing to invest time if the content is strong." He adds: "When storytelling justifies it, more parts simply mean more of a good thing."

## Rhea Chakraborty Makes a Comeback



## Hyderabad man sentenced to life for sexually assaulting 12-yr-old daughter

A court in Hyderabad on Tuesday, February 3, sentenced a man to rigorous imprisonment for sexually assaulting his 12-year-old daughter. On Tuesday, the courts in the city convicted four other men in separate cases of sexual offenses against minor girls following investigations by the Women Safety Wing of the Hyderabad police.

The convictions were delivered by Sessions Courts and Fast Track Special Courts in cases registered at Begumpet, Banjara Hills, Bhavani Nagar and SR Nagar police stations. In another case, a neighbour who assaulted a nine-year-old girl was awarded 25 years of rigorous imprisonment. Another accused received a 20-year sentence for luring and sexually assaulting an eight-year-old child. Two other cases involving sexual assault and an attempt to rape minor girls aged four and eight resulted in five years of rigorous imprisonment each. The courts also imposed fines and ordered victim compensation ranging from Rs 2 lakh to Rs 5 lakh under victim compensation schemes.

## TGHR seeks report after Telangana govt school students made to sweep floors

The Telangana Human Rights Commission here has directed the Principal Secretary, School Education Department and the District Educational Officer (DEO), Hyderabad, to submit reports on the disciplinary action against responsible officials who allegedly have been making students in various government schools to sweep, dispose garbage and perform other menial tasks.

The reports were sought by TGHR member Sivadi Praveena, who took Suo Motu cognizance based on a news report published in the Telugu daily Namasthe Telangana, which stated that school officials have been allegedly making children do the physical and labour intensive work in violation of rules and due to non-availability of sweepers.

According to a statement from the TGHR, the Principal Secretary and DEO have been asked to submit "detailed, factual and action-taken reports on the availability of sweepers, preventive measures, disciplinary action against responsible officials, and steps to ensure strict compliance with child protection laws, and has posted the matter for reports."

The matter will be next heard on February 24. According to the TGHR, the students have also allegedly met with "instances of threats and physical punishment for refusal", which it said amounts to serious violations of child rights and statutory protections under the Right to Education Act, 2009, and the Juvenile Justice (Care and Protection of Children) Act, 2015.

## Hyderabad IT professional files complaint over 16-hour workdays

An IT professional has approached the Telangana labour department alleging that a major multinational company forced him to work extended hours for years without paying overtime. The complaint comes at a time when the debate on ideal working hours in India has intensified following calls by industry leaders for longer work weeks. According to a report published in TOI, the complainant, Sridhar Merugu, said he was made to work intermittently for more than 16 hours a day during his 14-year tenure with the firm.

He has demanded compensation for the additional hours he worked. He stated that it is unreasonable to expect employees to put in such long shifts without adequate pay. Sridhar also moved the National Human Rights Commission, claiming that the company ignored labour laws and refused to release overtime wages.

According to him, the situation became worse when he fell ill but was still asked to continue working. He further alleged that the company denied late-night and early-morning shift allowances and continued to push him due to staff shortages. Sridhar said he raised the issue after being forced to work continuously for over 16 hours a day for three to four months. When his grievances were not addressed, he was allegedly terminated in September 2025, which he believes was linked to his refusal to continue under what he described as unlawful working conditions.

The 45-year-old professional has urged the government department to direct the US-based company to clear his pending overtime dues along with statutory interest and penalties. The report also mentioned other IT professionals from Hyderabad claiming that they are working beyond the standard 40-hour work week. Many employees reportedly avoid claiming overtime despite it being their legal right. Santosh Kumar, an IT professional with nearly three decades.

## Eagle Force Nets 75 NDPS Fugitives

Eagle force, Telangana, has launched a special statewide drive to tackle the pendency of absconding accused in cases registered under the NDPS Act. Across the state, 3,228 absconding/wanted/NBWs accused have been identified in NDPS cases, of whom 1,278 belong to Telangana, underscoring the scale of the challenge, said Sandeep Shandilya, director, Eagle force. "Our special drive commenced on January 29, 2026.

Within just four days, Eagle force teams successfully apprehended 75 absconding accused, who were handed over to concerned police stations. Detailed interrogation reports were prepared, and urine tests were conducted transparently in the presence of family members," Shandilya said.

He added that 38 of the 75 persons tested were found negative, reflecting the positive impact of timely intervention and highlighting the importance of sustained monitoring, counselling and rehabilitation. The drive will continue throughout February.

"This initiative reflects the firm resolve of Telangana police to strictly enforce the NDPS Act and dismantle drug networks. At the same time, emphasis is being placed on re-integration and rehabilitation, with a vision to comprehensively resolve the issue within the next two to three years through sustained efforts," Shandilya said. Recognising that tackling the drug menace requires a multi-pronged strategy, Telangana police is giving equal importance to demand reduction alongside supply-side enforcement.

According to police officials, Swapna had visited her family's agricultural land on Wednesday morning to attend a panchayat convened to resolve the dispute. While she was returning from the site, her brother, along with others, allegedly attacked her with an axe. Local residents who noticed her lying injured rushed her to a nearby hospital, where doctors declared her dead on arrival.

Swapna's mother, Venkataamma, alleged that her son had been plotting to kill Swapna for the past three years and had made at least two previous attempts on her life. She further claimed that following a land survey earlier in the day, three individuals attacked Swapna using sticks and knives, contradicting the initial version that only an axe was used.

Angered by the killing and the alleged police inaction, lawyers gathered at the Moinabad Police Station, accusing the police of refusing to accept their complaint and of threatening them to vacate the premises. The protesters staged a dharna for several hours, demanding the suspension of Moinabad Sub-Inspector Narsimha Rao for alleged mishandling of the case.

The sit-in protest led to severe traffic congestion in and around the police station as lawyers raised slogans demanding justice for their slain colleague. Following intervention by senior police officials, the protesters were pacified and a case was eventually registered. Police said that special teams have been formed to trace and arrest the accused, who fled the scene after the attack. Sub-Inspector Narsimha Rao did not respond to requests for comment regarding the allegations made by the protesting lawyers.

A seasoned politician, Quadri served as a Greater Hyderabad Municipal Corporation (GHMC) corporator from 1986 to 1991. He was elected as an MLA for four consecutive terms, winning the Charminar constituency three times since 2004 and later representing Yakutpura in 2018.
