### HC Upholds TGPSC Gr-1 Recruitment

The Telangana High Court on Thursday confirmed its interim directions of September 25 last, setting aside a single judge's directions and permitting the Telangana Public Service Commission (TGPSC) Group-I to complete the recruitment of selected candidates. These candidates had been given their appointment letters after the interim order, subject to the court's final order. Thursday's judgment comes as a relief to these candidates.

A division bench comprising Chief Justice Apareesh Kumar Singh and Justice G.M. Mohiuddin pronounced the judgment while disposing of a batch of writ appeals preferred by the commission and

### ECI To Announce Schedule For Polls in Assam, WB, TN, Puducherry, Kerala In March

The Election Commission of India (ECI) on Thursday briefed central observers to be deployed for forthcoming Assembly Elections in five states. The ECI is expected to announce the schedule of elections for Assam, Kerala, Puducherry, Tamil Nadu and West Bengal in March. The ECI will be deploying 1,444 officers, including 714 general observers, 233 Police Observers and 497 Expenditure Observers in these states. Briefing the observers ahead of the polls, Chief Election Commissioner (CEC) Gyanesh Kumar said they should ensure free, fair and transparent elections and that their presence will energise the entire election machinery across 824 constituencies where elections are going to be held. Election Commissioner Dr. Vivek Joshi instructed that Voter Information Slips (VIS) should be distributed well in time to the

## Rs.17K Cr Push for Urban Growth

**No town will be left behind in development, Says CM Revanth Reddy**



and sewerage systems.

Since coming to power in December 2023, Chief Minister A. Revanth Reddy, who also oversees the municipal administration department, has introduced several key reforms aimed at improving ease of administration, ensuring uniform development of towns, enhancing civic services, and strengthening monitoring mechanisms. With a long-term vision to develop cities and towns on the lines of Hyderabad, the Chief Minister personally initiated

the preparation of future-oriented urban development plans, sources said.

Officials noted that during the previous BRS government, delays in releasing the State's share of funds had stalled several development projects. However, under the present Congress government, timely release of funds has enabled long-pending works to commence at the ground level.

Under the Special Assistance to States for Capital Investment (SASI)

scheme, Telangana completed the required reforms, making it eligible for ₹1,698 crore as reform-linked assistance. Of the total allocation over two years, ₹9,387.11 crore was released from the Urban

Infrastructure Development Fund for 2,374 works in 130 municipalities. Under the Telangana Urban Finance and Infrastructure Development Authority (TUFIDCO) scheme, ₹1,896.96 crore was sanctioned for 1,166 works in 85 municipalities. Transfer of funds amounting to ₹462.19 crore were released to 110 municipalities.

Additionally, ₹462.19 crore was allocated under the Swachh Bharat Mission for 347 works, while ₹4,729.69 crore was released under the AMRUT scheme for 107 works across 109 municipalities.



**My govt focused on Viksit Bharat, not division, Says PM Modi**

Prime Minister Narendra Modi on Thursday launched a strong attack on the Congress and other Opposition parties in the Rajya Sabha, accusing them of weakening constitutional institutions, undermining national unity and harming India's global image for political gain. Replying to the Motion of Thanks on the President's Address, Modi said his government remained focused on building a "Viksit Bharat" through reform, performance and transformation.

The Prime Minister sharply criticised the Congress leadership and Leader of Opposition Rahul Gandhi over remarks made against BJP MP Ravneet Singh Bittu. Referring to an incident

## India Rejects Claim It Will Halt Russian Oil Imports

Amid US President Donald Trump's claim that India has agreed to halt purchases of Russian oil, the Ministry of External Affairs on Thursday reiterated that ensuring energy security for its 1.4 billion people remains the top priority for the Government of India, especially amid evolving global energy dynamics. Addressing a press conference in the national capital, MEA spokesperson Randhir Jaiswal said India's energy decisions are guided by national interest.

"In so far as India's energy security or sourcing is concerned, the government has publicly on several occasions, including me here, stated that ensuring the energy secu-

rity of 1.4 billion is the supreme priority of the government," Jaiswal said. He further outlined the government's strategy, adding, "Diversifying our energy sourcing in keeping with objective market conditions and evolving international dynamics is at the core of our strategy to ensure this. All of India's decisions are taken and will be taken with this in mind.

"Trump made the remarks following the announcement of the India-US trade deal, claiming that New Delhi would stop buying Russian oil and shift toward increased purchases from the United States and Venezuela. "We spoke about many this including Trade, and ending the War with Russia and Ukraine are guided by national interest.



## 'No Guarantees, Only Scams' Harish Rao Releases Congress Scam Calendar

Escalating its attack on the Congress government, the BRS Legislature Party (BRLSP) deputy leader T. Harish Rao on Wednesday released a poster titled 'Congress Scam Calendar', alleging widespread corruption under the Revanth Reddy-led regime.

The calendar-style poster lists month-wise alleged irregularities, claiming that scams have marked every month of the year. According to BRS, the allegations span multiple departments and sectors, including Civil Supplies, NTPC fly ash management, RTC contracts, AMRUT works,



is. Addressing the media, Harish Rao said the calendar reflects what he described as the systematic collapse of governance in Telangana under the Congress government. He alleged that the State government has turned every department into a centre of corruption, with public money being misused.

He further claimed that welfare initiatives and development activities have taken a back seat due to alleged corruption. Taking a dig at the ruling party, Harish Rao said the Congress had promised a job calendar during elections but had instead delivered a scam calendar.

## Telangana Set for a Final Winter Chill

A final spell of winter chill was settling across Telangana on Thursday, with the minimum temperature expected to dip further over three days due to dry northerly winds dominate sweeping over the state. Day temperatures would rise slightly from Thursday due to increased solar heating and lack of cloud cover. IMD scientists told. No cold wave warnings have been issued so far, with most districts remaining under the watch category, early morning and late night hours as the season's last cold spell plays out over the coming days. Weather officials indicate

that hazy conditions seen in recent days are expected to clear completely, leading to crystal clear skies and dry weather. According to the TGDPS, night temperatures slid into the low teens in several districts. In north and west Telangana, the minimum temperature was expected to hover between 12°C and 14°C, while Hyderabad was likely to see 14°C to 16°C during the same period. In the GHMC limits, the minimum temperature recorded over the last 24 hours ranged from 14.7°C in Malkajgiri to 18.9°C in Khairatabad and Sanathnagar. Forecasts indicated a uniform drop across most circles.

## Over 3,800 Indians Deported From US In 2025: Govt Tells Parliament

Over 3,800 Indian nationals were deported from the US in 2025, the government informed the Rajya Sabha on Thursday. The figures include 3,414 Indians deported through Washington till mid-December, according to the data shared in a tabulated form in a written response to a query by Minister of State (MoS) for External Affairs Kirti Vardhan Singh. Congress member Randeep Singh Surjewala asked the number of Indian nationals deported from the United States

In 2025, over 3,800 Indian nationals were deported from the US, according to the data shared in the written response. The tabulated data also included locations of Indian consulates in the US and the corresponding number of deportations in 2025, viz., consulates of India in New York (47), Atlanta (31), Houston (234), San Francisco (49) and Seattle (31).


## 16 Dead, Several Others Feared Trapped After Blast in Illegal Coal Mine

At least 16 labourers were killed, and several others feared trapped following an explosion at an "illegal" coal mine in Meghalaya's East Jaintia Hills district on Thursday, Director General of Police I Nongrang said. Rescue teams have been engaged in search operations, she said, adding that the incident occurred in the Thangsku area in the morning. "We have recovered 16 bodies so far. The exact number of labourers present inside the mine at the time of the explosion

is yet to be ascertained. More people are feared trapped," she said. One person who sustained injuries in the blast was initially taken to Sutnga Primary Health Centre before being referred to a Shillong hospital for better treatment, East Jaintia Hills Superintendent of Police Vikash Kumar said. The explosion is suspected to have occurred during coal mining activities at the site, which is believed to be an illegal operation. Asked whether the mine was operating illegally, Kumar said, "Yes, it seems like that." He said

the cause of the explosion is yet to be ascertained, and an inquiry will be conducted. The National Green Tribunal (NGT) had imposed a ban on rat-hole coal mining and other unscientific mining practices in Meghalaya in 2014, citing environmental damage and safety risks, while also restricting illegal transportation of coal extracted through such methods. Rat-hole mining involves digging of narrow tunnels, usually 3-4 feet high, for workers to enter and extract coal. The horizontal tunnels are often termed "rat-holes", as each just about fits.

# BRS-BJP Secret Pact is like Veena-Vani bond: CM Revanth

Chief Minister A Revanth Reddy on Thursday alleged that the BJP and BRS were maintaining a "Fevicol bond" to protect each other's interests and accused the BJP-led Centre of deliberately ignoring the Telangana government's requests for approval of key projects, including national project status to the Palamuru-Rangareddy lift irrigation scheme (PRLIS), funds for the Musi development project and Metro Rail Phase-II.

Addressing a public meeting at Choppadandi in Karimnagar district, the



Chief Minister accused the BJP and BRS with collusive politics, alleging that both parties were shielding corruption cases. He referred to what he described as a "Veena-Vani bond" between the two parties, likening them to the 22-year-old conjoined twins of Hyderabad.

lenged opposition leaders to a face-off at LB Stadium in Hyderabad to debate the government's performance.

Referring to Prime Minister Narendra Modi's earlier remark that Kaleshwaram had become an "ATM" for Chandrashekhar Rao, Revanth Reddy asked why no inquiry had been ordered so far. He said Modi for not acceding to the state's request for a CBI inquiry into the Kaleshwaram project and for not ordering further investigation into the Formula E race case. He said the Telangana Assembly had passed a resolution seeking a CBI probe into the

Kaleshwaram issue and questioned why no action had been taken even after six months. He said the state government had also written to the Centre seeking permission to proceed against an IAS officer in the Formula E case, but there had been no response. If the BJP and BRS had no understanding, Revanth Reddy dared the Centre to arrest Chandrashekhar Rao and former irrigation minister T Harish Rao in the Kaleshwaram scam, and former municipal minister K.T. Rama Rao in the Formula E race case. He also demanded a CBI probe into the cases.

## ₹500 Crore Promise for Municipal Development if BJP Wins: Bandi Sanjay

After detailed evaluation and counselling, Baby Imad underwent bilateral full-

All Major Parties Allot 50% Tickets To BC Candidates



The Congress, BRS and the BJP have allotted over 50 per cent of their tickets to Backward Class (BC) community candidates for the municipal elections scheduled on February 11. This is against the 28.21 per cent of the total wards in 121 municipalities and 35.24 per cent in 10 municipal corporations allotted to the community quota set aside for the community for the polls, and the failed attempt of the government to ensure 42 per cent reservations. Data from the three parties show that the ruling Congress allotted 1,601 tickets to BC candidates, accounting for 53.69 per cent. The BRS allotted 1,580 tickets, or 52.98 per cent, while the BJP allotted 1,493 tickets, amounting to 50.07 per cent. Under the reservation policy notified by the government, reservations for the BC, Scheduled Caste and Scheduled Tribe communities are capped at 50 per cent.

With parties fielding BC candidates even in unreserved wards, candidates from general categories accounted for less than half of the tickets. The Congress allotted 20 per cent of its tickets to general category candidates, the BRS 21 per cent and the BJP 28 per cent, with the remaining seats going to SC and ST community candidates.

A table-top mapping has been carried out to link electors listed in the 2025 electoral rolls with those covered during the 2002 SIR. This is being followed by field-level mapping, with BLOs undertaking house-to-house visits to identify and verify residences, particularly in urban areas. During the SIR, BLOs are expected to make three to four visits to each polling area. Enumeration forms will be distributed during the first visit, while subsequent visits will cover households that were not available earlier. The CEO clarified that electors who are not mapped during the preparatory phase would still be able to furnish their details during the SIR.


Lok Sabha Speaker Om Birla on Thursday said he had requested Prime Minister Narendra Modi not to come to the House on Wednesday, citing a possible security concern arising from the conduct of some Opposition members. Making a statement in the House, the Speaker said he had received "concrete information" that several Congress MPs could carry out an "unexpected act" by approaching the seat where the Prime Minister sits.

"When the Leader of the House was to reply (to the debate on the motion of thanks on the President's address), I had concrete information that many members of the Congress could carry out an unexpected act by reaching

the spot where the prime minister sits," Birla said. He said that to prevent any untoward incident and to uphold the dignity of the House, he had asked the Prime Minister to avoid attending the sitting.

"If this incident had taken place, it would have left the democratic traditions of the country in shreds," Birla said, adding that Modi had agreed to his request. The Speaker said the conduct of some Opposition members inside the House and later in his office on Wednesday was inappropriate and unprecedented. Describing it as a "black spot", he warned that if members brought posters and pamphlets into the House, proceedings would not be allowed to function.

"Never in history have political differences been dragged to the House. The



conduct of the Opposition members in the office of the Speaker was not appropriate, and in fact it was like a black spot," he said. The Lok Sabha witnessed disorderly scenes on Wednesday when Opposition MPs, including women members, moved towards the Prime Minister's seat holding banners ahead of his scheduled reply to the Motion of Thanks on the President's address. Modi was not present in the House at the time. BJP member P.P. Chaudhary was speaking when Opposition members entered

the Well, forcing adjournment of proceedings. The Prime Minister's reply to the Motion of Thanks was deferred amid protests by the Opposition over references to former Army chief General M.M. Naravane's unpublished book and the Chair's refusal to allow Leader of the Opposition Rahul Gandhi to speak. Reacting to the Speaker's remarks, Congress general secretary and Lok Sabha MP Priyanka Gandhi Vadra rejected the allegation, calling it "an absolute lie". Speaking to reporters in the Parliament complex, she said there was no plan to harm the Prime Minister and accused the government of shielding itself behind the Speaker. "It is an absolute lie. There is no question of anybody raising hands on the prime minister, trying to hurt him or any such

thing," she said. "But if you are going to allow your members to quote books, talk nonsense, the Opposition benches are going to protest. I am sorry, the Prime Minister is hiding behind the Speaker. They are making the Speaker say all this because yesterday he did not have the guts to come in the House. Because three women were standing before his bench, what nonsense is this," the Congress MP said.

Amid continued protests, the Lok Sabha on Thursday passed the Motion of Thanks on the President's address without the customary reply by the Prime Minister. Amendments moved by the opposition were put to vote by the Speaker and rejected. The House was adjourned multiple times during the day due to sloganising and protests.

## Opposition Stir Puts Off Modi's LS Speech

Prime Minister Narendra Modi's proposed reply to the Motion of Thanks on the President's Address in the Lok Sabha did not take place on Wednesday despite indications from official sources, with the House adjourned for the day amid sustained Opposition disruptions. The Prime Minister was not present in the House when proceedings resumed, and BJP member P.P. Chaudhary was speaking when Opposition members entered the Well of the House and moved towards the Treasury benches. Women MPs from Opposition parties, led by Congress member Varsha Gaikwad, protested and marched towards the Prime Minister's chair. Sandhya Rai, who was



in the Chair, adjourned the House for the day within minutes of reassembly at 5 pm. The Lok Sabha had earlier been adjourned till 5 pm following uproar over remarks by BJP MP Nishikant Dubey targeting the Gandhi family. The ruling party later claimed that Opposition members ignored repeated appeals by senior ministers to return to their seats. The Prime Minister is now expected to reply to the Motion of Thanks in the Rajya Sabha on Thursday at 5 pm, during which he is likely to touch upon recently concluded trade agreements with the Euro-

pean Union and the United States. Commenting on the Prime Minister's absence, Congress MP Priyanka Gandhi said he was "scared" and alleged that Union railway minister Ashwini Vaishnaw and Dubey "ran away like a bullet train". Leader of the Opposition Rahul Gandhi said the Prime Minister did not want to face the truth and reiterated the charge in a post on X. Earlier in the day, the House witnessed repeated adjournments over Dubey's remarks and references to books critical of the Gandhi family. Presiding officer Krishna Prasad Tenneti cautioned Dubey that such references were not permitted, citing Rule 349, which bars members from reading from books or documents not connected with the


## J&K Parties and Farmers Welcome Centre's Move To Halt Proposed Railway Lines

Political parties, farmer groups, and orchard-dependent communities across Jammu and Kashmir have warmly welcomed the Centre's decision to pause three proposed railway projects in the Valley. The move follows sustained objections from local residents, apple growers, and elected representatives, who warned that large-scale land acquisition would devastate orchards and threaten the livelihoods of thousands of families. Apple orchardist Abdul Razzak Wani, speaking over the phone from Shopian—one of the areas where vast stretches of farmland had been earmarked for acquisition—said the announcement brought immense relief. "All I can say is that we are finally breathing easier. For weeks we lived in anxiety, unsure about our future and that of our children. This decision has lifted a heavy burden from our minds," he said.

Union Railway Minister Ashwini Vaishnaw explained earlier in the day that although there had been a demand for additional railway lines beyond the existing Srinagar-Baramulla route, concerns raised by the J&K government and Members of Parliament prompted a reconsideration. They argued that the proposed alignments would cut through vast stretches of apple orchards—an economic backbone for south Kashmir. Acknowledging these objections, the Centre decided to place the projects on hold. The announcement comes after months of protests in Pulwama, Shopian, and Anantnag, where residents feared the loss of agricultural land, destruction of orchards, and potential

displacement. Throughout the past several months, villagers, growers, and civil society groups held demonstrations demanding that the government rethink the proposed routes. Many insisted on transparent consultation, fair compensation, and alternative alignments that would not jeopardise Kashmir's horticultural economy. Their message was consistent: development must not come at the cost of fertile land and generational livelihoods. Former chief minister and PDP president Mehbooba Mufti welcomed the Centre's decision, calling it a much-needed relief for Kashmir's agrarian sector. In a post on 'X', she said, "The decision to put the Pahalgam and Shopian railway lines on hold brings much needed relief to Kashmir's agrarian economy. These projects threatened to destroy scarce fertile land and push over a million rural families into uncertainty. Development that uproots farmers is not progress."

## Gas Tanker Accident Chokes Mumbai-Pune Expressway

It was a literally nightmare experience to thousands of commuters, who were stuck for more than 24 hours at the Mumbai-Pune Expressway after a CNG tanker overturned in the middle of the road, triggering a massive traffic jam that stretched to almost 25 kilometres. The majority of commuters were left stranded on the Expressway since Tuesday evening, forcing them to spend the whole night in their cars without food and water. Help came only in the afternoon when Police distributed water and food to them.

According to officials, the incident occurred near the Adoshi tunnel in Raigad district at around 5 pm on Tuesday when the tanker, allegedly travelling at high speed, lost control due to the slope near the Adoshi Tunnel on the Mumbai-bound route and overturned. Soon after the accident, gas was found leaking from the tanker, causing panic among motorists. The tanker was carrying propylene gas, which is highly flammable. Due to the high risk of a



gas leak and potential explosion, authorities immediately suspended all vehicular movement on the Mumbai-bound lane, resulting in a gridlock that stretched for over 25 kilometers. "A potentially dangerous situation developed because the tanker was transporting propylene, which is extremely flammable. As soon as the leakage was confirmed, we implemented full emergency protocols," a senior highway police officer said. The chaos left hundreds of vehicles stranded and caused massive congestion on both carriageways. The vehicular movement in both directions came to a complete halt, with passengers - including women and children - deprived of food, water and toilet facilities.

## Fadnavis Has No Right To Comment on NCP Merger Talks: Sharad Pawar

Nationalist Congress Party (NCP) founder Sharad Pawar on Wednesday reiterated that the late Ajit Pawar had been keen on a merger of the two NCP factions, asserting that Maharashtra Chief Minister Devendra Fadnavis had "no right" to comment on the issue. Mr. Pawar said Ajit Pawar had held discussions with senior leader Jayant Patil, countering Mr. Fadnavis's claim that the former Deputy Chief Minister would have taken him into confidence had any such move been imminent. After Ajit Pawar's death, leaders of the Sharad Pawar-led faction had claimed that merger talks were at an advanced stage and that



February 12 had been finalised to announce the reunification. Dismissing the claims, Mr. Fadnavis had said Ajit Pawar never informed him of any such plan. "If the discussions had reached any final stage, Ajit Dada would have told us (BJP). Had any date been fixed, he would have informed us. He was part of our government; could he take such a decision without sharing these matters with us? I have no idea what talk he had with Sharad Pawar. As far as

we are concerned, we have no information regarding any such date," the Chief Minister had said earlier.

Responding to the remarks, Mr. Pawar said, "I don't think the Chief Minister has any right to mention me. He was nowhere in the merger discussions. My colleagues, Jayant Patil and Ajit Pawar, were discussing it. There is nothing more to it than that." The former Union minister said this was not the time to engage in political discussions. "Right now is the time to support family members. We are not discussing political issues with anyone," he said.

Earlier in the day, Mr. Pawar held a closed-door meeting with Ajit Pawar's sons, Parth and Jay, at Vidya Pratish-

than, an educational institution in Baramati. The meeting lasted about one and a half hours. Reports suggested that the discussion revolved around a proposal to build Ajit Pawar's memorial on the Vidya Pratishthan premises. However, Mr. Pawar dismissed the speculation. "I am not aware of any memorial for Ajit Pawar being built in Baramati. I am the chairman of the institution whose land is being discussed; at the very least, I should have been informed. No such discussion has taken place. We will sit together and decide what needs to be done, but it is not appropriate to comment on something that does not exist," he said.

### GNIT certificate row in HC

Justice N. Tukaramji of the Telangana High Court ordered notice to Guru Nanak Institutions of Technology (GNIT) in a writ petition filed by 35 engineering students questioning withholding of original certificates to compel recovery of fees. The judge was dealing with a writ petition filed by Narayandas Sai Vivek and 34 others. The petitioners pointed out that GNIT unlawfully retained vital academic documents, including SSC and Intermediate certificates, semester-wise marks memos, degree certificates, transfer certificates and bonafide

certificates. It was argued that such retention gravely impaired their ability to pursue higher education, seek employment and appear for competitive examinations. It was further contended that the action of the institution was in clear violation of the UGC Regulations, 2018, as well as relevant circulars issued by AICTE and JNTU Hyderabad. Emphasising that the students have been made to suffer for a prolonged period, counsel for the petitioners Narayandas Sai Vivek sought immediate release of the original certificates. The judge, after hearing preliminary submissions, ordered notice and posted the matter for further

### HC rejects custody habeas petition

A two-judge panel of the Telangana High Court comprising Justice Mousumi Bhattacharya and Justice Gadi Praveen Kumar dismissed a habeas corpus plea filed by a father seeking production and custody of his minor son. The panel was dealing with a plea filed by Abdul Raheem Uddin, who alleged that the mother was illegally detaining his eight-year-old son, Sheikh Tamim Uddin Thani, denying access and communication, and disobeying a visitation order passed in his favour by

the Family Court. He contended that such continued withholding of custody amounted to unlawful detention warranting habeas corpus relief. On the contrary, the state argued that the petitioner was, in effect, seeking implementation of a Family Court order through a writ of habeas corpus, which was impermissible. He further contended that the petitioner had not even approached the concerned police authorities with a complaint, and that disputed custody issues could not be agitated in a habeas corpus petition before a constitutional court.

### Hyderabadis Lose Nearly Rs. 85 lakh in Investment Frauds

A 33-year-old private employee alleged that fraudsters cheated him of Rs. 71.11 lakh through a fake stock trading scheme after luring him into a Telegram group promising high returns. The complainant said he joined the Telegram channel on December 25 after receiving a WhatsApp link linked to a so-called high-profit programme of an MNC financial services firm. Police

said the accused shared what were said to be stock tips, introduced a daily trading plan and created an internal equity account using the victim's Aadhaar details. The victim deposited money for alleged OTC trading, IPOs and DTC investments. Though the accused portal showed a balance of Rs. 2.20 crore, the victim was denied withdrawal and was asked to pay additional fees. When he contacted the accused, their phones were switched off, police

alleged that fraudsters cheated him of Rs. 4 lakh on the pretext of a fake financial trade. Police said the accused, identifying herself as Geeta, gained the victim's trust and persuaded him to invest in an online trading scheme by promising profits. After the victim transferred the amount, the accused allegedly blocked him on all social media platforms. In another case, a businessman from Goshamahal

alleged that fraudsters cheated him of Rs. 11.20 lakh by a woman he met on a dating app. Police said the accused, identifying herself as Geeta, gained the victim's trust and persuaded him to invest in an online trading scheme by promising profits. After the victim transferred the amount, the accused allegedly blocked him on all social media platforms. In another case, a businessman from Goshamahal

### Plea claims GHMC inaction

Justice Lakshmi Narayan Alishetty of the Telangana High Court took on file a plea alleging inaction on the part of GHMC in preventing alleged illegal and unauthorised constructions by Meridian School at Madhapur, Serilingampally mandal. According to the petition, the petitioners were owners of land in Survey No. 14/1, Madhapur, where Meridian School was allegedly carrying out construction

activities without obtaining a sanctioned building plan from the competent authorities. It was contended that the petitioners submitted a detailed representation requesting the authorities to restrain the school management from proceeding with further construction. Despite the lapse of several years, no action was taken. The petitioner contended that the unauthorised constructions had continued unchecked due to administrative apathy. Counsel appearing for the respondents contended that the school had not deviated from the permissions granted.

### Brother Held For Murder of Advocate Over Land

A day after advocate Gotika Swapna was murdered in her agricultural land at Kethireddypally in Moinabad, police on Thursday arrested four persons including her brother G. Raju and his associates Errolla Sandeep, Vadde Veeresh and Kavali Shiva Lingam. The murder was said to be the fall-out over a property dispute. Swapna was murdered when she went to the farmland to get the land surveyed with the intention of selling a portion of it for her marriage expenses. Police said she had recently married a man she was in a relationship with through an Arya Samaj ceremony. To raise funds for a traditional marriage, she planned

to sell one acre out of the four acres of land said to be registered in her name. Chevella DCP Yogesh Gautham said she was accompanied by her mother Venkatamma, another advocate and a surveyor to the land in Survey No. 339. "Raju knocked down Swapna with his car. When she fell down, his associates attacked her," he alleged. Police said Swapna's father had married Mallamma, who had no children. He later married her younger sister Venkatamma, with whom he had four children: two sons and two daughters including Swapna and Raju. The eldest daughter was married in 2001, while one of the brothers later died in a road accident.

### High Court Upholds TGPSC Gr-1 Recruitment



The Telangana High Court on Thursday confirmed its interim directions of September 25 last, setting aside a single judge's directions and permitting the Telangana Public Service Commission (TGPSC) Group-I to complete the recruitment of selected candidates. These candidates had been given their appointment letters after the interim order, subject to the court's final order. Thursday's judgment comes as a relief to these candidates.

A division bench comprising Chief Justice Aparesh Kumar Singh and Justice G.M. Mohiuddin pronounced the judgment while disposing of a batch of writ appeals preferred by the commission and several successful candidates, who were aggrieved by the common

order dated 09.09.2025 issued by the single judge. In its detailed judgment, the division bench examined the recruitment process, the method of evaluation adopted by the commission, and the grounds on which the single judge had intervened in the matter. The court observed that there were no allegations of mala fide, fraud, or proven systemic irregularities in the conduct of the examination. It held that in the absence of any demonstrated violation of statutory rules or arbitrariness, the directions to re-evaluation with moderation or to re-conduct of the examination was found to be unsustainable. Emphasis-

ing judicial restraint in matters relating to large-scale public recruitment, the division bench observed that intervention in examinations conducted by constitutional bodies should not be undertaken in the absence of proven mala fide, arbitrariness, or systemic irregularities. On these grounds, the division bench concluded that the single judge had erred in directing re-evaluation with moderation or re-conduct of the examination. The controversy arose out of recruitment to Group-I services for 563 posts under a notification dated February 19, 2024. The preliminary examination was conducted in June 2024 and its results were declared in July 2024. Candidates who qualified in the prelims appeared for the Mains held in October 2024 across 46 centres and the results were declared on March 30, 2025.

### WILL 15% INCREASE IN DEFENCE BUDGET GIVE INDIA MORE BANG FOR THE BUCK?

Never before since the end of the Second World War has the world been so badly fractured as now, especially since Donald Trump's return to the White House in January 2025. That he, holding the most powerful office in the world, who should have been seriously working to uphold the global rules-based order, is doing just the opposite, has left most nations, including most long-term US allies, seriously worried. It is needless to say that some of his policies also impact India, in more ways than one, including in strategic matters.

Overall, as the strategic and security environment worsens the world over, including in South Asia, India needs to factor in its security calculus the manifold existing challenges and the newer ones emerging. Our own Operation Sindoor involvement

highlighted the nuances of a fragile and hostile geopolitical environment in our neighbourhood and the critical imperative of being operationally ready and better militarily prepared against our own adversaries at all times.

Unquestionably, adequate resources thus have to be allocated for ensuring security preparedness -- but are we doing it? India's finance minister, Nirmala Sitharaman, in her record ninth consecutive Budget presentation, and the Narendra Modi government's 13th Budget in the Lok Sabha on February 1, has allocated Rs 7.85 lakh crores for the defence budget in FY 2026-2027 -- a satisfying 15 per cent jump from last year's defence budget and which is two per cent of India's GDP. Last year's allocation was Rs 6.58 lakh crores for the defence ministry, which was around just 1.9 per cent of GDP. It may be noted that India's defence spending

currently accounts to around 14.5 per cent of the total Union Budget in 2026-27.

Is the budget for this financial year adequate to ensure India's overall security build-up to cater for the formidable two-front threat that India faces from its main adversaries - China and Pakistan -- both individually and collectively? That deserves serious analysis. India's parliamentary subcommittees have unanimously and consistently recommended that the nation's defence budget be raised to three per cent of GDP is quite well known but has never been implemented by any government of any political hue.

In analysing the adequacy or otherwise of the allocations for the forthcoming financial year, it will be worthwhile to take a sharp look at the immediate requirements of our armed forces.

# Rupee inches up 7 paise amid trade deal uncertainty, RBI cues awaited

The Indian rupee traded in a narrow range and strengthened by 7 paise to 90.40 against the US dollar in early trade on Thursday, supported by cautious optimism in the market even as investors awaited official confirmation of the India-US trade deal and cues from the Reserve Bank of India's policy decision. At the interbank foreign exchange market, the rupee opened at 90.52 against the dollar and moved up to 90.40, gaining 7 paise from its previous close. On Wednesday, the domestic currency had depreciated 15 paise to settle at 90.47. During early trade on Thursday, it also briefly touched 90.53.

Forex market participants said sentiment remains



guarded as neither India nor the United States has released formal documentation outlining the final terms of the proposed trade agreement. Traders noted that the market mood has shifted from initial optimism to careful verification, limiting further upside for the rupee.

"Market is now waiting for confirmation and finer details before extending the rupee's rally further," said Amit Pabari, Managing Director of CR Forex Advisors. He added that attention has also turned to the RBI's Monetary Policy Committee meeting scheduled for Friday. According to Pabari, markets largely expect the central bank to keep inter-

est rates unchanged, with a growing consensus that rate cuts are unlikely before the end of 2026.

RBI's stance, along with clarity on the trade deal, is expected to influence the rupee's direction in the near term.

Meanwhile, the dollar index, which measures the US currency's strength against a basket of six major currencies, rose 0.18 per cent to 97.79. Global oil prices provided some relief, with Brent crude futures declining 2 per cent to USD 68.07 per barrel. On the domestic equity front, benchmark indices opened lower. The Sensex fell 278.72 points to 83,538.97, while the Nifty declined 94.15 points to 25,681.85. Foreign Institutional Investors bought equities worth Rs 29.79 crore on Wednesday, according to exchange data.

# 'Mirzapur' movie to hit theatres on September 4, 2026






## Randeep Hooda undergoes major physical transformation for Eetha

## All Officials in AP Must Understand Cybersecurity: Chief Secretary

Chief Secretary K. Ramakrishna Rao on Thursday said strong policy alignment, administrative readiness, and cross-departmental coordination are crucial to effectively address evolving cyber risks that impact governance, public services, and critical infrastructure. Speaking after inaugurating Shield 2026, a noted initiative by the Telangana Cyber Security Board (TGSB) to prevent cyber crime, focus on investigation and victim system, the Chief Secretary said cybersecurity must be embedded across all levels of administration to ensure effective and timely responses.

He formally launched key digital initiatives developed by TGSB, including 1930 Saarthi, an AI-powered multilingual cybercrime reporting and assistance system; Sentinel (Cyber Crime Investigation Tool – CCIT), a rule-based platform for faster and uniform cybercrime investigations; and C-Sight, an AI-enabled system for automated processing and management of digital evidence related to Child Sexual Abuse.

## GHMC Plans to 30 Multi-Level Car Parkings in City

The GHMC has proposed to construct 30 automated multi-level car parking facilities across the city, modelled on the parking system at KBR Park. Three locations have been shortlisted so far — Indira Park at Domalguda, Chacha Nehru Park at Masab Tank and Khilwat near Charminar, a GHMC official said. The civic body is identifying feasible sites at tourist locations, shopping complexes and other high-traffic zones. The parking facilities will be developed under the public-private partnership (PPP) model, under which the private agency will operate the facility for 10 to 15 years, collect parking charges and later hand it over to the GHMC.

As part of the model, the GHMC will allow the agency to set up advertising spaces and eateries to ensure the project's economic viability, as the corporation will not fund the construction. Officials said the process of setting up the parking facilities in different parts of the city is currently at a preliminary stage. Parking congestion, particularly near parks and high-footfall areas, has led to vehicles being parked on roads, resulting in penalties imposed by traffic police. The issue of parking space shortages in various wards was also raised by corporators at a recent GHMC Council meeting. Several corporators urged the Mayor and the GHMC Commissioner to provide automated multi-level car parking facilities in their respective wards, to which both responded positively.

Stating that no individual could remain in power indefinitely, Revanth Reddy said the country's progress depends on collective efforts from all sections of society. He added that reservations provided by Congress governments had enabled many from minority communities to secure employment and urged minorities to prioritise education.

Referring to Jamiat Ulama-e-Hind, the Chief Minister recalled its role in the freedom struggle and its continued efforts to promote communal harmony. He also acknowledged the organisation's support during his 2019 Lok Sabha election from Malkajgiri, crediting it as part of his political journey from grassroots activism to Parliament.

## After terrorising villagers near Hyderabad, tiger moves to Jangaon

The tiger on the prowl since about 20 days ago in Yadadri-Bhuvanagiri district of Telangana, about 60 km from Hyderabad, has moved to Jangaon district on Thursday, February 5, prompting officials to issue precautions to villagers there. Jangaon



District Forest Officer Kondal Reddy said the tiger's pug-marks were noticed Thursday morning at a village in Lingala Ghanpur mandal.

The tiger appears to have born in an area surrounded by villages, and it has been moving into habitations, he told PTI.

He said the district administration is issuing precautions to villagers by tom-tomming, advising them not to venture out during night hours and to take care of their domestic animals.

Before reaching Jangaon district, the big cat has given a nightmare to residents since its presence was observed in Yadadri-Bhuvanagiri district on January 17, believed to be a first near Hyderabad in 50 years. The Yadadri administration had also issued alerts to residents asking them not to move out during the night.

# Hyderabad office market to add 19 msf supply: ICRA

Hyderabad's office market is entering its next growth phase, backed by steady leasing demand, improving vacancy trends, and consistent rental appreciation, according to ICRA. The city is expected to see about 18–19 million square feet of new Grade-A office supply over the late FY2026–

FY2027 period, with nearly a quarter of the upcoming space already pre-leased—an indicator of sustained occupier confidence despite global economic uncertainties. Leasing activity has remained resilient across India through 9M FY2026, and Hyderabad has been among the stronger performers. During the period, the city added 8.4 msf of fresh Grade-A space,

while net absorption stood slightly higher at 8.5 msf, largely driven by continued demand from IT-BPM and BFSI occupiers. As a result, vacancy levels have eased to around 17 percent as of December 2025, improving from the highs seen a year earlier. ICRA expects market fundamentals to remain stable even as new supply enters. Occupancy levels are projected to hold in the range of 82.5–83 percent by March 2027, supported by ongoing leasing momentum and a diversified occupier base.

Hyderabad's share in India's Grade-A office landscape has also expanded steadily. As of December 2025, the city accounted for roughly 16 percent of total stock across the top six markets, with Hitec City/Madha-

kets have risen at a 3–4 percent compound annual pace over the past five years, and a similar year-on-year increase is anticipated through FY2026 and FY2027. Over the longer term, Hyderabad's office stock has grown significantly faster than most peer markets, supported by developer activity and favourable planning policies that have enabled large-scale expansion.

## HYDRAA Clears Septic Tank Encroachments, Fences Four Acres of Govt Land in Hyderabad

HYDRAA said it had removed encroachments around septic tanks and secured nearly four acres of government land in Shilpa Brundavan Colony, near Alvin Colony Circle in the Kukatpally zone on Thursday. It said encroachers had occupied open spaces earmarked around septic tanks — areas originally meant for planting greenery to reduce odour — by converting them into private plots. Following the introduction of underground drainage systems, such vacant parcels are typically reserved for parks or public use. According to HYDRAA, residents complained that one Y.V. Rao had encroached upon the septic tank area and the adjacent open land. They alleged that in collusion with Shilpa Developers,

unauthorised plots were laid out on adjoining government land under the pretext of private ownership, with roads demarcated and even existing layout boundaries altered. Acting on the complaint, HYDRAA, revenue and GHMC teams conducted a field inspection on the directions of HYDRAA commissioner A.V. Ranaganath. The inspection confirmed encroachments spanning about 20 guntas around the septic tank area. On Thursday, HYDRA erected fencing around the unauthorised layout to prevent further illegal activity.

# Advocate Qurram Ali Demands Immediate Implementation of Advocate Protection Act

Lawyers across Telangana staged statewide protests on Wednesday, condemning the brutal murder of a woman advocate and alleging lapses in handling the case. "Who is responsible for the lives and safety of advocates and their families?" he asked. "Doctors, police personnel, government employees, and RTC drivers have protection laws.
